Mayor McCoy will write a letter to the State Department of Transportation informing them of the situation regarding the curbs being too low, which allows for residents to park on them and cause damage. Also, the situation can become dangerous as residents try to walk around the vehicle blocking the sidewalk and may get hurt. Mayor McCoy will present his findings at the next Town Council Meeting.

## AN ORDINANCE AMENDING ORDINANCE 279 AN ORDINANCE ESTABLISHING PROCEDURES AND FEES FOR WORK PERFORMED WITHIN A PUBLIC RIGHT OF WAY

## Amendment to Ordinance No. 279 codified in Vernon town Code of Ordinances Chapter 11, Article II, Section 11-21, entitled" Construction"

Ordinance No. 279 is amended as follows:

The last line of Section (b) I (d) will now read

"A fee of One Hundred dollars (\$100.00) for each license issued."

Section (b) II will now read:

A permit application must be submitted and approved by the Town Engineer prior to performance of any work by a licensed contractor within the public right of way in the Town of Vernon. Each permit application must be approved the Town Engineer or his designated agent. No work shall be commenced or be continued unless the approved permit is posted by or in the position of the licensee or his/its agent at the location of the work to be performed. A fee of One Hundred dollars (\$100.00) will be charged for each permit application and license issued". No work shall be performed until the performed until the permit application is approved.

Except as amended above, Ordinance 279 remains in full force and effect.

This Ordinance shall be effective for a period of not more than ten (10) years from the date of not more than ten (10) years from the date of adoption. If the Town Council does not act or renew this Ordinance, it shall be deemed repealed.

Enclosed is a request for the Disposal of Fixed Assets 85000031, otherwise known as 35 Hale Street, from Alan West, Superintendant of the Vernon Cemetery Commission. This is a sixty four year old two-story residence, which was acquired by the Commission in 1973 to create more grave space.

At this time, the house is in need of major structural repairs, including plumbing, heating, and electrical upgrades. The house has been vacant since September, 2009. Previously, it was rented out for \$700.00 per month. The Town/ Commission paid approximately \$700.00 per year for water and sewer service. The Vernon Cemetery Commission now wishes to demolish the house in order to expand the Grove Hill Cemetery Grounds. (Please see attached memorandum from Mr. West). The house is fully depreciated based on the original cost of \$5,505.60. Once demolished by Public Works, this land will be freed up for use as future plots. Mr. West estimates that 280 plots could be sold from this space. At \$700.00 per plot, that would generate \$196,000.00, the equivalent of 23 years of rental income. If twelve plots per year were sold in this anticipated new section, the income would equal the loss of rental income of \$8,400.00.

## PROPOSED MOTION:

This memo is to inform you of the intent of the Vernon Cemetery Commission to demolish the house at 35 Hale Street, Vernon, CT.

At a VCC meeting on September 8, 2009, it was decided unanimously to demolish the house and use the property for additional grave spaces at Grove Hill Cemetery. The following list of steps have been taken.

- 1. A letter was sent to Mr. Robert Hurd, of the Local Historic Properties Commission, asking him to determine if the house had any historical value to the town. Attached is the request and the response from the LHPC.
- 2. Acting Director of Public Works, Dave Tomko, agreed to help with the plans for demolition. We would not hire outside TOV for this work.
- 3. The Building Department was contacted and we have the necessary paperwork for that nermit
- 4. Water Pollution was contacted to disconnect the sewer.
- 5. We have the CBYD markings in place at the site.
- CL&P has been contacted and are waiting paperwork so they can go ahead and disconnect the electrical
- The Water Company has turned off the water. This needed to be done because the house is vacant.

The house is in need of many costly updates and repairs. In 2006 it was appraised for \$149,900. Since then, the housing market has come down considerably.

The intent when this property was purchased in 1975, was to create more grave spaces. The land area has been mapped out and it is determined that their 280 grave spaces available on this property. The cost today of a single grave space is \$700, which brings the value to \$196,000.

It is our hope that we will be able to continue with the demolition plan as soon as possible. If you have any questions, please call me.

#### Gentlemen:

We have been evaluating our present equipment and fleet. After working with staff, I feel that the following assets should be disposed of. Dwight Ryniewicz, Fleet Supervisor, has evaluated an auction company, Central Auto Auction, for much of this endeavor. This company is an auction house that performs services for dealers and municipalities. The Town of East Hartford recently used their services and were quite pleased with both the level of service and the prices obtained. They sell primarily to auto wholesalers and junk dealers. The Town of Vernon will be insulated from any claims that normally could arise if we auctioned directly to the public. Dwight has visited their facility located in Hamden, CT and was informed of the following terms and information by Peter Saldamarco. President.

There is a \$195.00 flat rate fee per vehicle that is charged only if the vehicle is sold. Central will come and pick up the vehicles from DPW. All auctions are done live with the vehicle running, however, in the event the vehicle does not run it is placed on closed circuit TV and auctioned. Automotive related equipment can be auctioned also, fees will be modified accordingly.

If a vehicle does not sell in-house, it will be placed on a web based auction. Auctions are every Tuesday. Checks will be issued every Thursday. We can set a reserve price for each asset, or accept or reject bids on site. An itemized statement will be sent with the check to show a full accounting of each sale as well as profit or loss. A copy of each vehicle title will be sent back completed with purchaser information for our records.

Equipment that is too costly to move or in poor condition can still be auctioned through the closed circuit system. The purchaser will come to our location to pickup and remove.

In the event the Town chooses to utilize this service, our vehicles and equipment will have to be prepped and decommissioned, as many have not had this performed to date.
