Amendment to Ordinance No. 242

On August 18, 2009, the Town Council voted to send the Proposed Ordinance to a Public Hearing on September 15, 2009. Said public hearing was held and citizen commentary was received. The proposed ordinance is before you for your consideration. (Please see the enclosed memorandum from John D. Ward, Town Administrator, dated October 2, 2009, to Mayor Jason L. McCoy, the memorandum from John D. Ward concerning the Committee Membership, a Map of the District showing the Commercial property in question). BLRWPCA members and Representatives of Fuss & O'Neil will be present to discuss the status of the project, engineering details, and the district, along with Mr. David Ignatowicz, Director of the Town of Vernon's Water Pollution Control Authority.

Daniel Wright of the Bolton Lakes WPCA, and Marshall Gaston from Fuss and O'Neil presented information about the project and provided a large map of the service area and the different phases of connection. Other members of the Bolton Lakes WPCA and Fuss and O'Neil joined the discussion once they arrived.

Members of the public and town council asked questions and discussion took place regarding the size of the pipes vs the flow and the reason behind them; cost for services; lots outside the geographical area; vacant lots; and phase timeframes for hooking up to the system. The different funding sources for the project was also discussed. The inter-municipal agreement with the Town of Manchester consists of up to 200,000 gallons per day flow rate. The average residence will have a flow of 200 gallons per day.

G.) **NEW BUSINESS**

1. **Update from Vernon Superintendent Richard Paskiewicz and Board of Education Member and Budget Steering Committee Chairman George Apel regarding the 2009-2010 budget.**

Chairman Apel and Superintendent Paskiewicz provided a breakdown of the \$300,000 cut to the board of education budget. A furlough day will be taken by all school staff including teachers, custodians, paraprofessional staff, support staff and the Superintendent on January 15, 2010 for a savings of \$160,000 to the budget. Other cuts were made by changing school days from 184 to 182, workmen's compensation, copier lease, whiteboards, St. Bernard's School, language lab, and music coordinator to the teacher for a total of \$146,000 in savings. The mid-week detentions at RHS and Paras were added back into the budget for a total of \$6000.00. Discussion took place.

2. **Request that the Town Council approve participation in CROCOG'S RFP for a Trash Authority.** (Enclosed is a memorandum from John D. Ward, Town Administrator, dated 10/2/09 to Mayor McCoy and the Town Council).

PROPOSED RESOLUTION:

THE TOWN COUNCIL, HEREBY RESOLVES TO: (1) ALLOW THE TOWN TO EXPRESS ITS PRELIMINARY INTEREST IN PARTICIPATING IN THE SOLID WASTE AUTHORITY FORMED BY THE CAPITOL REGION COUNCIL OF GOVERNMENTS, THE "CENTRAL CONNECTICUT SOLID WASTE AUTHORITY;" AND (2) AUTHORIZE THE MAYOR AND/OR HIS DESIGNEE TO SIGN ALL NECESSARY AGREEMENTS AND TAKE ALL NECESSARY ACTIONS TO ALLOW THE TOWN TO PAY A FEE OF FIVE HUNDRED DOLLARS (\$500.00) TO HELP DEFRAY THE PROFESSIONAL FEES NECESSARY TO DRAFT A MODEL ORDINANCE WHICH THE TOWN MAY ADOPT, IF THE TOWN DECIDED TO BECOME A MEMBER OF THE ABOVE REFERENCED AUTHORITY.

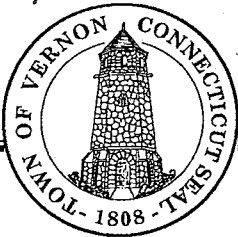
