The following is the local educational agency’s (LEA’s) plan for providing supplemental instruction and support to students, including those identified as needing academic, social-emotional, and other supports, including the provision of meals and snacks. ## Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Parents were surveyed multiple times about the needs of their learners. The needs that have been identified through the surveys include more socioemotional support, academic intervention, and support with the learning loss created by the pandemic. Facilitators have expressed similar concerns. All stakeholders have had the opportunity to participate in the open board meeting for the adoption of this plan.

A description of how students will be identified and the needs of students will be assessed.

Learners will be identified in a variety of ways including reviewing formal and informal assessments data, surveying facilitators for specific feedback as well as surveying families to identify needs. Learners with IEPs, English language learners, learners from low socioeconomic levels will be prioritized for the extra academic support. With the learning loss from the pandemic, intervention and social support are of the utmost needed areas.

Parents and guardians will be informed of the opportunities for supplemental instruction and support through a varying means including weekly newsletter, information meetings with the administration team, morning coffee with the Lead Facilitator, student conferences, IEP meetings and support plans, as well as personal invitations.

A description of the LEA's plan to provide supplemental instruction and support.

Nea will use the Expanded Learning funds in the following ways:

SEL curriculum, ELA curriculum, and instructional materials:

Nea will purchase a specific SEL curriculum called Tool Box. This curriculum is a research-based social-emotional learning curriculum. It teaches critical social competencies necessary for academic and life success such as: resiliency, self-management, and responsible decision-making skills.

ELA curriculum:

Nea will use part of the funds to purchase an ELA curriculum that meets the needs of the learners through a culturally relevant lens and provides facilitators with engaging text and activities.

Instructional materials:

Nea will use part of the funds to purchase classroom book sets, sets of Stem Scopes, Newsela, TCI, Lexia, IXL, Reading A-Z, and Reading with Relevance.

Certificated staff:

Nea will use part of the funds to increase instructional minutes through intercessions. With the adoption of a year round calendar, Nea has the ability to plan intentional interventions during the two intercessions. Learners who have been identified as struggling academically, learners with IEP's, learners struggling with socioemotional issues, will be offered slots in the intercession camps.

Nea will use part of the funds to hire an Intervention Coordinator as well as a Family Learner Liaison. The Intervention Coordinator will be responsible for middle school benchmark reading assessment data collection, coaching of facilitators, and direct instruction. The Family Learner Liaison will work with families on attendance and any support needed to improve learner engagement including wrap around services.

Classified staff:

Nea will use part of the funds to provide classrooms (K-5) with Learner support coaches. These LSC's will lower the ratios in the classroom and provide learners with an additional adult to support them academically. In addition, LSC's will allow for the facilitators to work with small groups of learners on specific academic content by engaging the other learners in activities that build community and SEL skills.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

The District Leadership team met with the site administration to review data and determine needs. We then mapped out identified needs and anticipated needs resulting due to the impact of COVID over a four-year period of time. From there we allocated specific services based on State and Federal funding requirements to each funding source supporting identified needs and resources. The four-year plan was brought to our stakeholders and passed by our Governing Board.

# Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before June 1, 2021, and must be submitted to the county office of education, the California Department of Education, or the chartering authority within five days of adoption, as applicable. ## Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

*EC* Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
