Bidders and others properly interested are invited to be present at the Bid Opening. Bids received after the time fixed for receipt cannot be considered. Certified check(s), bank cashier's check(s), or bid bond(s) shall be required with the Base Bids equal to **five percent (5%) of the Base Bids. Make checks or bid bonds payable to South Kitsap School District No. 402.**
