



## The Educational Programs & Operations Levy Empowers and Engages Students!

In 2021, the voter approved levy from 2017 will expire. We are asking voters to renew the same local tax rate and continue funding the current educational programs and operations in South Kitsap.



**This is a renewal of a levy which must be approved every four years.** The rate is estimated at \$2.50 per \$1,000 of assessed valuation. The tax rate per \$1,000 of assessed value will not exceed the current rate of \$2.50 and may be less over the course of the levy.



**The levy provides critical school funding** and makes up 15 percent of South Kitsap School District's budget and funds more than 150 staff positions. **This is not a new tax. It is a replacement for the levy that expires in 2021.**



**The levy bridges the gap in educational funding.** Opportunities for students in athletics, activities, and academics outside of core instruction are not funded by the state and are dependent on local tax payer support.

### What Will The Levy Cost?

If voters approve the replacement levy, the local tax rate will remain stable at \$2.50 per thousand of assessed valuation.



This local support replacement levy funds **15%** of our school district's daily operating budget. State and federal dollars fund **85%** of the day-to-day operations of South Kitsap School District.




## Renewal = Stable Local Tax Rate

2022 Collection Estimate = \$2.50 / thousand \$27,880,220  
2023 Collection Estimate = \$2.50 / thousand \$30,386,678  
2024 Collection Estimate = \$2.50 / thousand \$33,118,717  
2025 Collection Estimate = \$2.50 / thousand \$36,096,640

\* The tax rate per \$1,000 of assessed value will not exceed the current rate of \$2.50 and may be less over the course of the levy.


