The motion carried, 5-0.

The Board President opened the Additional Appropriation Hearing at 5:41 p.m. Dr. Wyndham presented information relative to the hearing. There were no questions or comments from the public. There were eight people in attendance. The hearing was closed at 5:42 p.m.

Mrs. DeWeese made a motion, seconded by Mr. McDavid, that the Board of School Trustees approve the Additional Appropriation Resolution for the Pension Debt fund as presented. The motion carried 5-0.

The working session reconvened at 5:43 p.m.

Mr. McDavid made a motion, seconded by Mrs. Engelhardt, that the Board of School Trustees adopt the 2018 Budget Resolution as presented. The motion carried 5-0.

Mr. McDavid made a motion, seconded by Mrs. Engelhardt, that the Board of School Trustees adopt the 2018-2019-2020 CPF Plan Resolution as presented. The motion carried 5-0.

Mr. McDavid made a motion, seconded by Mrs. Engelhardt, that the Board of School Trustees adopt the Bus Replacement Plan Resolution as presented. The motion carried 5-0.

Mr. Webb made a motion, seconded by Mrs. DeWeese, that the Board of School Trustees authorize the Director of Finance & Operations to advertise the Notice of Adoption for the 2018-2019-2020 CPF Plan as presented. The motion carried 5-0.

Mr. McDavid made a motion, seconded by Mrs. Engelhardt, that the Board of School Trustees adopt the Pension Bonds Levy Neutrality Resolution as presented. The motion carried 5-0.

Mrs. DeWeese made a motion, seconded by Mr. McDavid, that the Board of School Trustees approve the General Fund Transfer Resolution as presented. The motion carried 5-0.

Mrs. DeWeese made a motion, seconded by Mrs. Woodward, that the Board of School Trustees approve the Investment Resolution as presented. The motion carried 5-0.

Mr. Webb made a motion, seconded by Mrs. Engelhardt, that the Board of School Trustees authorize the Director of Finance & Operations to allocate LIT revenue into the Capital Projects Fund (CPF) based on specific budgetary needs. The motion carried 5-0.

Mrs. Engelhardt made a motion, seconded by Mr. McDavid, that the Board of School Trustees approve the uniform recommendations as presented, including a lease and rental agreement with Plymate pending legal review, and authorize the Director of Finance & Operations to execute all necessary documents. The motion carried 5-0.

Mrs. Woodward made a motion, seconded by Mrs. Engelhardt, that the Board of School Trustees approve the complete legally reviewed easement agreement and approve right of entry with Citizens Energy Group pending legal review. The motion carried 5-0.

There being no further business, the meeting adjourned at 6:10 p.m.
