209. HEALTH EXAMINATIONS/SCREENINGS	
<p>1. Authority SC 1402, 1403</p>	<p>In compliance with the School Code, the Board shall require that district students submit to health and dental examinations in order to protect the school community from the spread of communicable disease, to ensure that the student's participation in health, safety and physical education courses meets his/her individual needs, and to ensure that the learning potential of each student is not lessened by a remediable physical disability.</p>
<p>2. Guidelines SC 1402, 1407 Title 22 Sec. 7.13</p>	<p>Each student shall receive a comprehensive health examination upon original entry, in sixth grade, and in eleventh grade, conducted by the school physician, with written consent of the parent/guardian.</p>
<p>SC 1403, 1407</p>	<p>Each student shall receive a comprehensive dental examination upon original entry, in third grade, and in seventh grade, conducted by the school dentist, with written consent of the parent/guardian.</p>
<p>SC 1407</p>	<p>A private health and/or dental examination conducted at the parents' request and expense will be accepted in lieu of the school examination.</p> <p>The district will accept reports of privately conducted physical and dental examinations completed within one (1) year prior to a student's entry into the grade where an exam is required.</p>
<p>SC 1402</p>	<p>Each student shall receive, from the school nurse or medical technician, vision tests, hearing tests, height and weight measurements, tuberculosis tests, and other tests deemed advisable, at intervals established by the district.</p>
<p>SC 1409 Pol. 216</p>	<p>The individual records of health examinations shall be maintained as a confidential record, subject to statute and Board policy.</p>

<p>SC 1419 Title 28 Sec. 23.45</p>	<p>A student who presents a statement signed by the parent/guardian that a medical examination is contrary to his/her religious beliefs shall be examined only when the Secretary of Health determines that the student presents a substantial menace to the health of others.</p>
<p>SC 1402, 1406 Title 22 Sec. 7.13</p>	<p>Where it appears to school health officials or teachers that a student deviates from normal growth and development, or where school examinations reveal conditions requiring health or dental care, the parent/guardian shall be informed; and a recommendation shall be made that the parent consult a private physician or dentist. The parent shall be required to report to the school the action taken subsequent to such notification. When the parent/guardian informs the school of financial inability to provide an examination, the school shall advise him/her of the availability of public assistance. Where no action is taken, the school may conduct further examinations.</p>
<p>SC 1405 Title 28 Sec. 23.2 20 U.S.C. Sec. 1232h</p>	<p>Parents/Guardians of students who are to receive physical and dental examinations or screenings shall be notified. The notice shall include the date and location of the examination or screening and notice that the parent/guardian may attend or may have the examination or screening conducted privately at the parent's expense. Such statement may also include notification that the student may be exempted from such examination or screening if it is contrary to the parent's religious beliefs.</p> <p><u>Student Illness</u></p> <p>If a student becomes ill in school, every attempt will be made to contact the parent. If the parent cannot be reached, the nurse or designee will contact one of the individuals designated by the parent as an emergency contact.</p> <p>If the condition is serious, the nurse will contact the family physician or school physician. If a physician cannot be contacted, the nurse or designee may arrange to hospitalize the student.</p> <p>Should it be necessary to hospitalize the student, the nurse or designee will accompany the student to the hospital. The building principal will be responsible for contacting the parents.</p>
<p>3. Delegation of Responsibility SC 1402</p>	<p>The Superintendent or designee shall instruct all staff members to continually observe students for conditions that indicate health problems or disability and to promptly report such conditions to the school nurse.</p>
