AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to procurement that we communicated to District management and the Board of Directors in a letter dated May 13, 2021. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Kennewick School District No. 17 from September 1, 2019 through August 31, 2020.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Payroll gross wages, leave cash outs and supplemental contracts
- Accounts payable general disbursements
- Procurement public works and professional services
- Land purchases for future school sites
- Tracking and monitoring of theft sensitive assets, such as Chromebooks
- Cash receipting timeliness and completeness of deposits at the Nutrition department

- Associated Student Body Activities at Kamiakin, Kennewick and Southridge high schools; Desert Hills and Horse Heaven Hills middle schools; and Amon Creek, Hawthorn and Cascade elementary schools fundraisers
- Use of restricted funds professional learning and local revenues
- Self-insurance for health and welfare, unemployment and workers compensation
- Financial condition

INFORMATION ABOUT THE DISTRICT

Kennewick School District No. 17, located in Benton County, provides educational services to about 19,000 students in pre-kindergarten through 12th grade. The District operates three high schools, an alternative high school, one project based high school, a skills center, five middle schools, 17 elementary schools, a parent partnership, STEM high school and one preschool. In addition, the District also holds classes at the Juvenile Justice Center.

An elected, five-member Board of Directors governs the District. The Board appoints management to oversee the District's daily operations and about 2,500 certificated and classified staff. For fiscal year 2020 the District's total expenditures were about \$380 million.
