

RESOLUTION NO. 21-

A RESOLUTION DECLARING THE IMPROVEMENT TO CERTAIN PARCELS OF REAL PROPERTY TO BE A PUBLIC PURPOSE AND EXEMPT FROM TAXATION; ESTABLISHING A REDEVELOPMENT TAX EQUIVALENT FUND AND PROVIDING FOR THE COLLECTION AND DEPOSIT OF SERVICE PAYMENTS INTO THAT FUND; AND SPECIFYING THE PUBLIC INFRASTRUCTURE IMPROVEMENTS DIRECTLY BENEFITING THE PARCELS.

It was moved by _____, seconded by _____ to approve the following:

WHEREAS, Ohio Revised Code Sections 5709.77 to 5709.80 (collectively, the “*TIF Statutes*”) authorize the legislative authority of a county, by resolution, to declare the improvement to parcels of real property located within the unincorporated territory of the county to be a public purpose and exempt from taxation, require the owner of each parcel to make service payments in lieu of taxes, establish a redevelopment tax equivalent fund for the deposit of the those service payments, and specify public infrastructure improvements made, to be made or in the process of being made that directly benefit, or that once made will directly benefit, those parcels; and

WHEREAS, this Board has determined to declare the improvements to certain parcels of real property, which parcels are further described in Section 1, to be a public purpose; and

WHEREAS, this Board desires to provide for the construction and/or installation of the public infrastructure improvements described in Section 2; and

WHEREAS, notice of this proposed Resolution has been delivered to the Boards of Education of the Olentangy Local School District and the Delaware Area Career Center; and

WHEREAS, the Olentangy Local School District, pursuant to a resolution of the Board of Education of the Olentangy Local School District adopted on June 10, 2021, has approved the TIF Exemption and waived the notice requirements of Ohio Revised Code Sections 5709.78, 5709.83 and 5715.27; and

WHEREAS, the Delaware County Career Center, pursuant to a resolution of the Board of Education of the Delaware Area Career Center adopted on June 17, 2021, has acknowledged and consented to the TIF Exemption, and waived the notice requirements of Ohio Revised Code Sections 5709.78, 5709.83 and 5715.27;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Delaware, State of Ohio, that:

Section 1. Parcels of Real Property. The parcels of real property subject to the exemption granted by this Resolution are identified and depicted in **EXHIBIT A** attached hereto (each, as currently or subsequently configured, individually, a “*Parcel*” and collectively, the “*Parcels*”).

Section 2. Public Infrastructure Improvements. This Board hereby designates the public infrastructure improvements described in **EXHIBIT B** attached hereto (the “*Public Infrastructure Improvements*”) and any other public infrastructure improvements hereafter designated by resolution as public infrastructure improvements made, to be made or in the process of being made by the County that directly benefit, or that once made will directly benefit, the Parcels. With the exception of any public infrastructure improvements made to or related to any existing or future interchanges at Interstate Route 71 and US36/SR37, the Public Infrastructure Improvements shall be made within the jurisdictional boundaries of the Olentangy Local School District.

Section 3. Authorization of Tax Exemption. This Board hereby finds and determines that 75% of the increase in assessed value of each Parcel subsequent to the effective date of this Resolution (which increase in assessed value is hereinafter referred to as the “*Improvement*” as defined in Ohio Revised Code Section 5709.77(D)) is hereby declared to be a public purpose and shall be exempt from taxation in accordance with Ohio Revised Code Section 5709.78(A) for a period commencing for each Parcel with the first tax year that begins after the effective date of this Resolution and in which an Improvement attributable to a new structure on that Parcel first appears on the tax list and duplicate of real and public utility property were it not for the exemption granted by this Resolution and ending on the earlier of (a) twenty (20) years after such commencement or (b) the date on which the County can no longer require service payments in lieu of taxes, all in accordance with the requirements of the TIF Statutes. The real property tax exemption granted pursuant to this Section and the payment obligation established pursuant to Section 4 are subject and subordinate to any real property tax exemption granted pursuant to Sections 3735.65 to 3735.70 or Sections 5709.61 to 5709.69 of the Ohio Revised Code.

Section 4. Service Payments. Pursuant to Ohio Revised Code Section 5709.79, the owner of each Parcel is hereby required to and shall make service payments in lieu of taxes with respect to the Improvement allocable thereto to the Treasurer of Delaware County, Ohio (the “*County Treasurer*”) on or before the final dates for payment of real property taxes. The service payments in lieu of taxes shall be charged and collected in the same manner and in the same amount as the real property taxes that would have been charged and collected against that Improvement if it were not exempt from taxation pursuant to Section 3 of this Resolution, including any penalties and interest (collectively, the “*Service Payments*”). The Service Payments, and any other payments with respect to each Improvement that are received by the County Treasurer in connection with the reductions required by Ohio Revised Code Sections 319.302, 321.24, 323.152 and 323.156, as the same may be amended from time to time, or any successor provisions thereto as the same may be amended from time to time (the “*Property Tax Rollback Payments*”), shall be allocated, distributed and deposited in accordance with Section 6 of this Resolution.

Section 5. TIF Fund. This Board hereby establishes, pursuant to and in accordance with the provisions of Ohio Revised Code Section 5709.80, the Berlin Business Park Tax Equivalent Fund (the “*TIF Fund*”). The TIF Fund shall be maintained in the custody of the County and shall receive all distributions to be made to the County pursuant to Section 6 of this Resolution. Those Service Payments and Property Tax Rollback Payments received by the County with respect to the Improvement of each Parcel and so deposited pursuant to Ohio Revised Code Section 5709.80 shall be used solely for the purposes authorized in the TIF Statutes or this Resolution. The TIF Fund shall remain in existence so long as such Service Payments and Property Tax Rollback Payments are

collected and used for the aforesaid purposes, after which time the TIF Fund shall be dissolved and any incidental surplus funds remaining therein transferred to the County's General Fund, all in accordance with Ohio Revised Code Section 5709.80.

Section 6. Distributions. Pursuant to the TIF Statutes, the County Treasurer is requested to distribute the Service Payments and Property Tax Rollback Payments to the County for further deposit into the TIF Fund for (a) payment of costs of the Public Infrastructure Improvements, including, without limitation, debt charges on any securities of the County issued to pay or reimburse financing costs or costs of those Public Infrastructure Improvements and (b) any other lawful purpose.

All distributions required under this Section 6 are requested to be made at the same time and in the same manner as real property tax distributions.

Section 7. Further Authorizations. The County Commissioners, or any of them, the County Auditor, the County Prosecutor, the County Treasurer, the County Administrator, the Economic Development Director, the Clerk of this Board and other County officials, as appropriate, are each authorized and directed to make such arrangements as are necessary and proper for collection of the Service Payments and the Property Tax Rollback Payments and to prepare and sign all documents and instruments and to take any other actions as may be appropriate to implement this Resolution.

Section 8. Non-Discriminatory Hiring Policy. In accordance with Ohio Revised Code Section 5709.832, this Board of Commissioners hereby determines that no employer located in the Parcels shall deny any individual employment based solely on race, religion, sex, disability, color, national origin or ancestry. The County shall include a non-discriminatory hiring policy covenant in any development agreement entered into between the County and any owner or developer of any Parcel.

Section 9. Tax Incentive Review Council. The applicable Tax Incentive Review Council, with the membership of that Council to be constituted in accordance with Section 5709.85 of the Ohio Revised Code, shall, in accordance with Section 5709.85 of the Ohio Revised Code, review annually all exemptions from real property taxation granted by this Resolution and any other such matters as may properly come before that Council, all in accordance with Ohio Revised Code Section 5709.85.

Section 10. Filings with Ohio Development Services Agency. Pursuant to Ohio Revised Code Section 5709.78(H), the Economic Development Director or designee is hereby directed to deliver a copy of this Resolution to the Director of the Ohio Development Services Agency within fifteen days after its effective date. Further, and on or before March 31 of each year that the tax exemption authorized by Section 3 remains in effect, the Economic Development Director or other authorized officer of the County is directed to prepare and submit to the Director of the Ohio Development Services Agency the status report required under Ohio Revised Code Section 5709.78(H).

Section 11. Open Meetings. This Board finds and determines that all formal actions of this Board and any of its committees concerning and relating to the passage of this Resolution were taken in an open meeting of this Board or any of its committees, and that all deliberations of this Board and any of its committees that resulted in those formal actions were in meetings open to the public, all in compliance with the law including Ohio Revised Code Section 121.22.

Section 12. Effective Date. This Resolution shall be in full force and effect immediately upon its adoption.




Section 3. Authorization of Tax Exemption. This Board hereby finds and determines that 75% of the increase in assessed value of each Parcel subsequent to the effective date of this Resolution (which increase in assessed value is hereinafter referred to as the “*Improvement*” as defined in Ohio Revised Code Section 5709.77(D)) is hereby declared to be a public purpose and shall be exempt from taxation in accordance with Ohio Revised Code Section 5709.78(A) for a period commencing for each Parcel with the first tax year that begins after the effective date of this Resolution and in which an Improvement attributable to a new structure on that Parcel first appears on the tax list and duplicate of real and public utility property were it not for the exemption granted by this Resolution and ending on the earlier of (a) twenty (20) years after such commencement or (b) the date on which the County can no longer require service payments in lieu of taxes, all in accordance with the requirements of the TIF Statutes. The real property tax exemption granted pursuant to this Section and the payment obligation established pursuant to Section 4 are subject and subordinate to any real property tax exemption granted pursuant to Sections 3735.65 to 3735.70 or Sections 5709.61 to 5709.69 of the Ohio Revised Code.

Section 4. Service Payments. Pursuant to Ohio Revised Code Section 5709.79, the owner of each Parcel is hereby required to and shall make service payments in lieu of taxes with respect to the Improvement allocable thereto to the Treasurer of Delaware County, Ohio (the “*County Treasurer*”) on or before the final dates for payment of real property taxes. The service payments in lieu of taxes shall be charged and collected in the same manner and in the same amount as the real property taxes that would have been charged and collected against that Improvement if it were not exempt from taxation pursuant to Section 3 of this Resolution, including any penalties and interest (collectively, the “*Service Payments*”). The Service Payments, and any other payments with respect to each Improvement that are received by the County Treasurer in connection with the reductions required by Ohio Revised Code Sections 319.302, 321.24, 323.152 and 323.156, as the same may be amended from time to time, or any successor provisions thereto as the same may be amended from time to time (the “*Property Tax Rollback Payments*”), shall be allocated, distributed and deposited in accordance with Section 6 of this Resolution.

Section 5. TIF Fund. This Board hereby establishes, pursuant to and in accordance with the provisions of Ohio Revised Code Section 5709.80, the Ravines at Meadow Ridge Tax Equivalent Fund (the “*TIF Fund*”). The TIF Fund shall be maintained in the custody of the County and shall receive all distributions to be made to the County pursuant to Section 6 of this Resolution. Those Service Payments and Property Tax Rollback Payments received by the County with respect to the Improvement of each Parcel and so deposited pursuant to Ohio Revised Code Section 5709.80 shall be used solely for the purposes authorized in the TIF Statutes or this Resolution. The TIF Fund shall remain in existence so long as such Service Payments and Property Tax Rollback Payments are collected and used for the aforesaid purposes, after which time the TIF Fund shall be dissolved and any incidental surplus funds remaining therein transferred to the County's General Fund, all in accordance with Ohio Revised Code Section 5709.80.

Section 6. Distributions. Pursuant to the TIF Statutes, the County Treasurer is requested to distribute the Service Payments and Property Tax Rollback Payments to the County for further deposit into the TIF Fund for (a) payment of costs of the Public Infrastructure Improvements, including, without limitation, debt charges on any securities of the County issued to pay or reimburse financing costs or costs of those Public Infrastructure Improvements and (b) any other lawful purpose.

All distributions required under this Section 6 are requested to be made at the same time and in the same manner as real property tax distributions.



General Exclusions:

1. The following general scope items are not included as part of this GMP and are assumed to be by others or by Owner:

 - Builders Risk Insurance
 - Professional Liability Insurance (Unless specifically called out for an individual trade)
 - Remediation and removal of any contaminated materials
 - Building Permit
 - Health Department Permit
 - EPA/Storm Water Pollution Permit
 - Utility Service Charges
 - Utility Consumption for Gas, Water or Electric
 - Environmental Site Assessments
 - Geotechnical Site Investigation and soils testing
 - Material inspections & testing, including FF/FL testing on slabs
2. Any work associated with Tornado Shelters, which are not identified in the plans.
3. Any additional scope required from final building department permit approval that is not identified within the GMP documents.
4. Tap Fees, Utility Capacity Charges, Connection Charges, New Service Charges, or any other utility charge is not included.
5. Importing or exporting of soils from the site is excluded. It is assumed that all spoils from the site will be able to be utilized within the school property.
6. Custom colors of materials not specifically identified in the documents are not included.
7. Site utilities that may be needed, but not identified on drawings are not included.
8. The pad mount transformer, meter, meter wiring and underground electrical service cable shall be supplied by Power Company serving the school.
9. Lime or Chemical stabilization of soils is specifically excluded from this GMP, except as noted and identified in GMP #1 (North and West roadway/parking areas. Drying of soil will be done via disking if it is determined that optimum moisture can be achieved through this method as determined by Owners testing company. If soil moisture levels can't be achieved after three attempts of disking (per area) additional compensation will be required.
10. Mass rock and utility rock excavation, rock blasting, chipping, hammering or excavation of any rock is excluded.

11. Additional well points and subsurface dewatering is excluded.
12. Removing, handling, testing of any hazardous materials.
13. Costs for Testing and Inspections, including Code-Required Special Inspections to be paid for by Owner. Exclude costs for additional samples, tests, and inspections required by contractor beyond specified requirements, due to no fault of the contractor. Does not exclude participation and assistance to complete any special inspection requirements per General Conditions. Specific testing and testing reports included within specification sections as part of a submittal is included.
14. We do not have a dedicated telephone line in the field office included.
15. Pond Liners are excluded.

Clarifications:

1. This GMP represents the full and complete scope of work associated with the Olentangy Middle School No. 06.0. This GMP combined with GMP No. 01.0 will complete the necessary scope of work for the New Middle School No. 06.0:
2. Project is a non-prevailing wage and is sales tax exempt.
3. Project Notice To Proceed to be issued no later than June 14, 2021 based on Board Approval at the June 10, 2021 Board Meeting.
4. Schedule delays beyond our control may occur due to the current Coronavirus situation. We reserve the right to modify our schedule due to any changes or increases in the Federal or State mandated guidelines. This impact could also lead to additional costs due to Government mandates associated with COVID-19.
5. Commissioning is included but only as an active participant; Cost of the Commissioning Agent is by others.
6. Our GMP is based on the assumption that the building fire water service is sufficient to provide flow and pressure as required in Specification Division 21 and as calculated through the Sprinkler Contractor assessment during the Design Assist process. We do not have any enhancements to the water system, such as pumps, storage, etc., to boost the water system.
7. The gas service meter is being provided by others.. The primary electric service & transformer are being provided by others conduits for primary service are included as shown on drawings in this GMP(our work starts at the secondary side of the transformer). Fiber Service, Telco Service, and cable TV service is not included Conduits as shown on drawings are part of this GMP(our work starts at the building Demark). All service pulls are being provided by the others.
8. The storm and sanitary lines are to be brought to within five (5) feet of the building as part of the Sitework and Utilities Scope of Work. All storm and sanitary connections related to this GMP will be starting from five (5) foot

outside the building to the interior. The cost for the Technology Conduit installation and wire is carried under this GMP.

9. All costs for testing to be paid by the Owner. RCS will coordinate with Architect or directly with Owner provided testing company for required inspections.
10. Background check requirements of construction personnel is not included as part of this GMP. If Co-owners elect to set up a background check requirement for all construction staff, a mutually agreeable list of minimum requirements will need to be established. The cost of completing background checks is not included in the GMP.
11. Any tap fees, capacity charges, connection charges, new service charges, and/or utility charges of any kind for the building are not included with this GMP. Contractor trailer facilities are included as cost of the work.
12. It is our intention to install all anchor bolts via drill and epoxy method post footing placement at locations approved by A/E. All anchor bolts that are required to be "wet set" are accounted for per supplemental information received in evaluation of this process.
13. Preliminary dirt calculations indicate excess topsoil on site. This topsoil will be stockpiled on site at location to be defined. No spoils are to be removed from the site. Areas that have been approved to receive additional topsoil in addition to existing topsoil will be proof rolled to a 90% compaction prior to adding topsoil on top. If contractor makes valid attempt to achieve 90% compaction on existing topsoil and this cannot be achieved there will need to be variation from the 90% requirement. This condition, if presented will be reviewed and discussed in field for determination to move forward.
14. A 12' wide construction road will be installed as part of the early site package. The areas of the construction road that will be at landscape areas will remain in place and covered with 6" of topsoil to bring to final grade. Areas in pavement or concrete will be incorporated into the construction.
15. Robertson Construction will require all personnel coming on site to abide by new COVID-19 Safety measures that have been put in place by Robertson Construction. This includes, but is not limited to Daily Temperature check to be submitted prior to coming on site, Health Safety Check forms to be completed on Monday, Wednesday and Friday or immediately upon coming to site, masks to be worn by all staff until further notice issued by Governor.
16. Locker Bases to be provided by locker manufacturer. Concrete bases are not included for lockers.
17. Perimeter insulation on foundations and slab is not included as none is shown.
18. Abuse resistant or impact resistant gypsum board is not included in this GMP as none was shown in specifications or drawings.
19. Spray-Applied Cellulosic or Glass Fiber Insulation "Monoglass" is listed under specification 72153, but not found in drawings and is not included as part of this GMP.
20. Discontinued laminates will be replaced with Standard laminates in similar colors/patterns from approved suppliers if necessary.

21. This GMP includes three coats of wax on VCT flooring materials and one coat of sealer on sealed concrete flooring.
22. Epoxy floor setting materials and Epoxy grout is not included in this GMP.

24. Biodegradable oil is not included as part of the Elevator proposal or included in this GMP. Oil for Elevator to be MAC32 Oil.
25. Per specification section 07 27 23 Boardstock Air Barrier we have excluded the ABBA installation requirements for testing and inspections by ABBA.
26. Drywall mock-up to be done in place in lieu of separate mock-up panels. This is per plan.

29. No rubber tile or rubber stair treads are included with this GMP.
30. This GMP does not include any Lightning Protection
31. This GMP does not include Data/Technology Head End equipment.
32. This GMP does not include DAS System, only Survey/testing to determine if there is a need for the DAS System.
33. Only minor floor prep is included in the flooring contractor's proposal, including joint preparation and a light skim coat. No grinding of joints is included. Any curling of concrete slabs would be considered additional cost to the base GMP. This is conditioned that the concrete was installed per specification and meets all testing requirements when installed. Due to this being an unquantifiable condition we have elected all costs to be done as the condition presents itself in lieu of including an inflated cost in concrete or flooring contractors bid.
34. The HVAC Control System is HEAT.
35. The electrical contractor is using Habitec Security.
36. Foundations will be earth formed.

Easement & Right of Way

Olentangy Local School District Board of Education, "Grantor", in consideration of \$1.00, the easement terms, and other good and valuable consideration from Ohio Power Company an Ohio corporation and a unit of American Electric Power, 700 Morrison Road, Gahanna, OH 43230, "Grantee", the receipt and sufficiency of which is acknowledged, grants and conveys with general warranty covenants to Grantee its successors, assigns, lessees, licensees and tenants, a right of way and easement, "Easement" for electric and other current/future energy or communication purposes, overhead and underground, in, on, over, through and across the following described lands situated in the State of Ohio, County of Delaware, Township of Berlin, being part of Farm Lots 9 and 24, Section 3, Township 4 North, Range 18 – United States Military Lands. Being part of a 44.983 acre tract of land as described in Official Records Volume 1809, Page 833 of the Delaware County Recorder's Office, Ohio (Parcel # 418-320-01-001-001).

Said lines and facilities shall be constructed within certain strips of land thirty (30) feet in width and fifteen (15) feet in width, the centerline being the facilities as installed. The approximate location of said easement is depicted on Exhibit A, attached hereto and incorporated herein.

This Easement conveys all necessary and convenient rights for the Easement's use, including, without limitation, the rights to: construct, operate, maintain, inspect, protect, repair, replace, enlarge, upgrade, extend and remove utility facilities and relocate within the Easement, all necessary and convenient facilities which include but are not limited to: poles, anchors, guys, supporting structures, conductors, conduits, enclosures, grounding systems, foundations, manholes, transformers, and associated equipment, adding thereto from time to time; perform grading or filling for such facilities; cut, trim, remove and/or otherwise control, with herbicides or by other means, at Grantee's option (without any liability to Grantor), any trees, limbs or branches, brush, shrubs, undergrowth, of whatever size, buildings, structures, or other obstructions that in Grantee's reasonable judgment endanger or interfere with the safety or use of its facilities, both within and adjoining the Easement. Within the Easement, Grantor shall not: place any structures, piles or debris, interfere with lateral support, change the level of the ground by excavation or mounding without Grantee's written consent, allow any construction that would be inconsistent with the National Electric Safety Code or Grantee's design standards, and, for underground lines, permit or cause any excavation, except for other utilities, provided such utilities rights do not conflict with this Easement. This Easement also conveys the right of ingress and egress in and over any reasonable routes at all times.

If any governmental authority requires Grantee to relocate the facilities contemplated by this grant, this Easement conveys the right to relocate such facilities to a comparable location of Grantee's choosing, without the need for a new easement.

Grantor may use its property for all purposes not inconsistent with the full enjoyment of the Easement, but Grantor acknowledges high voltage electric lines will be constructed within the Easement and Grantor shall use its property in a manner consistent with all applicable safety rules and regulations for working near electric lines. Safety/required clearance issues may be referred to Grantee's Engineering Group. Grantee shall restore the premises or pay reasonable damages done to fences, drains, seeded lawns (not landscaping), gates, ditches and crops caused by Grantee's use of the Easement. Grantor has authority to grant this Easement. No delay or omission by Grantee in exercising any right hereunder shall operate as a waiver or forfeiture of such right. This Easement grant is effective and binding upon the parties, their successors, assigns, lessees, licensees, heirs and legal representatives, and if any term hereunder is held invalid, the remainder shall not be affected thereby.

Professional Service Agreement
The Ohio State University Wexner Medical Center**

This Professional Services Agreement (the "Agreement") is entered into this 1st day of July, 2021 ("Effective Date") by and between the Olentangy Local Schools School District Board of Education ("OLSD"), located at 7840 Graphics Way, Lewis Center, OH 43035 and The Ohio State University on behalf of its Wexner Medical Center ("OSU") at 410 W 10th Ave, Columbus, OH 43210. OLSD and OSU are collectively referred to as the "Parties" or, separately, a "Party."

RECITALS

WHEREAS, OLSD is responsible for the education of students in the district; and

WHEREAS, OLSD coordinates services for children who are determined to be in need of additional and/or alternative behavioral health interventions that exceed the school system's expertise or statutory responsibility; and

WHEREAS, OSU is an academic medical center and through its Department of Psychiatry and Behavioral Health, employs professionals with the necessary qualifications to provide such services; and

NOW, THEREFORE, in consideration of the foregoing premises and covenants and conditions set forth herein, the parties hereto, intending to be legally bound hereby, agree as follows:

1. **Purpose.** OSU hereby offers to OLSD, and OLSD hereby accepts the student mental health services as detailed in Exhibit 1 (the "Services").
2. **Provider Qualifications.** OSU shall require that the psychotherapists and nurse practitioner be appropriately licensed, certified or otherwise qualified to provide the Services. OSU agrees to provide evidence of appropriate licensure, certification or qualification to the OLSD concurrently with the execution of this Agreement. OSU agrees to maintain appropriate licensure, certification or qualification throughout the term of this Agreement and to immediately notify OLSD of any change in OSU's licensure, certification or qualification to provide the Services.
3. **Background Checks.** OSU shall obtain Bureau of Criminal Investigation (FBI) criminal background checks for any employees that will be working in OLSD with students. These checks shall satisfy the requirements in R.C. 3319.39. OSU shall not assign any employee to perform duties pursuant to this Agreement who has a disqualifying offense under this statute and/or R.C. 3319.31. OSU shall pay the costs of obtaining background checks and it shall, upon request, provide OLSD with proof that it has complied with this request.
4. **Obligations of OLSD.** OLSD shall provide the following:

a) A private office for OSU psychotherapist to utilize at each building with all necessary equipment in good working condition to utilize during school hours (the "Office"). The Office will be utilized to meet with students, parents/guardians, community partners and school personnel, and to conduct administrative functions.

b) All necessary authorizations and consents from the students' parents or guardians, or from an eligible student who has reached the age of majority (18). OLSD will provide copies to OSU.

c) Appropriate emergency responder access to the Office.

5. **Records.** OLSD will maintain all educational records completed regarding the students relating to the provision of Services, in compliance with 20 U.S.C. § 1232g ("FERPA"), 20 U.S.C §§ 1400, *et seq.* ("IDEA"), 29 U.S.C. §§ 701, *et seq.* (§ 504 of the Rehabilitation Act) and other applicable laws. Except as described below, OLSD will retain custody and control of all medical records and charts related to Services provided under this Agreement, in compliance with Health Insurance Portability and Accountability Act of 1996 ("HIPAA"), as amended by the Health Information Technology for Economic and Clinical Health Act of 2009 ("HITECH"), and their respective implementing regulations, including the Privacy Standards adopted by the U.S. Department of Health and Human Services as they may be amended from time to time, 45 C. F. R. parts 160 and 164, subparts A and E (the "Privacy Rule"), the Security Standards adopted by the U.S. Department of Health and Human Services as they may be amended from time to time, 45 C.F.R. parts 160, 162 and 164, subpart C (the "Security Rule"), the Breach Notification Standards adopted by the U.S. Department of Health and Human Services, as they may be amended from time to time, at 45 C.F.R. part 164, subpart D (the "Breach Notification Rule"), as well as related state laws and/or regulations (collectively, the "HIPAA Rules"), and other applicable laws and regulations.

Students, who at their own expense, seek ongoing care at OSU locations are considered patients of OSU providers who are "health care providers" under HIPAA and records of such visits are OSU records and are subject to HIPAA, not FERPA.

6. **Reports.** OSU agrees to provide such reports and data to OLSD as it may request to document: program outcomes, number of students served, linkages to other community providers and such other information as requested by OLSD in a format agreed upon by OSU and OLSD. It is understood and agreed that all such information sharing will be subject to all federal and state laws, rules and regulations pertaining to the confidentiality and privacy of educational and health records.

7. **Compensation.** The estimated annual cost for the Services is set forth in Exhibit 2.

8. **Confidentiality.** OSU acknowledges and agrees that the confidentiality of a student's medical information is of the utmost important and that any student medical information received by OSU shall be kept strictly confidential, without the prior consent of the parent, guardian, eligible student who has reached the age of majority (18), or as required by applicable law. .

9. **Independent Contractor.** The parties agree that OSU is an independent contractor and that nothing in this Agreement shall be construed to create any other relationship between the parties,

including but not limited to, that of employee, partner, agent, joint venture, or representative. OLSD shall not be responsible to OSU or to any governing body for any payroll-related taxes related to the performances of services, including, but not limited to, withholding or other taxes related to federal, state or local income tax, social security benefits or unemployment compensation. OSU shall be solely responsible for the payment of any local, state or federal fee or tax, including but not limited to, workers' compensation, social security, unemployment insurance and income taxes, that may be due and owing from the amounts paid under this Agreement. OSU is not eligible to participate in OLSD's pension, health or other fringe benefit plans. Neither Party shall have any right, power or authority to enter into any agreement for or on behalf of, or incur any obligation or liability on behalf of, or to otherwise bind, the other Party.

10. Insurance. OSU shall acquire and be responsible for maintaining professional liability coverage in the amount of \$1 million per incident and \$3 million annual aggregate. OLSD will maintain customary comprehensive general liability insurance in types and with limits of liability not less than those which are customary for its operation, and reasonably adequate to cover liabilities arising out of its obligations hereunder. Each Party shall provide the other with proof of such insurance coverage promptly upon the request by the other.

11. No Assignment. No Party shall assign this Agreement or any of the rights and responsibilities it contains without the prior written consent of the other Party, and any attempted assignment or delegation without consent shall be void and of no effect. Subject to the foregoing, this Agreement shall be fully binding upon, inure to the benefit of and be enforceable by the Parties hereto and their respective.

12. Subcontract. No work or services to be performed by OSU hereunder shall be subcontracted to or performed on behalf of OSU by any third party, except upon written permission by OLSD.

13. Non-Discrimination. OSU shall provide all services under this Agreement in the manner appropriate to any special needs, status, or background of the student, including, but not limited to race, color, sexual orientation, age, handicap, national origin, or ancestry.

14. Amendment. This Agreement may only be amended by the express, written agreement of both parties.

15. Term. The term of this Agreement shall be from July 1, 2021 through June 30, 2023 ("Term"), unless or until it is terminated earlier in accordance with this Agreement. Upon any extension or renewal of this Agreement, the parties shall assess and make necessary changes to the payment to ensure it remains fair market value and commercially reasonable for the Services.

16. Termination. This Agreement may be terminated by either Party with or without cause with sixty (60) days written notice to the other party. Notwithstanding the foregoing, either Party, upon written notice to the other Party shall have the right to terminate this Agreement in the event of a material breach by the defaulting Party. The defaulting Party shall have 30 calendar days after receipt of a written notice to cure such breach, or, if the breach is not reasonably cured within such 30 calendar day period, or the defaulting Party has not commenced to cure the default within such time period and proceeded to cure

the safe with reasonable diligence thereafter, the non-defaulting Party shall have the right to terminate this Agreement immediately upon the expiration of such cure period.

17. Notice. Any notice required pursuant to this Agreement shall be in writing and shall be deemed to have been delivered and given for all purposes (a) on the delivery date, if delivered personally to the party to whom the notice is addressed; (b) deposited in U.S. first class mail, return receipt requested, postage and charges prepaid or any other means of rapid mail delivery for which a receipt is available; or (c) sent by electronic mail with confirmation of receipt, addressed to the address set forth below or to such other address as either Party may designate in writing to the other Party from time to time.

18. Construction; Severability. In the event that any provision of this Agreement conflicts with the law under which this Agreement is to be construed or if any such provision is held invalid by a court with jurisdiction over the Parties to this Agreement, (i) such provision shall be deemed to be restated to reflect as nearly as possible the original intentions of the Parties in accordance with applicable law, and (ii) the remaining terms, provisions, covenants and restrictions of this Agreement shall remain in full force and effect.

19. Applicable Law. This Agreement shall be interpreted, construed and enforced in all respects in accordance with the laws of the State of Ohio. Each party irrevocably consents to the exclusive jurisdiction of the Court of Claims in connection with any action to enforce the provisions of this Agreement, to

recover damages or other relief for breach or default under this Agreement, or otherwise arising under or by reason of this Agreement.

20. Entire Agreement. This Agreement constitutes the entire agreement between the Parties and supersedes all prior agreements, whether written or oral, between the Parties.

21. Headings. The captions and headings used in this Agreement are inserted for convenience only and shall not affect the meaning or interpretation of this Agreement.

22. Counterparts. This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same document.

Exhibit 1 – Services

1. OSU will provide four (4) full-time, on site psychotherapists to OLSD. The psychotherapists will be assigned, one each, to each of OLSD's four high schools. The psychotherapists would hold LISW, LISW-S, LSW, LPC, or LPCC licensure. Placement of psychotherapists will be agreed upon by OLSD and OSU. Their services include:
 - a. Assisting with the evolution of an effective, efficient preventative services program;
 - b. Participating in public information and public relations activities, serve as a community liaison and advocate for mental health and OLSD;
 - c. Screening, referral and case management activities to help OLSD's students access relevant services;
 - d. Providing high quality direct services, including crisis intervention, psychotherapy, assessment, support services, and follow up to at-risk students and their families;
 - e. Coordinating intervention strategies with school personnel, mental health center personnel and other community agencies;
 - f. Coordination and collaboration with other child serving systems;
 - g. Maintaining data and documentation to track outcome measures and assist in compiling outcome measure reports for OLSD;
 - h. Completing all paperwork associated with the financial, clinical, legal, or regulatory management of the case or OLSD's operations in a timely and accurate manner ;
 - i. In response to periodic tragic events, OLSD may request the provision of short-term crisis services on behalf of students, school personnel, family members and the community-at-large. OLSD acknowledges that the psychotherapist's availability will control OSU's ability to accept expanded services requests, and OSU is under no obligation to accept such requests. However, OSU will make every effort to accommodate OLSD's requests; and
 - j. If ongoing treatment is recommended for a student referred by OLSD, OSU will work in partnership with the parent or guardian and OLSD to provide a list of appropriate referral sources and a recommended level of care which may or may not include a referral to OSU. External referrals may be directed to an alternative provider based on the student's unique needs. If ongoing treatment is deemed necessary, parent(s) or guardian(s) would be informed of potential for additional costs associated with different levels of care. OSU shall in no way limit a student's ability to seek treatment from his or her own physician.
2. OSU will provide one (1) on site Lead Clinician to OLSD. The Clinical Lead's services include:
 - a. Serving as a primary liaison between OLSD, clinical providers, and OSU to ensure successful program administration and to best meet the needs of OLSD and students;
 - b. Administering the program to ensure quality, safety, compliance, and consistency across the schools;
 - c. Supervising the four psychotherapists providing services to OLSD;
 - d. Developing policies, procedures and guidelines for services provided;
 - e. Communicating with current OLSD student support services, faculty and staff;
 - f. Leading educational programming and initiatives for OLSD; and
 - g. Providing clinical services throughout the district (estimated 70% clinical appointment):

- i. Addressing unmet student needs or overflow volume at OLSD high schools; and
 - ii. Addressing emergent needs or volume-based needs at OLSD middle schools.
3. OSU will provide priority access to one (1) Nurse Practitioner to OLSD for four (4) hours per week. The Nurse Practitioner's services include:
 - a. Providing high quality direct services, including crisis intervention, psychotherapy, assessment, medication management, and follow up to at-risk students and their families; and
 - b. These services will be provided at OSU locations and billed to the individual's insurance.
4. OSU will provide a minimum of three (3) annual public education events to OLSD stakeholders. The Clinical Lead will work with OLSD to create the topics and content, and to determine the target audience for each event.
5. Upon OLSD's request, OSU will create an explanatory pamphlet and/or information packet(s) outlining available behavioral health services for students, to be provided to OLSD parents or stakeholders.
6. OSU will create informative content for OLSD's website(s) and/or social media platforms outlining services provided as well as blogs, posts, or related information containing helpful hints or relevant topics for students.
7. OSU will work to ensure students in need of referral for additional services would be given priority access to OSU's services and to those from OSU's collaborative organizations throughout Central Ohio. However, OSU shall in no way limit a student's ability to seek treatment from his or her own physician.
