The school have more than 50+ members and staff and to comply with the current [Schools coronavirus \(COVID-19\) operational guidance \(publishing.service.gov.uk\)](https://www.publishing.service.gov.uk/government/uploads/system/uploads/attachment_data/file/90122/schools-coronavirus-guidance) from 08 Mar 21 and to ensure compliance with the [Health and Safety Executive \(HSE\)](https://www.hse.gov.uk/) a copy of this risk assessment has been placed on the school website. Following the announcement of a National Lockdown on 04 January 2021 the School had only been open for vulnerable children and the children of critical workers until 08 Mar 21. From the schools return this revised Risk Assessment will apply to all students and staff.

Covid-19 is a virus that **is thought to spread mainly from person-to-person.**

- Between people who are in close contact with one another (within about 2 meters).
- Through respiratory droplets produced when an infected person coughs, sneezes, or talks.
- These droplets can land on hard surfaces and in the mouths or noses of people who are nearby or possibly be inhaled into the lungs
- Covid-19 may be spread by people who are not showing symptoms (Asymptomatic)

It is important to note however that staff are still required to wear face coverings in communal areas and other areas where social distancing may not be possible e.g. Staff room and in addition the wearing of masks beyond this minimum standard is welcomed. Remember, face coverings are just one in a series of control measures and should not be used in isolation.
