Dear Parents/Carers,

Since the Easter break the school has very much been refocusing on the curriculum and getting back to normal teaching; the most recent step being lessons moving back into subject areas. The Duke of Edinburgh's Award scheme is back up and running. The new Year 9 Bronze group have now completed an on-site training day learning about maps, how to make route cards and plan routes. They then put this into practise on an accompanied training walk round the local area. Just before half term they completed a weekend practice expedition. They started in Long Compton on the Saturday morning and navigated their way to Shipston on Stour. There was some fantastic navigation, some good navigation and times where groups found it a challenge. But they all completed day 1 having learnt lots about themselves, their group and about perseverance. This time we did send them home to sleep as overnight stays had only been permitted 5 days earlier and we continued to be cautious.

Who knew looking at the map frequently was going to help them know where they were. Lots of the students amazed me at how well they worked together and their enthusiasm all weekend. Have enjoyed lessons in ultimate Frisbee, volleyball and tennis this half term.



Student Absence Procedure

If your child is unwell and cannot attend school please call the 24 hour Absence Line on 01926 645 611 before 8.50am, stating their name and form, your name and the reason. This must be done for each day they will be absent.

If your child is unable to attend school for any reason other than illness, planned or emergency (part day, full day or multiple days), please always complete a leave of absence form and send it by email to enquiries@kinetonhighschool.org.uk This form should - we all need to play our part. be used for all appointments (medical, dental, music exams or external sporting activities), holiday requests, religious observance dates and all other reasons or circumstances where your child will be absent from school.

Failure to make an application for leave in advance can also result in a Fixed Penalty Notice being issued to the arrangements. parent(s).

Unauthorised Absence

There are times when children are absent for reasons, which are not permitted by law. Examples of unauthorised absence are parental illness, term time . holidays or a family day out. Where there is no explanation for an absence or where the explanation or reason for the absence is considered unsatisfactory absence will be recorded as 'unauthorised'. Unauthorised Absences have to be reported to the Local Authority. The Attendance Compliance Enforcement Team may contact you where unauthorised absence continues to be a problem. Unauthorised absence could result in a Fixed Penalty Fine or other legal action. We are always concerned about the amount of school time pupils miss as a result of term time leave. There is no entitlement to time off during term time. Leave of absence is only granted in The full Attendance policy can be found under exceptional circumstances at the discretion of the Headteacher in accordance with the school policy as agreed by the governing body.

We greatly appreciate parental support to reduce the total amount of days lost due to holidays. We are committed to working in partnership with you to enable your child to reach their academic targets and to support their social development. For this to happen we need to keep individual attendance as high as possible

It is our policy:

- Only in an exceptional circumstance will term time leave be allowed. Parents/Carers wishing to apply for leave of absence need to fill in an application form well in advance and before booking tickets or making travel
- If term time leave is taken without prior permission from the school, the absence will be unauthorised and you may be liable for a fixed-penalty fine or other legal action.
- Please remember that absence for whatever reason disadvantages a child by creating gaps in his/her learning. A good understanding of the work and good progress can only take place when the child is in the classroom regularly and on time.

If you think you have exceptional circumstances please talk to us without delay and before arrangements are entered into or money committed. If exceptional circumstances are accepted the Headteacher will determine how much absence will be authorised. Each application for a leave of absence will be considered on a case by case basis and on its own merits.

Warwickshire Secondary School pupils recorded 6,651 half day sessions of absence due to holiday in the Autumn/Spring term during academic year 2018/19. This is an increase of 602 on the previous year.
