# Introduction

Our Connecticut school communities — with students at the center — continue to be bold and innovative as they respond to the COVID-19 pandemic. The United States Department of Education (USED) has recognized the importance of supporting these efforts, particularly with the infusion of resources to support education in Connecticut. The American Rescue Plan Act of 2021 Elementary and Secondary School Emergency Relief Fund (ARP ESSER) has granted the State of Connecticut an additional \$1,105,919,874, providing the opportunity to develop bold, high-impact plans to address the substantial disruptions to student learning, interpersonal interactions, and social-emotional well-being. While earlier sources of federal relief funding during the pandemic supported our ability to first survive, and then thrive, ARP ESSER is Connecticut's opportunity to transform our schools.

The federal government requires that each Local Education Agency (LEA create a *Safe Return to In-Person Instruction and Continuity of Services Plan* (the Plan). This plan must be publicly available online by June 23, 2021 and submitted to the Connecticut State Department of Education (CSDE) as a part of the ARP ESSER application due mid-August 2021. To aid in the planning process, CSDE is providing this template to guide LEAs planning as well as serve as an opportunity to share the Plan with the public.

Due to the expansive efforts of the CSDE and the educational community, as of the week of May 3-7, <u>no district in the state of Connecticut was fully remote</u>. This was achieved through extensive planning by each LEA; therefore, this template should be seen as a means to support LEAs' efforts to date and can be used to expand upon or revisit previous Reopening School Plans.

The CSDE has maintained consistently that in-person learning is the preferred opportunity for students and that schools should work to safely open their buildings for the 2020–21 school year. We are proud to have led the nation in safe return to in-person instruction — as of April 30 nearly 82.7% of Connecticut school districts were offering a predominately fully in-person learning. Thank you for your work and helping us continue to be an example of how we can best serve our children safely in school buildings.

# I. Health and Safety Strategies

### Fairfield Public Schools continues to follow the most current Connecticut DPH and CSDE guidance.

As we approached the start of the 2020 - 2021 school year, Fairfield Public Schools committed to a Reopening Plan that was practical and responsive to the needs of students, staff, and the community, while adhering to the parameters laid out in Adapt, Advance, Achieve: Connecticut's Plan to Learn and Grow Together. Following our plan allowed us to bring PK-12 students back for full-time, in-person learning in March 2021.

Given our extensive work during the pandemic, we were well positioned for a safe return for the 2021-2022 school year. We reopened with a full in-person return while adhering to all local, state and federal requirements. New guidance from the State Departments of Public Health (DPH) and Education (SDE) supports the transition to the state's general public health approach to the routine management of respiratory viruses in PreK-12 schools.

	Mitigation strategy	LEA response
<b>✓</b>	Universal and correct wearing of masks	Effective February 28, 2022, Fairfield Public Schools has adopted a mask optional policy. As a school community, we commit to respecting the rights of students, staff, and visitors to wear a mask or to not wear a mask.  There may be a need to go back to temporary masking and additional mitigation strategies in the event of a cluster or outbreak (as determined with the Fairfield Health Department).
<b>✓</b>	Physical distancing (e.g., including use of cohorts/podding)	Students maintain a minimum of 3 feet distance whenever possible. The 6 feet distance will remain in effect for adults.  Cohorting will no longer be in effect.
<b>✓</b>	Handwashing and respiratory etiquette	Staff reviews guidance and training on proper handwashing techniques and respiratory etiquette with students. Frequent hand washing or hand sanitizing is expected and is supported by signage and hand sanitizer stations at all entry points and classrooms
<b>✓</b>	Cleaning and maintaining healthy facilities, including improving ventilation	Schools are cleaned and sanitized according to adopted procedures. Ventilation is continuously monitored to ensure necessary air flow.

	Mitigation strategy	LEA response
<b>✓</b>	Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments	Isolation and quarantine follows CDC guidance, including masking for 5 days upon return to school. Quarantine is based on out of school exposure only. Tracking and communication of positive cases has ended with the 21-22 school year. In the event of a cluster or outbreak in the 22-23 school year (as determined with the Fairfield Health Department), communication will resume as for any highly communicable disease.
<b>✓</b>	Diagnostic screening and testing	The school system uses COVID diagnostic testing in cooperation with the Fairfield Health Department to determine positive cases. Home/rapid tests are also accepted.
<b>✓</b>	Efforts to provide vaccinations to educators, other staff, and students, if eligible	Vaccination clinics are publicized through school communication channels. The Fairfield Health Department has offered and continues to offer clinics for students and staff to encourage vaccination and boosters.
<b>✓</b>	Appropriate accommodations for children with disabilities with respect to the health and safety policies	The district will continue to maintain health and safety protocols and policies to support the individual needs of students and staff.

# **II. Continuity of Services**

Beginning in September 2021, Fairfield Public Schools implemented an in-person learning model. Student learning is being supported with:

- Social emotional screening and counseling support
- Staff training in equity and anti-bias measures
- Identification of student needs for grade level skills and acceleration of instruction, with additional tutoring support as needed
- Collaborative grade and department work to align instruction in support of student learning needs

The public has had continual opportunities to provide input and comment to the Safe Return to In-Person Instruction and Continuity of Services Plan and subsequent updates through live comment at board of education meetings, email, and/or online comments on the district website. The plan was made publicly available on the district website along with a link for feedback and input. Initial public comment centered on the need for updated guidance to reflect the high vaccination rate and low infection rate in our community at the time. Subsequent updates of the Safe Return to In-Person Instruction and Continuity of Services Plan, including this June 23, 2022 update, will be posted on the FPS website along with a link for feedback and input.
