WAIVER & COMMITMENT

Frederica Academy truly is a FAmily and this becomes even more important in the midst of the COVID-19 pandemic.

The partnership of keeping your children safe along with our faculty and staff requires commitment on both of our parts. While we are optimistic that the priority of these precautions will wane over time, at the time of re-enrollment, our community is still experiencing pandemic conditions and as such, we are asking for your commitment in the event that we will open school in August 2021 under the same COVID-19 protocols that were implemented for the 2020-2021 year.

In this event, we will be asking our faculty and staff to make this assessment on a daily basis: Have I presented any of the following symptoms? Fever, shortness of breath, dry cough, runny nose, sore throat, respiratory symptoms, repeated shaking with chills, muscle pain, headache, or new loss of taste or smell. Have I experienced an exposure to someone diagnosed with COVID-19? If the daily assessment yields more than one yes answer, we will ask that employee to remove him/herself from the school environment until symptoms are no longer present. We will also be checking temperatures daily.

We would like to ask that you do the same with your child each school day. If your child has been exposed to someone diagnosed with COVID-19, please do not send him/her to school and contact the School Nurse at (912) 638-9981 ext. 492 or schoolnurse@fredericaacademy.org to discuss next steps.

On a daily basis, please assess your child for the following:

If any combination of these symptoms are present, do not send your child to school. The FAmily is relying on your good judgment. When dropping your child off at school each day, they will also have a temperature check. If the temperature exceeds 100 degrees, they will not be allowed to remain at school.

Athletics: While all FA students do not participate in extracurricular athletics, all Middle and Upper school students are eligible to participate in Frederica's athletic programs. The pandemic of COVID-19 introduces a new element of risk to the pursuit of athletics. The school has implemented many protocols to help protect our community from exposure to the virus. However, many of these protocols are just not possible while participating in athletics.

Because of the demand from students, parents, and the greater community, we have allowed athletics to continue but as a school community, we believe it is important to state that we do not believe it is possible to implement adequate safeguards to protect participants from the spread of the COVID-19 virus.

Because of this increased hazard, the school would like to request the parents/guardians of each student participating in athletics to acknowledge their acceptance of the risk and their understanding that the school makes no assertion of adequate protection – unlike what occurs on campus during the school day.
