Events with an Audience

All events that we deliver with an audience will have been fully risk assessed to adhere to government guidance. Examples of specific measures for any events with an audience include:

- Socially distanced audiences with strict max capacity for each venue.
 - o Big Top max 300 with an empty seat between each group.
 - o Jubilee Hall max 75 with an empty seat between each group.
- Face masks to be worn by all audience members at all times when indoors.
- One-way entry/exit system.
- Where served, drinks to be collected and only consumed once seated.

This is covered by the government guidance for the Performing Arts and a Festival venue risk assessment

Workshops - Pupils Only

We are confident that we can successfully deliver all planned workshops but with slight adjustments. In order to maintain pupil bubbles we will:

- Keep 2m between pupils in different bubbles
- Where 2m is not possible, maintain 1m plus with pupils wearing masks
- Pupils sanitise their hands on entry
- Students should queue outside the classroom in their bubbles
 - Year 7s to left of door, Year 8s to the right and Year 9s on opposite side of corridor
- Dismiss students by bubble

This is covered by the DFE guidance for schools and the school risk assessment for cross bubble co-curricular activity

Workshops - Pupils & Parents

In order to maintain social distancing requirements we will:

- Ensure parents and pupils can participate in groups of up to 2 households.
- Keep 2m between groups.
- Where 2m is not possible, maintain 1m plus with participants wearing masks for outdoor activities masks are not required.
- Participants sanitise their hands on entry
- Have groups wait outside the building and then enter with a 2m distance between them. There will be no communal gathering before and after events.
- Dismiss participants by group
