





#### What is the LCAP?

### Plan Summary- Areas to Celebrate

- Based on the 2019 CA Schools Dashboard, published in 2020
  - All students scored Level 5- BLUE Performance Band in both ELA
  - All students and sub-groups scored at Level 4- GREEN or Level 5-BLUE Performance Bands in Math
  - Students with Disabilities increased from Level 2- Orange to Level 3 Yellow in ELA
  - Graduation rate increased by 1.8% at 97.7% Level 5- BLUE Performance Band
- > iReady- Winter 2020 data confirms a high proficiency rate for ELA at 70% and 72% in Math
- The district has adopted the standards-aligned curriculum for TK-6 ELA/ELD (Wonders) and TK-5 Math (Math Expressions). For Oak Ave and Temple City High School, the district has adopted the standards-aligned curriculum for 7-12 for ELA /ELD (StudySync).

### Plan Summary- Areas to Celebrate

- Social Emotional Learning and students well being:
  - Teachers and Counselors were available: Teachers office hours, individual group and small group counseling sessions, Friday- SEL classes
  - Hiring of the Program Specialist- Equity and Outreach
  - Partnership with Care Solace Counseling
- Technology Integration:
  - Canvas Learning Management System: Central location to access teaching and learning
  - Parent Square: 99% Contact Rate
  - Universal Design for Learning (UDL): Differentiation of instruction and learning

### Plan Summary- Areas of Focus

- Social Emotional Learning: Student and staff emotional well being
  - Restorative Justice trainings for all staff including noon duties working with students during non instructional times
- Systematic implementation of:
  - MTSS at each school site (establishing Tier I and II support)
  - Standards based assessments (iReady, Mastery Connect, StudySync)
- Creating a positive and welcoming school culture
  - Training for all office staff: customer service, culturally relevant and responsive interactions




