BOARD PRESIDENT'S REPORT

Mr. Wyland announced four Extra Mile Award recipients to honor at this evening's meeting. Their extra effort made a significant difference for our students and staff this year. Lawrence Pajak, a District custodian for over 30 years, was nominated by Mrs. Kathy Taback who stated, "I have seen Larry countless times over the years collecting tickets and helping around the stadium. He seems to be the kind of gentleman that is steadfast and invaluable to MTLSD. He has been there in the pouring rain, freezing snow and any other weather that western Pennsylvania brings our way. I just think the past year has shown us how invaluable the "helpers" have been to our community, even the silent ones."

Athletic Director John Grogan also felt that Larry was a worthy recipient of this award saying, "Larry has worked at sporting events for years and has been invaluable to our department for a long time. I am so pleased he was nominated for the Extra Mile Award."

Hoover Elementary principal, Dr. Nicole Giehll, nominated Hoover staff members, Mary Ehland, Rae Ann Macosko and Kimberly Gamble, for going the extra mile this past year. Mary Ehland is a classroom aide in the Learning Support classroom for many years and her ability to build genuine connections with students allows them to feel seen, supported, and develop a true sense of belonging in our school, which we all know is foundational for learning to occur. This year Mary simply outdid herself. Rae Ann Macosko is the library/media specialist at Hoover. When the District shifted to the hybrid model in October, a teacher was needed to cover a temporary leave of absence in the new developed Cyber Learning Academy. Given her experience teaching 4th grade curriculum and excellent technology skills, she was an exceptional fit for the position. Her patience, adaptability, and resourcefulness have been vital to ensuring the day to day operations during this highly unusual year, and the District is very grateful. Kimberly Gamble serves at the counselor at Hoover. Over the years, Mrs. Gamble has worked tirelessly to help our Hoover students learn important lessons including understanding feelings/emotions and identifying effective coping strategies, as well as developing important character traits such as kindness, courage, resilience, diversity, empathy, respect, patience, and inclusion. The Hoover community is so fortunate to have a wonderful counselor like Mrs. Kimberly Gamble--she truly brings out the best in all.

Certificates and a small token of appreciation were presented to all four recipients. Mr. Wyland congratulated them for going above and beyond for the students of Mt. Lebanon School District.

The board president reported that the Board will vote this evening to approve the 2021-2022 final budget in the amount of \$108,211,756 setting the millage rate at 25.59 mills. The budget includes a .80 mill increase with the use of \$1.5 million from the Fund Balance. This is a balanced budget while maintaining our academic, fine arts and athletic programs.

Mr. Wyland reported that on Friday, May 21, Mr. Hugh Beal tendered his resignation as a School Board Director. The Board would like to thank Mr. Beal for his years of service and dedication to the District and the Mt. Lebanon community. He served with passion and an unwavering commitment to the students and the District. Mr. Beal believed his differences in opinion regarding District finances and policies made further service unproductive.

Mr Beal's resignation was submitted on Friday evening. I discussed the matter with Vice President Fleisher and Mr. Peterson, our solicitor over the weekend. The Board is required to appoint a replacement. However, because of the timing of Mr. Beal's resignation relative to the next municipal election, the appointment will only be for the next several months - through the next reorganization meeting. The two year balance of Mr. Beal's term will be on the ballot in November.

Regarding the appointment until that time, Board policy BBE provides that this is generally done through an application and interview process as we did when Mr. Freeman was appointed. However, the policy also provides that where the vacancy is for less than one year the Board may deviate from that policy. The vacancy to be filled is abbreviated and there is important work to be done in that time. The sooner we fill the spot and return the Board to capacity the better. I also believe that a former Board member, who served recently and would require next to no time getting up to speed is preferred. This circumstance is exactly what Section 5 of Policy BBE was intended for. And, it is not without precedent. Prior Boards have done exactly this under very similar circumstances.

Mr. Wyland recommended to the Board that Mr. William Cooper be appointed to return and serve until the winner of November's special election is seated. Mr. Cooper recently left the Board and would be able to quickly engage and meaningfully participate. It is in the best interest of the District to appoint someone with Mr. Cooper's experience and ability. Mr. Wyland spoke with Mr. Cooper to inquire whether he would be interested in filling this short term, and the board president advised that Mr. Cooper is willing to serve until December, although he does not plan on running for the balance of the term.

Consistent with my recommendations to the Board, resolutions were included on tonight's agenda for the full Board to consider regarding how to fill this short vacancy.

Mr. Wyland stated that this has been a historically challenging year. From the first day of school there was a relentless need to respond and adjust to the constantly changing pandemic environment. While there were times when there was not an agreement with the path forward each step of the way, the focus as a school community has always been on the education, health, and well-being of our students.

As this school year comes to a close, there is a light at the end of the tunnel. This past weekend the community came together to enjoy the outdoor evening concerts staged by our high school percussion ensemble and choir. This coming week prom will be held at the high school and look forward to the Class of 2021 commencement on June 3rd and last day clap outs at our elementary schools.

Mt. Lebanon is a resilient community with so much to be grateful for -- from our talented teachers and dedicated staff who kept our schools on track no matter what instructional mode we were in, to our principals and administrators whose leadership was critical in this moment, and our parents who persevered through so much. Mr. Wyland especially thanked Dr. Steinhauer for all of his hard work as he navigated this year filled with so many unknowns.

SUPERINTENDENT'S REPORT

Dr. Steinhauer congratulated Anna Mares and Rosemary Crist who each won Superior Writing Awards for their respective submissions to the National Council of Teachers of English annual Achievements in Writing Program. The NCTE Achievement Awards in Writing is a schoolbased writing program established in 1957 to encourage high school students to write and to recognize some of the best student writers in the nation. Only students who are juniors may participate. This year, 285 students were nominated to participate in the Achievement Awards. Of those, 136 were selected to receive Certificates of Superior Writing. Dr. Steinhauer presented Anna and Rosemary with certificates of achievement for this outstanding accomplishment.

Natalie McGee is a Senior who has been recognized for groundbreaking research on her project: *Examining the Effects of Marine Microplastics on Porifera Mi-cro-bial Filtration*.

Natalie just finished participating in the International Science and Engineering Fair (ISEF). She was selected as an ISEF finalist during the Covestro Pittsburgh Regional Science and Engineering Fair earlier this spring. Only four students were selected from the 1,000 students who participated in the regional fair. This is the second year in a row that Natalie has achieved this prestigious honor and, the only Mt. Lebanon High School student whose research was selected for this competition in at least the last 10 years.

All students who applied for ISEF were judged based on their research papers. All papers were peer-reviewed by a panel of experts. At the Covestro Pittsburgh Regional Science and Engineering Fair, Natalie was awarded the following awards:

Natalie is supported by Science Club faculty advisors Kyle Tilger and Josh Bilak and high school science teacher Pam Harris.

Dr. Steinhauer congratulated Natalie on these outstanding accomplishments and invited her on stage to receive a Certificate of Achievement for the Board.

The superintendent reported that the Pittsburgh Business Times 2021 top districts of the decade ranked Mt. Lebanon 3^{rd} in the region and 5^{th} in the Commonwealth. In addition Mt. Lebanon ranked 3^{rd} in Keystone Exam rankings for the decade. The Honor Roll ranks the 105 school districts in the region and the 495 districts in the state based on standardized test scores. Mt. Lebanon Schools have ranked among the top four schools on the list since it was first published in 2005.

Dr. Steinhauer ended is report with a very special recognition. Deanna Hess, our Supervisor of Health Services, and her team of school nurses and aides have spent this year looking after the health of all of us in this District.

Since the beginning of the year, her leadership guided us through the development of Covid protocols that aligned to the Allegheny County Health Department, PA Department of Health, and CDC recommendations to manage a safe and healthy environment in our schools. She established procedures for our contact tracing efforts for staff and students and trained her staff and building principals in this very time-consuming but essential task. She maintained the District Covid Dashboard and was relentless in finding pharmacies to support vaccine clinics in our District. Deanna's relationship with the ACHD was necessary for the District as we navigated the ever-changing recommendations and requirements during the pandemic.

Deanna and her team of nurses and nurse aides have led the sourcing and administration of various COVID vaccines since they became available. They are the reason that so many of our staff and students are vaccinated. But most remarkably, throughout this incredibly challenging year, Deanna approached every action she took with kindness, empathy, understanding, and patience. The school nurses and aides approached their roles with the same dedication and purpose.

We are so grateful and thankful for Deanna and her team. They are our "helpers" as Mr. Rogers would say, who looked after us with love and great care during a challenging time.

BOARD REPORTS

<u>Policy Committee</u> – Dr. Diamond reported that the Policy Committee met on May 10 to review the revisions to policies DFE, Athletic and Fine Arts Receipts, and ECF, Energy Management and Resource Conservation. The Committee recommended moving the policies forward for board approval.

<u>Diversity, Equity & Inclusion Committee</u> – Dr. Hackett reported that the DEI Committee met before this evening's meeting to review the DEI Taskforce meeting held earlier this month. The goal statement was reviewed and revisions were made to clarify them. Dr. Hackett presented a summary of the Diversity, Equity and Inclusion Community Forum on May 12, 2021. Dr. Irvin and Dr. Bennett presented on overview of the DEI Taskforce and discussed the goals. Approximately 110 residents attended the forum.

<u>Municipal Liaison</u> – Dr. Hackett reported that there will be regular pool operations this summer. The will be no festivities at the Main Park on July 4 but there will be music and a fireworks show. The Municipal DEI meetings are going well.

<u>Parkway West</u> – Mr. Wyland reported that the graduation student placement report was finalized, and clearly illustrates how students overwhelmingly find employment or go on to post-secondary

education in their field of study. The independent auditor's report ending school year ending 2020-21 showed no findings.

Mt. Lebanon students Hailey Berry, Nathanial Braco, Nathan Diaz, Jessica Osborne have been named to the National Technical Honor Society. The educational planning committee continues to review the possible adoption of a new power motor sports program for the 2022-2023 school year.

A memorandum of understanding has been reached between Parkway CTC and Steel Center CTC consolidating the Business Manager position creating a significant savings to both institutions and member districts.

<u>Pathfinder School</u> – Ms. Fleisher reported that the Pathfinder board met on May 19 for their regular business meeting. The next meeting is on June 16.

<u>PSBA/NSBA</u> – Dr. Strotmeyer reported that Governor Wolf was in the southeastern part of the state last week as part of the bipartisan charter school reform plan to save the state taxpayers over \$400 million dollars. There has been progress in that particular area along with joint support from both parties at the state level.

<u>Environmental Sustainability Board</u> - Dr. Strotmeyer reported on the activities in the Municipality particularly about the eco districts initiatives with air quality monitors. The ESB talked about putting air quality monitors at each of the schools as part of that overall project.
