EXECUTIVE SESSION

The President announced that executive session was held immediately prior to the meeting for the purpose of personnel matters.

SWEARING IN CEREMONY

Magisterial District Judge James A. Lenker administered the oath of office to Dr. Tamara Willis, Superintendent of the Susquehanna Township School District.

REPORTS/ANNOUNCEMENTS

Mrs. Newill, PSBA Representative, reported that a temporary grant of immunity to Covid 19 lawsuits for school districts was passed by PA House and is now in the PA Senate Judiciary Committee.

Ms. Zoe Jackson, Senior Student Representative, and Miss Paige Mullen, Junior Student Representative, reported that SL / AC Primary held a Diversity Day with students and staff wearing clothing from their respective cultures. They also reported that TH Elementary held a Family Virtual Literacy Night as well as an African-American Read-in that also celebrated women's history month. They continued their report noting that STMS started the STMS bi-weekly podcast, with the latest episodes about mental health and the guidance department's role. They reported about the STMS learner spotlight in which students explained the practices of Ramadan. They also reported that STMS students in mural class are working to improve the community and learning environment. They noted that STMS has partnered with Penn State University exposing learners to the idea of college. They concluded their report noting that there is a STHS police dog fundraiser to support the K9 unit with a goal of \$10,000. They noted that a fundraising competition between buildings lasts until May 13th. They also noted that spring sports continue, including Track and Field, Baseball, Softball and Boys Tennis. (report attached to BoardDocs)

Mr. Dwayne DeFoor, Alumni Association President, reported that he is creating a Directory of Alumni Businesses, with 29 listed to date. He noted that business owners are also being asked to mentor a student in the district. Mr. DeFoor noted that events coming up include the Spring Fest in May with seven food-truck vendors

and 21 vendors or crafters in total so far. He reported that the Alumni website has links to all vendors. He noted that another event upcoming is on June 18th, The Annual Susquehanna Invitational Golf Tournament. He encouraged those who do not play to attend the Awards Dinner at 5 p.m. (report and invitational letter with registration and sponsorship information attached to BoardDocs)

Mr. Dwayne DeFoor, HANNA Foundation Board Member, reported that Hanna packs go home to families every weekend and that the numbers have been growing since January, with 33 in February and 112 in March. He thanked Angie at STMS and Micah at SL / AC for their assistance. Mr. DeFoor noted that the HANNA Pantry has served 306 families (1200 individuals) in February and 361 in March (roughly 1500 individuals). Mr. DeFoor concluded by noting that a grant from Dauphin County came in to support the commercial refrigeration project at the HANNA Pantry, putting in a freezer and cooler, but that there continues to be a \$10,000 gap in funding. (report and dashboard record attached to BoardDocs)

Mr. Dietrich, DCTS Representative, reported that all board members should have received a voting packet for Joint Operating Board. He also reported that the new DCTS website is up and running, designed by DCTS students and migrated from the prior website. He noted that DCTS co-op students were hired for the task.

Dr. Willis, Superintendent, thanked the Student Representatives for their thorough reports. She noted that they may actually eliminate the need for a Superintendent's Report going forward because they do such an amazing job providing an overview of all of the great things happening in our district. Dr. Willis noted that she is proud to continue the time-honored partnership between the HANNA Foundation and the Susquehanna Township School District by serving as one of the newest members of the Board of Trustees. She noted that the Foundation represents the best of Susquehanna Township and embodies the core values of the District. She asserted that she believes that every learner deserves a world-class education, regardless of background or life challenges and that the Foundation has enhanced educational opportunities for our learners through its legacy programs like the Zach Holtzman Award and others, its funding of Communities in Schools Site Coordinators in our buildings and its pledge to eradicate food insecurity within our Township. She noted that she is proud to be a part of this noble work and that she looks forward to the next chapter in this partnership. Dr. Willis concluded her report by noting that the Rebranding Committee will be meeting on April 23rd to review the motion passed by the school board during their last meeting. She noted that this evening we have presenters from the Native American community who will share insights heard by the committee during its process. She noted that she looks forward to giving the board an opportunity to engage with our guests.

FAMILY LITERACY NIGHT




