A school district mascot should be a source of pride, celebration, and unity for all members of a community. It should be something that unites us all and brings our community together. These vital markers of a world class logo and mascot cannot exist under our current name and imagery while at the same time being offensive and doing harm to our neighbors and friends in the Native American and Indigenous communities that are part of the diverse population we celebrate as our strength.

While the name "Indians" will always be part of our history, we are excited to move forward with a process that selects a new district name, mascot, and imagery that can unite all members of our community in pride. Therefore, we will be bringing a new logo, name and mascot to the district.'

However, she noted that the policy limits the educational options available to offenders in small districts like the STSD in which only one building serves each grade-level. She stated that there needs to be a balanced approach to the rights of the victim and the offender. She asserted that the policy does not make this possible in small districts. Mr. Campbell stated that when you sexually assault someone, you don't get balance. He asserted that balance when you are raped is ridiculous. He stated that the rapist is a criminal and that it is disgusting that Mrs. Voughs is protecting rapists in a school.
