Hold Harmless Agreement and Waiver of Liability

That I, on behalf of the Group, fully accept the risks, and assume responsibility for any injury which may incur while on the property or using the facilities or equipment of Rumsey Hall. By risks, it is meant all risks, whether arising from a condition of the premises or equipment; whether foreseeable or unforeseeable; whether caused by individual's actions or the actions of others, including negligent conduct, or even intentional conduct, within or without the rules of play or participation, or whether caused by a combination of these factors. By injury, I acknowledge there is an inherent risk of injury in the activity, and while rare, that risk can include very serious and permanent injury, disability, economic losses and even death. Some, but not all, of the risks that my Group may or will be exposed to include: Inappropriate conduct or negligence by self or others; misjudgment by self or others; participants' mental, physical, or emotional conditions (known or unknown, disclosed or undisclosed); unusual/unknown illnesses; extreme and unpredictable weather conditions; unmarked or obscured hazards; falling down or slipping; being in remote locations away from immediate access to help; transportation problems; animal hazards, such as stings, bites, poisoning, blows and illness transmitted by animals and insects; and other risks associated with being in and around tennis and sports courts, streets, sidewalks, and pathways. These and other activities, risks, hazards and dangers can result in (for example): falls, being struck, or colliding with objects or people; experiencing vehicle collision; injuries due to heat, cold, heavy exertion; property damage or loss; broken bones, wounds, cuts, burns; drowning; becoming lost or disoriented; illness: long or short term, such as gastrointestinal problems and those contracted as a result of an borne disease; mental/emotional trauma; and/or other injury, permanent disability, or death.

That regardless of the circumstances which may give rise to any injury, I agree that the Group will not sue RUMSEY but instead hereby release, waive and discharge RUMSEY, its board, officers, administrators, teachers, coaches, employees, and agents, all of which are hereinafter referred to as "Releases", from demand or claim of any losses or damages caused or alleged to be caused in whole or in part by the releases. And that the Group will instead defend, indemnify, and hold the releases' harmless from and against any and all claims for injury or damages, including reasonable attorneys' fees to defend RUMSEY, and against any actual liability, loss or expense, arising out of the use of RUMSEY's facilities and equipment, to the extent such claim or such actual liability, loss, expense of RUMSEY arises from the negligent or intentional acts or omissions of the team or organization with which I am affiliated.

BY SIGNING THIS FORM, I ACKNOWLEDGE THAT I HAVE HAD THE OPPORTUNITY TO ASK QUESTIONS AND OBTAIN WHATEVER INFORMATION I REQUIRE TO FULLY INFORM MYSELF ABOUT THE ABOVE AGREEMENT AND I HAVE READ THIS WAIVER AND RELEASE, AND BY SIGNING IT AM GIVING UP SUBSTANTIAL RIGHTS, YET DO SO VOLUNTARILY. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, IT IS MY INTENTION, ON BEHALF OF THE GROUP TO SPECIFICALLY RELEASE AND AGREE TO INDEMNIFY RUMSEY HALL SCHOOL FOR ANY CLAIMS AGAINST IT ARISING OUT OF THE GROUP'S USE OF ITS FACILITIES.

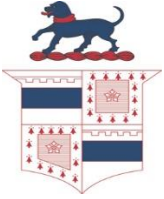
