Reporting of Criminal Incidence

Voluntary Confidential Reporting

Great Oaks Career Campuses accepts confidential reports and will employ every effort to maintain confidentiality. If, however, there is an immediate threat to self or others appropriate notifications will be made.

Reports of a felony crime will be directly forwarded to local law enforcement and District Administrators.

Confidential reports by professional counselors, health care providers, attorneys and clergy for the purpose of providing a timely warning to the campus community and statistical purposes should be directed to the Great Oaks Career Campus Adult Ed. Director.

You can anonymously report anything that is suspicious or endangering you, your friends or your school. Text or call 844-SaferOH (844-723-3764) Any Great Oaks employee in receipt of information involving a crime on campus shall report that information to their immediate supervisor, the campus SRO or Safety Services department. In the event of an emergency where disclosure of personally identifiable information is necessary to prevent further or future harm to an individual and/or members of the campus community, information will be disseminated to appropriate parties.

Campus Security Programs

All students are informed of campus security procedures during orientation. All staff members are briefed on campus security procedures upon being hired. Both staff members and students are encouraged to be responsible for their own security and the security of those around them by carefully reading the campus security procedures and reporting any incidents when they occur.

Great Oaks Career Campuses employs the following security measures:

- 1- A.L.I.C.E. approach to active shooter
- 2- NaviGate Security software
 - a. Stores our crisis plan, safety report, reporting forms and inspections and flip charts
- 3- Monitoring Cameras
- 4- Electronic Locks
- 5- Fencing
- 6- Lighting and additional CPTED concepts
- 7- Access Control protocols

Access to Campus Facilities

Great Oaks Career Campuses maintains a secure campus environment. General access for staff, students, vendors and visitors is restricted. Staff and students must at all times have their I.D. badges visible. Staff admittance to our facilities must be through an entry equipped with a door reader and use their badge to gain entry. No one is allowed to enter by piggy backing through once the entry has been opened. Student access is restricted through predesignated entries that are staffed by a receptionist in accordance to our Lobby Track practices. Visitors to our buildings and any contractors or vendors must check in with a main entry receptionist or have prior approval by campus or district administrators. No door is to be propped open without prior approval by a campus or district administrator.

A student admitted to Great Oaks accepts the responsibility to conform to all Great Oaks rules and regulations. Proven failure to meet this obligation will justify appropriate disciplinary sanctions, including expulsion, suspension, disciplinary probation or reprimand.

Staff, faculty and contractors remaining in a building after closing hours must notify the campus administration or campus custodial staff. Subsequent to the daily closing, all buildings and exit doors will be secured and locked.

Students and visitors will not be authorized to remain in a closed building or gain access to a building or area after closed hours, unless prior written permission is obtained by a campus administrator.

Campus Alerts/Emergencies

When there is no immediate threat to the safety of the campus community, yet notification of security/safety concerns are warranted (i.e. patterns of theft) an “Advisory” may be issued with the incident summary. The primary responder and reports made for the purpose of issuing an “Advisory”, or “Alert” (or Timely Warning), should be made with the campus and district administrators.

*In situations where there may be an immediate threat to the campus community, the Campus Administration will initiate without delay (upon confirmation of a threat and if doing so does not compromise efforts to contain an emergency) security/safety “Alerts”, or “Timely Warnings”, using the following resources: **Blackboard***

Crime Log

Crime log entries summarizing crimes and conduct violations reported to Great Oaks Campus Security Authority (CSA) *Coordinator of Health and Safety, Adult Director, Campus Administrator or School Resource Officer. Staff members should report similar events to the Adult Director.* The Crime Log will be maintained by the Campus SRO and the Campus Adult Ed. Supervisor.

Positive Behavior Intervention—Policy 4116.05

It is the intent of the Great Oaks Career Campuses to promote positive behavior intervention and supports to create a safe and productive workplace and educational environment for its employees and students, and to ensure that every student in the District is free from the unreasonable use of physical restraints and seclusion. The District focuses on the prevention of behavior problems through the implementation of non-aversive effective behavioral system. However, there may be times when physical restraint and seclusion may be necessary to maintain the student’s safety as well as the safety of others. Physical restraint and seclusion are used to defuse dangerous situations, protect the student and others from injury, and regain a safe, controlled learning environment. Physical restraint and/or seclusion may only be implemented if the student presents an imminent risk of physical harm to himself/herself or others.

Dangerous Weapons

A student shall not possess, handle, transmit, conceal, or use as a dangerous weapon any instrument capable of causing harm to another person. Dangerous weapons include, but are not limited to:

Firearms

The definition of a firearm shall include any weapon, (including a starter gun) which will or is designed to or may readily be converted to expel a projectile by the action of an explosive; the frame or receiver of any such weapon; any firearm muffler or firearm silencer; or any destructive device which includes any explosive, incendiary, or poison gas including bombs, both homemade and of the fireworks type, missiles, mines, and military ordinance, including bullets and shells.

Knife

The definition of a knife includes, but is not limited to, a sharp blade-cutting instrument.

VI. Current Campus Crime Statistics

Violence Against Women's Act (VAWA)

These are Dating Violence, Domestic Violence, Sexual Assault and Stalking. Sexual Assault, Domestic Violence, Dating Violence and Stalking are considered primary crimes for the purposes of *Clery Act* reporting and are defined and discussed in this section.

Campus Sex Crime Prevention Act

The Campus Sex Crime Prevention Act requires sex offenders to provide notice to each institution of higher education at which the person is employed or enrolled.

Sexual Assault/Misconduct

Great Oaks Career Campuses strive to create a community that promotes personal growth and wellbeing. Sex offenses are illegal, unacceptable and will not be tolerated by the District. Incidents of sexual assault include both forcible and non-forcible offenses. Prohibited offences include crimes involving dating and domestic violence, stalking and sexual assaults. Upon written request Great Oaks Career Campuses will disclose to the alleged victim of a crime of

violence or non-forcible sex offense, the report on the results of any disciplinary proceedings conducted by Great Oaks.

Three very important factors that may help prevent you or a friend from becoming a victim of a sexual assault involve; 1) be an active bystander 2) alcohol and 3) notification to others in the event of an incident involving sexual misconduct or assault (including date rape).

All members of the Great Oaks Community are encouraged to take responsibility for preventing and addressing sexual misconduct within our community. To help enhance your safety and the safety of your friends, commit to be an active bystander by taking the following steps:

- 1- Notice the situation...be aware of your surroundings
- 2- Interpret it as a problem...do you recognize that someone needs help
- 3- Feel responsible to act...see yourself as being part of the solution to help
- 4- Know what to do...educate yourself on what to do
- 5- Intervene safely...take action but keep yourself safe

You can also enhance your safety and the safety of others when you out with friends by:

- 1- Having a plan...formulate a plan regarding personal safety with friends before you go out
- 2- Go out together...go out as a group and don't allow friends to become separated, especially if they are impaired or unfamiliar with the parties involved
- 3- Watch out for others...if you are walking at night with friends and notice a person walking by themselves in the same direction, ask them to join you so they don't have to walk alone
- 4- Diffuse the situation...if you see a friend coming on too strong to someone who may be too impaired to give proper consent; interrupt, distract, or redirect the situation. If you are too embarrassed or shy to speak out, get someone to step in.
- 5- Trust your instincts...if a situation doesn't seem right to you, trust your instincts and remove yourself from the situation, or assist a friend who may not recognize the situation
- 6- Take care of each other

Alcohol can be a factor in that it can contribute to aggression by the perpetrator or diminished cognitive abilities on your part. Date rape drugs can be placed in any drink, not just alcohol. Do not drink a beverage where you don't know the source, who is serving you or are suspicious of the circumstances. If Great Oaks is not made aware of an incident, we can't take proper steps to help prevent a future incident. Reporting a crime or incident is a separate step from

prosecuting. Any person who believes they have been a victim of any sexual assault or misconduct or have information regarding a sexual assault are encouraged to report the incident to the District officials or law enforcement officials, or both.

Intervention

Great Oaks is committed to providing both a sensitive and effective response to an incident of this nature. Any of the listed resources will help the victim seek any medical, civil and/or counseling services. Victims of a sexual assault are strongly encouraged to seek immediate medical attention so that physical evidence can be preserved, should the victim choose to prosecute. An assault can be reported without initiating an investigation or prosecuting the alleged attacker. While it is the victims' option to (or not to) seek assistance from law enforcement and campus authorities, Great Oaks encourages persons who have been sexually assaulted to report the assault, seek assistance and pursue criminal and on campus action for not only their protection, but the entire campus community. Victims should report the assault to the CSA.

The District can help per cure transportation to the hospital and/or the local police department and can assist the victim in notifying proper civil authority. With the exception of a Licensed Counseling Services, health and pastoral counselors, all Great Oaks employees are required to contact a CSA. Confidentiality will be maintained to the extent possible, however, cannot be guaranteed.

Harassment Free Environment

Great Oaks Career Campuses promotes a productive campus environment and will not tolerate conduct by any member of the campus community that harasses another employee or student, disrupts or interferes with another, or creates an intimidating, offensive or hostile environment. This includes threatening behavior, violent actions, and sexual harassment. Students who feel they are the target of any type of harassment should immediately report the situation to the Campus Administrator. Employees are to contact the Director of Human Resources. Please refer to the Harassment Free Policy in the Student Handbook and/or the Employee Handbook for further information. Students are protected under Title VII of the Civil Rights Act and Title IX of the Education amendments.

Hate Crimes

Hate crimes are where the victim is intentionally selected based on his or her actual or perceived race, gender, religion, sexual orientation, ethnicity, disability, national origin, or

gender identity. Great Oaks must report any of the above listed crimes, as well as vandalism, intimidation, larceny/theft, simple assault and any other crime involving bodily injury where bias is a motivating factor. If you believe you have experienced, or witnessed, a hate crime you may report it to the Campus Administrator.

Standards of Conduct

Great Oaks is committed to maintaining a campus free of illegal drugs or the unlawful use of alcohol or illicit drugs. It is the policy of Great Oaks not to permit the possession, consumption, and sale of alcoholic beverages on campus in accordance with the laws of the State of Ohio, the regulations of the Ohio Department of Commerce, Division of Liquor Control (DOLC) and the policies of Great Oaks. Great Oaks has the responsibility of upholding federal, state, and local laws regarding the use of drugs and alcohol. Students who choose to possess or use unlawful drugs or misuse lawful drugs or alcohol subject themselves to both arrest and prosecution, and Great Oaks action.

Campus Policy Regarding Illegal Substances

Great Oaks strictly forbids the possession, use or sale of any alcoholic beverages and/or illegal drugs on all campus grounds. Students and staff members should report any knowledge of such activities to the Adult Director. Any infraction is cause for immediate suspension and possible termination. When appropriate, such infractions will also be reported to the local authorities. Specific details of this institution's drug policy are outlined in the campus drug free policy statement distributed annually to all staff and students under separate cover.

Student & Employee Compliance with Great Oaks Drug and Alcohol Policies

All Great Oaks students and employees are expected to abide by the terms of the school's policies. A student and/or employee found to be in possession or illegally using drugs and/or alcohol may be subject to appropriate sanctions. Such sanctions may include:

- 1- Referral for prosecution,
- 2- Termination of employment, and/or
- 3- Reprimand, probation, suspension or expulsion.

A disciplinary sanction may include the completion of an appropriate rehabilitation program. Students and employees are guaranteed due process.

Great Oaks Student Sanctions

In cases of civil or criminal action against a Great Oaks student, Great Oaks does reserve the right, for educational purposes, to review any action taken by authorities. Great Oaks may, at

its discretion, introduce further sanctions if the student's conduct has interfered with the Great Oaks exercise of its educational objectives or responsibilities to its members.

The Great Oaks Student Code of Conduct expressly prohibits the manufacture, distribution, sale, offer for sale, or possession of drugs or narcotics. Violation of this standard constitutes an offense and the student will be subject to maximum sanction of disciplinary expulsion or any sanction not less than a reprimand. Being under the influence of drugs and/or alcohol does not diminish or excuse the violation of the Student Code of Conduct.

The Student Code of Conduct also prohibits the possession and/or use of marijuana, and the unauthorized use of alcohol. Violation of these standards constitutes an offense and the student will be subject to a maximum sanction of disciplinary probation or any sanction not less than a reprimand. Being under the influence of drugs and/or alcohol does not diminish or excuse a violation of the Student Code of Conduct.

A student admitted to Great Oaks accepts the responsibility to conform to all Great Oaks rules and regulations. Proven failure to meet this obligation will justify appropriate disciplinary sanctions, including expulsion, suspension, disciplinary probation or reprimand.

Local, State and Federal Laws and Sanctions

Applicable legal sanctions under local, state or federal law for the unlawful use, possession or distribution of illicit drugs or alcohol are set forth in the referenced laws and are available upon request from an Adult Education Supervisor

Local State: Ohio Revised Code Chapters 2925 – Drug Offenses 3719 – Controlled Substances 4301 – Liquor Control Laws

Federal: Federal (Harrison) Narcotic Act Federal Narcotic Drugs Import and Export Act Federal Food Drug and Cosmetic Act Federal Alcohol Administration

These sanctions can include probation, fines, driver's license suspension, and/or incarceration. Future revisions, amendments, or additions to these or other applicable codes are incorporated into this policy by this reference.

DRUG PREVENTION PROGRAM

Drugs and Alcohol (Drug-Free School and Community Act of 1989)

Great Oaks is unequivocally opposed to the misuse of lawful drugs and the possession and use of unlawful drugs. Pursuant to the requirements of the Drug-Free School and Community Act Amendments of 1989 (PL 101-226), Great Oaks has adopted and implemented drug and alcohol policies and programs designed to prevent drug and alcohol problems within the campus

setting. The policies and programs are designed to identify problems at the earliest stage, motivate the affected individuals to seek help, and to direct the individual toward the best assistance available.
