JUNIOR/SENIOR RELEASE FORM

District 155 high schools will permit junior and senior students that have parent permission and approval of the building administration the opportunity to leave campus during any study hall/scheduled lunch period. Parents must grant permission for students to leave campus during their study hall/lunch period. Juniors and seniors in classes designated as blended learning classes may also have the ability to leave campus on designated flex days as scheduled and approved by their teacher.

Junior/senior students will have the opportunity to leave campus during study hall/lunch/blended learning flex periods on the days specified in advance by the school administration. Students are not permitted to leave campus without administrative permission at any other time. Students earning the study hall/lunch/blended learning flex period privilege agree to abide by the following policies and procedures:

- The student must complete the application process by having the appropriate period punched on their student identification.
• The student must display their student identification card with the appropriate period punched upon leaving the building.
• Those without their identification card and appropriate period punched will not be permitted to leave the campus.
• The student may leave and return to the building only through exit(s) identified by the school administration.

Study hall/lunch/blended learning flex period release is granted as a junior/senior privilege. There are certain responsibilities that accompany this privilege. Students who abuse this privilege or do not adhere to their responsibilities may have the study hall/lunch/blended learning flex period release privilege revoked. Students may have this privilege revoked for the following reasons:

- Returning to the school under the influence of illegal substances
• Leaving school without permission during class time
• Excessive tardies when returning to school
• Receiving multiple out-of-school suspensions
• Committing acts of vandalism, littering, loitering, or any other criminal act during the commons/lunch period
• Other circumstances that warrant revocation of this privilege by administration

Students that have their study hall/lunch/blended learning flex period release revoked may earn back the privilege in a specific period of time designated by the administration. Those students that attempt to leave campus while their privilege is revoked may lose their privilege for the remainder of the school year. Those students who attempt to take freshmen with them may lose their privilege.
