### Important Notes

1. All student vehicles must be registered before students may park on campus. Students must display the parking tags each day. There is a **\$100** non-refundable registration fee that will be **charged to your student account** upon submission of this application. Students who drive and park on campus without registering their cars are subject to fines and other disciplinary action.
2. All student drivers must be 16 with a valid driver's license (not a learner's permit) and be covered by insurance.
3. Since the roads on campus can serve as walkways or running paths for students, faculty, parents and visitors, all drivers must drive slowly (15 m.p.h.) and be constantly aware of the foot traffic, which usually forgets about cars! Excessive speed or reckless driving at any time is dangerous and if done by students, is grounds for serious disciplinary action, fines, and loss of driving and other privileges. Because we want to maintain a safe traffic pattern on campus and eliminate the possibility of accidents, we may fine students who park in handicapped areas and not in their designated parking area as well as students who drive with excessive speed or recklessly, or who fail to follow posted signs and directions. Students will also lose their driving and other privileges for these violations.
4. **Students may not go to their cars at any time of the school day unless they receive permission from an administrator to do so.** Disciplinary consequences are a result for violation of this school policy. However, student vehicles may be moved from one lot to another after 3:45 p.m.
5. Driving off campus without permission will automatically result in loss of driving privileges for two weeks for the first offense and other disciplinary consequences as needed.
6. Parking regulations are strictly enforced.
7. Parking anywhere other than your assigned parking space will result in losing your driving privileges for one week for the first offense and possible disciplinary action. This will double every occurrence thereafter and may involve additional disciplinary consequences as needed.
8. Under no circumstances may students switch spaces or parking tags with another student without the expressed permission of the Dean of Students.
9. No unlicensed vehicles such as bicycles are allowed.
10. Webb School is not liable for any vehicle damage incurred while driving or parking on campus, including damage from weather or athletic equipment (including baseballs and golf balls).

*Having a permit to drive to Webb School is a privilege; as such this privilege can be temporarily or permanently taken from a student if the student abuses it.*
