**\*Field Trip Permission**

Field trips may be planned from time to time as part of the activities of the program. This may include walking to nearby parks, ball fields, stores, etc. I understand that I will have prior notification of all field trips out of town. I give my consent for my child to take part in walking field trips and ride in school district vehicles, such as vans for in-town field trips to the library, pool etc. under proper Kids Korner supervision. I also give consent for my child to partake in Out-of-Town field trips that I have chosen for my child to attend.

**\*Photo Policy**

There are occasions when Kids Korner staff or representatives of Austin Public Schools photograph students while attending Kids Korner. Parents/guardians not wanting their child’s picture published, features on the World Wide Web and/or social media sites and/or news media must notify in writing Kids Korner.

**\*Sunscreen/ Bug Spray**

I give my consent for my child may use sunscreen and bug spray provided by Kids Korner. Parents/ Guardians not wanting to use sunscreen or bug spray provided by Kids Korner must notify Kids Korner writing and provide their own labeled bottles of sunscreen and bug spray.

**\*Procedure Agreement**

I recognize my responsibility to respect the rules of Kids Korner program as well as my responsibility to help my child respect the rules needed to provide a positive experience for all participants. I agree to pay for any damages my child might cause while participating in the program.

I agree, if my child does not comply with safety protocols and guidelines put in place by Kids Korner it may result in grounds for dismissal.

**By Signing my name below, I agree to the following:**

I agree to abide by the terms and conditions and payment schedule of the Kids Korner Program at Austin Public Schools. Regular enrollment has a \$5.00 before school charge; after school has a \$8.00 per day with a weekly minimum of \$30.00 per week. Non-School day rate of \$22.00 for up to 8 hours anytime over 8 hours are billed at \$3.50 per hour. Early Release rate of \$12.00 per day. Weekly minimums of \$30.00 are charged per week per child regardless of attendance including but not limited to: Vacations, Holidays, Illness, No School/Snow Days, Withdrawals, Site closures.

Ages 3 to preschool are contracted pricing while attending the Community Learning Center. Fulltime 30-40 hours \$130.00 per week; Parttime 20-30 hours \$95.00 per week; Occasional 10-20 hours \$65.00 per week. Hours over maximum are billed \$3.50 per hour. Contracted rates are charged weekly per child regardless of attendance including but not limited to: Vacations, Holidays, Illness, No School/Snow Days, Withdrawals, Site closures. Accounts are billed bi-weekly. Past due and/or accounts carrying a balance will obtain bi-weekly late fees and will result in suspension until paid in full.

I must provide a 2-week written notice prior to termination and pay termination fees per child. Families will be notified with new fees structure for SUMMER Kids Korner prior to registration and billing

In case of an emergency involving the above-named child, I authorize the Kids Korner Program to use Austin Mayo Clinic Emergency Room for emergency medical treatment, if I or my child’s doctor cannot be reached. I authorize Kids Korner staff to call 911 emergency care if deemed necessary and I will pay the charges.
