



## Local Incident Team's process when making recommendations to learning model changes

The St. Anthony-New Brighton's Local Incident Team (LIT) is made up of local experts and stakeholders committed to providing learning in a safe way. It is recommended that school districts develop an LIT to review and understand local epidemiology of COVID-19 in their community to guide decisions for the school year.

The LIT combines the knowledge of local public health experts with parents/guardians, and school administration and staff, who understand district operations and effective teaching and learning. The team's recommendations help guide and inform the School Board on making learning model decisions for the 2020-21 school year.

The LIT meets on a weekly basis to:

- Analyzes county/local COVID-19 data.
- Monitors health and safety needs of students and staff.
- Ensures staff levels provide necessary support for students.
- Consult with the Regional Support Team, as needed.

## When the LIT considers potential learning model changes, they focus on:

- **Building readiness:** necessary space to execute the learning model proposed.
- **Staffing:** necessary and appropriate number of staff to safely execute the learning model proposed.
- Health and safety: ensure that all safety and health precautions can be implemented to execute the learning model proposed.
- Instructional preparedness: teaching staff have the time to develop rigorous and relevant instructional practices in the new learning model proposed.
- State guidance: COVID-19 rate outlined by the state allows for the change in learning model.
- County guidance: county COVD-19 data rate allows for the change in learning model.
- Local guidance: local COVID-19 data rate allows for the change in learning model.
- Virus activity: in addition to the COVID-19 data, what is the trend line for virus activity, and does that allow for the change in learning model.

## Rethinking, reimagining how we do school

The pandemic has created various complications and obstacles to this school year. Yet, it has also challenged educators to rethink and re-examine how we provide school and improve equitable learning opportunities for our students.

In the Summer of 2018, Superintendent Dr. Corneille created a district Teaching & Learning Team. The purpose of St. Anthony-New Brighton's Teaching and Learning team was to examine both our mission as a school district and our instructional practices to ensure alignment with our vision: we are committed to the success of all learners.

Districts across the nation have had to change where learning takes place— moving from a brick-and-mortar school building to student's homes. The transition to distance learning was not familiar to most schools, teachers, students and families. This was a whole new process with a multitude of facets to consider - from technology, to curriculum, to child care, to meals. At SANB, we were intentional about asking our staff to examine their process of teaching and supporting our students to ensure learning is happening. Academically and personally speaking, as staff, we had to consider how to challenge students to think critically and deeply. We also had to acknowledge how the traditional way of school is based on the assumption that it can only happen in a classroom. And this year reminded us that learning happens outside of school too.

This year, our staff development has focused on the importance of rigor, relevance, and relationships to improve equitable learning outcomes. Without each of these components, also referred to as the Three R's, high levels of transferable learning is not possible. The Three R's are aligned with our strategic directions of high support matched with high expectations for both staff and students. This learning for staff has provided an opportunity to realign our processes of teaching with how our students learn, taking into account their unique abilities and interests. We will meet each student where they are at, focusing on the whole child, and helping them meet and exceed learning targets.

## District Health Services provides guidance, resources during global pandemic

Since March 2020, the district and the community have navigated various changes due to COVID-19 from how we provide learning to how we function on a daily basis.

Our Health Services team, led by District Nurse Lori Watzl-King, has been instrumental in our process to learn and implement new procedures to ensure a healthy learning environment for students.

Watzl-King also serves as the district's COVID-19 Coordinator and, last summer, helped staff and families monitor their health and supplied information and guidance with questions during COVID-19. Watzl-King also helped establish the district's COVID-19 Response Plan, which provides important information for staff, families and the community.

Watzl-King is critical to SANB's daily operations and assists district administration and staff with preparations for in-person school, provides on-site resources, such as biweekly testing for employees, and managed the vaccination schedules for staff.

In addition, she continues to navigate day-to-day situations with staff and provides guidance and resources to families to help keep their children healthy at home and in school. She also assists high school athletics and activities as they work with the Minnesota State High School League (MSHSL) in determining safe ways to practice and connect.

## Vaccination site partnership with Hennepin County

St. Anthony-New Brighton School District partnered with Hennepin County Public Health and Hennepin Healthcare to be a vaccination site. COVID-19 is a public health concern and large spaces are needed for the distribution of vaccines. Hennepin County has utilized St. Anthony Village High School as a vaccination site since Jan. 26, 2021. Hennepin Healthcare administers the vaccines and appointments are prioritized for healthcare workers and K-12 educators. Minnesota is currently in phase 1A and 1B of vaccinations.



#### Newly designed website at ISD282.org

#### **Building connection: Community Engagement Circles**

In November 2020, we introduced an opportunity for members of the St. Anthony-New Brighton (SANB) community to participate in open-group discussions, called Community Engagement Circles. These four successful events held in November and December of 2020 focused on school values that tie into the district's strategic priorities of high expectations matched with high support for students and staff, and strong communication and relationships with our families and community.

This year, we continue to introduce new themes each month through the month of June.

## Why Community Engagement Circles?

The goal of a community circle is to come together and create understanding, learn how to talk in new ways, and create connections. All of this is accomplished with the help of a trained facilitator. Basically speaking, engaging in circle events helps a community build new skills to relate with each other on more personal levels, raise awareness, and to create a foundation for connection and communication that strengthens the ability to have open conversations during difficult times.

These Community Engagement Circles are in partnership with the SANB, the City of St. Anthony Village, and the St. Anthony New Brighton Family Services Collaborative.

#### "This idea grew out of conversations across our school community –

we have our differences, they are important, and so many of us also have this key similarity — we want what's best for our kids. This is something we can build on when envisioning who we are as a community. These aspirations, sitting in the context of the significant amounts of community-level trauma our families are navigating, led to the development of the community engagement circles.

I am so proud of the work our neighbors and ourselves are doing to really be with each other, to walk with each other."

### NineNorth collaboration

One of the ways in which the district is able to engage with families, students and the community during COVID-19 is through the use of video. ## **Community Services Support of Residents**

During the school closure in spring 2020, Governor Walz issued Executive Order 20-19 on March 25, 2020, which authorized the Commissioner of Education to implement a distance learning period in schools across the state. Within that Executive Order, districts were asked to utilize staff that were able to work during the distance learning period. "When Community Services' programs closed, we had staff available to work and help address emerging needs in our community. Community Services pivoted and reallocated staff to provide emergency childcare, family support, community support, and delivery of meals and technology," said Wendy Webster, director of Community Services and Communications.

Community Services staff provided care to children and support to our parents and residents of St. Anthony. Early childhood and school age care staff provided emergency childcare Monday through Friday at the St. Anthony Community Center. Preschool teachers and parent and family educators from our Early Childhood Family Education (ECFE) program were assigned to family support. This entailed calling families with young children in our community to check in, listen, and get connected to online early childhood resources, such as a newly created YouTube channel and virtual ECFE classes.

Other staff, who were assigned to community support, called St. Anthony residents over the age of 60 to check in and identify needs that could be addressed by a community responder who assisted with deliveries of supplies, masks, and groceries so our most vulnerable residents could remain healthy at home. Community responders were also responsible for delivering school meals to families, and technology and instructional materials to students in grades K-12.

## St. Anthony-New Brighton receives financial credit rating upgrade

St. Anthony-New Brighton School District received a rating upgrade from A1 to Aa3. Moody's, a risk assessment firm, announced the credit rating in the process of refinancing \$3.3 million in bonds. This new credit rating, which is also a result of Moody's recent change in rating methodology, allows the district to get a better bond rate. In October 2020, the School Board authorized refinancing of the District's 2018A Bond. The estimated savings of \$131K increased to \$170k with the upgraded credit rating.

"As a school district, we are committed to being fiscally responsible. Historically, our community and its citizens provide our schools with the resources to educate our students— anytime we can save our community money, we will. The cost savings to our taxpayers generated by the refinancing is our commitment to this value," said Superintendent Dr. Renee Corneille.



## Meals Provided by Nutrition Services

During the 2020-21 school year, student meals are free and each student can receive five breakfasts and five lunches each week. While school is in distance or hybrid learning, families can pick up meals at Wilshire Park Elementary School or St. Anthony Village High School once a week. Meal delivery is also available. Nutrition Services also partnered with Every Meal (formerly The Sheridan Story) to provide bags of shelf-stable food to ensure children have access to nutritious food each week.

#### **Did you know? Mental Health Support**

St. Anthony-New Brighton School District partners with Lee Carlson Center for Mental Health and Well-Being to provide school-based mental health services to students. Lee Carlson provides an onsite mental health therapist at Wilshire Park Elementary School, St. Anthony Middle School, and St. Anthony Village High School. When schools closed in spring 2020, Lee Carlson transitioned from inperson sessions at school to virtual appointments to ensure students could continue services and meet with and receive support from their therapists.

#### **Emergency Childcare**

In the spring of 2020 when Gov. Walz issued Executive Order 20-02, which directed the Commissioner of Education to close schools across Minnesota and plan for "continuity of education during the COVID-19 pandemic for the purpose of preserving the health, safety, and lives of Minnesota's students, educators, and the broader public," he also directed school districts to provide childcare for children of emergency workers. Announced on Sunday, March 15, 2020, the purpose of emergency childcare was to ensure parents, who were employed in roles critical to the State's response to COVID-19, could continue working while their districtenrolled children ages 12 and younger received

free childcare during the hours they would have been attending school. Community Services closed Early Childhood Family Education (ECFE), half-day preschool, all-day preschool, and schoolage care (Village Kids) programs on Tuesday, March 17. At 6:30 a.m. on Wednesday, March 18, Community Services opened childcare at the St. Anthony Community Center to approximately 30 school district children whose parents were employed as Tier 1 or Tier 2 critical workers. This childcare service operated from March 18 through May 30, 2020. In the 2020-21 school year, free childcare for children of Tier 1 critical workers is required to be provided during school hours while Wilshire Park Elementary School is in hybrid, modified hybrid, or distance learning.





#### St. Anthony Community Services

#### **Early Childhood Family Education (ECFE)**

For parents and children (birth to age five), ECFE believes each family provides a child's first and most significant learning environment and supports parents to understand their child's development.

- Small, in-person classes for parents and children are offered at St. Anthony Community Services.
- Parenting support and coaching also available.

#### **Early Childhood Screening**

For children three to five years of age, an early childhood screening identifies any potential learning and/or health concerns so that children can get the help they need before starting preschool or kindergarten.

 In-person or virtual screenings are available and required before attending kindergarten.

#### **Half-Day and All-Day Preschool**

Preschool offers an environment where children ages three to five can play, learn and develop skills to help prepare for kindergarten.

 Residents of St. Anthony-New Brighton School District can register for the 2021-22 preschool program. Children who will be three, four, or five years of age by Sept. 1, 2021, can attend small, in-person half-day or all-day preschool classes at St. Anthony Community Services.

#### **Adult Enrichment and Recreation**

A variety of online and small, in-person classes such as photography, genealogy, gardening, glass mosaic, cooking and baking, golf and tennis lessons, pickleball, and weekly exercise classes.



Half-day and all-day preschool have continued to meet this school year. Children in preschool are not required to wear a mask.

#### **Youth Enrichment Classes**

A variety of online and in-person spring and summer classes such as preschool camps for ages two to five, kinder camp, soccer camp, track and field club, music lessons, archery, bowling, tennis, and horseback riding, online fitness, art, and science classes.

#### **Aquatics**

Morning and evening swim clubs now available in our newly renovated pool. Swim lessons are beginning in April and throughout the summer.





#### **Stadium Field Complex Upgrades**

In May 2020, we shared information with families and the community on the feasibility study for synthetic turf and an asphalt track at stadium field, as well as updates to the stadium complex to be completed at Central Park.

On Sept. 15, 2020, Dr. Troy Urdahl, director of Athletics, Activities, Facilities and Transportation, provided the School Board with a final recommendation for this project at their regular meeting. These recommendations were reviewed and approved by the board. Construction began in early October, 2020, with projected completion set for August 2021.
