

## Centennial Junior High School-Optional Device Protection Plan

Centennial Junior High School is providing a protection plan for students and parents as part of our User Device Agreement. Enrollment in the plan is optional with the understanding that if students/parents do not enroll in the protection plan they may carry full liability for the laptop in the same way they do for other damaged or lost school property, such as textbooks.

<b>Program Fees and Coverage</b>
<ul style="list-style-type: none"> <li>• <b>Fee:</b> \$25 per school year. <i>This fee is nonrefundable and will not be prorated.</i></li> <li>• <b>Maximum Expense:</b> \$225, 2021-2022 replacement cost of Cloudbook</li> <li>• <b>Coverage:</b> Repair or replacement of school issued laptop</li> </ul>
<b>Enrollment Deadline</b>
Plan may not be purchased after damage has occurred, or beyond the first term of the school year.
<b>Effective Coverage / Expiration Date</b>
<ul style="list-style-type: none"> <li>• <b>Effective Date:</b> Coverage begins when the \$25 nonrefundable fee is paid.</li> <li>• <b>Expiration Date:</b> Coverage ends on the earliest of the following dates: last day of school year, return of device, no longer enrolled in school.</li> </ul> <p style="text-align: center;"><i>Please be sure to return the device before the expiration date to ensure that the plan is always in effect.</i></p>
<b>Coverage</b>
<p><b>The Optional Device Protection Plan coverage includes:</b></p> <ul style="list-style-type: none"> <li>• Accidental damage caused by liquid, spills, drops, or other unintentional events.</li> <li>• Loss of device due to theft; claim must be accompanied by a valid police report.</li> <li>• Damage caused by fire; claim must be accompanied by official fire report from investigating authority.</li> <li>• Damage due to an electrical surge.</li> <li>• Loss or damage caused by natural disasters.</li> </ul>
<b>Exclusions</b>
<p><b>The Optional Device Protection Plan coverage excludes:</b></p> <ul style="list-style-type: none"> <li>• Damage caused by dishonest, fraudulent, intentional, and negligent (not locked and/or stored in an insecure manner or location) or criminal acts. Students and parents will be responsible for the full amount of repair/replacement for damage or loss that falls in this category.</li> <li>• Damage incurred to a device that is not in the school-issued protective case.</li> <li>• Consumables: Headphones, USB cables, AC adapters, charging cord, case, or software.</li> <li>• “Jailbreaking” or otherwise voiding the manufacturer’s warranty by altering the software. Jailbreaking is a term used to describe a process by which normal manufacturer controls on the functionality of the device are bypassed. Jailbreaking of school-issued laptop devices is not permitted.</li> <li>• Centennial Junior High School is not liable for any loss, damage (including incidental, consequential, or punitive damages), or expense caused directly or indirectly by the equipment.</li> </ul>
<b>Replacement Costs</b>
<p><b>Protection Plan:</b></p> <ul style="list-style-type: none"> <li>➤ <u>A \$15 fee will be assessed per covered incident</u></li> <li>➤ Subsequent Claim during school year             <ul style="list-style-type: none"> <li>○ Full device repair cost or replacement cost (if device is recovered, device must be returned to school and replacement fee will be reimbursed)</li> </ul> </li> </ul>
<p><b>No Protection Plan:</b></p> <ul style="list-style-type: none"> <li>➤ All incidents- Full device repair or replacement cost.</li> </ul>
<p><b>Misc.:</b> 2021-2022 replacement cost of items</p> <ul style="list-style-type: none"> <li>➤ \$225 Cloudbook</li> <li>➤ \$5 Computer sleeve</li> <li>➤ \$41 Chargers</li> <li>➤ \$25 Headphones</li> </ul>
