High School:

- HHFKA regulations are reflected in meals/ portion sizes in all serving lines. Ball high has 5 different lines to choose from every day, one in which fresh salads are offered daily.
- Nutrition Education in Cafeteria needs improvement.
- The policy for tracking food outside of cafeteria needs to be delivered in a more prominent matter so that students and staff are well aware that it is not allowed
- PE participation is offered to students for high school graduating credits. OR a different sport is offered for students to take in place of traditional PE.
- Emergency drills are practiced and communicated properly. The front office staff is well aware of these procedures and their scheduled times throughout the school year.
- Bathrooms and locker rooms are clean but not always very well equipped. Soap and sanitizer is not available at all restrooms.
- Hallways are very clean and uncluttered.
- The teen health clinic does stress a drug and alcohol free environment, as well as strong encouragement about a bully free environment. Students feel they have the freedom to openly discuss these type of issues with the staff that is available to them at Ball High School.

Middle School:

- Nutrition education posters only inside serving line. Central middle has a couple of "my plate" informational stickers- but small.
- Students are not allowed to leave the cafeteria with cafeteria food or bring outside food for sharing with their classmates.
- Anti-bullying and disciplinary contracts seem to be better developed, and implemented at Weis "upstairs" floor of the building. Central counselor could not say the same for central MS.
- Middle schools do not have enough full time nurses. Health aids are not well and fully informed of how to care for students with medical concerns.
- No AED training for central MS health aid, both AED's installed placed towards the back of the building
- Central Middle School was not in full compliance with the guidance that is offered to students
 against anti bullying. Weis area at Central better procedures and resources available at hand.
 The onsite psychologist at Central Middle explained that they had some tips against anti bullying
 placed online, but that the staff at Weis had more consequences in place for students who
 engaged in this type of activity.

Elementary:

- Playground time minutes fall short of 135/week. Testing dates may also affect these minutes depending on grade level.
- Oppe Elementary is the only campus that has a very well trained nurse assigned.
- Nurses are rotated between GISD campuses. This becomes an issue when the nurse is not well aware of the health status of the students that need medical attention at their campus.
- Parker, only 1 AED in front side of the building
- No sort of policy in place for checking AED's working status (ie: maintenance log)
- HHFKA regulations are reflected in meals/ portion sizes in all serving lines. Nutrition education lacks in the walls of the actual dining area. Some should be posted in the bulletin boards that are available at the campuses.
- Emergency drills are practiced and communicated properly. The front office staff is well aware of these procedures and their scheduled times throughout the school year.
- Bathrooms and locker rooms are clean but not always very well equipped. Soap and sanitizer is not available at all restrooms.
- Hallways are very clean and uncluttered.
