



VAUGHN 2021-22 Return to Campus Protocols

The much anticipated In-Person return to campus for all staff and students is fast approaching at VAUGHN Next Century Learning Center. We are very excited to welcome everyone back and are eager to see everyone in person. At the same time, we understand and validate the apprehension that many of us are feeling and the many questions that run through our head. It is our desire to provide some ease and alleviate some of the uneasiness you may be experiencing by understanding that we are employing the most up to date measures and protocols as recommended by the California Department of Health, the CDC and local authorities. With that in mind, below I would like to share the protocols and requirements that both staff and students are expected to comply with upon our full return to In Person Instruction:

1. Daily Health Checks
 - a. Students must submit their daily health check via the Parent Square app
 - i. If app is not available, parent/student will have to answer questionnaire in person
 - ii. Parents are required to take a temperature reading at home, if student presents a temperature of 100.4 they should not be brought to school
 - b. Staff must submit their daily health check via the assigned application
 - c. Staff must have their temperature read at the designated entry point
2. Testing
 - a. All students at Mainland will be required to test on a weekly basis per LAUSD guidelines
 - b. All unvaccinated staff at Mainland will be required to test on a weekly basis per LAUSD guidelines
 - c. A 10-15% sample of students will be required to test at the other campuses every 2 weeks
 - d. All unvaccinated staff at other campuses will be required to test every 2 weeks
 - e. Vaccinated staff/students presenting COVID like symptoms will be required to test Negatively prior to entry onto campus
 - f. Testing will be provided on site at each campus via an anterior nasal swab that will be overseen by contracted medical staff
 - g. To be exempted from routine testing staff must provide a copy of their vaccination record to Human Resources
3. Masks
 - a. All students will be required to wear a mask/facial covering while on campus and indoors (unless a medical exemption is provided)
 - i. If a mask cannot be worn a facial shield will be required to be worn
 - b. All staff (regardless of vaccination) will be required to wear a mask/facial covering while on campus and indoors (unless a medical exemption is provided in which case a facial shield will be required)



- c. All visitors/vendors onsite will be required to wear a mask/facial covering while on campus and indoors
 - d. All students/ staff and visitors will be allowed to remove their facial mask/covering while outdoors, eating lunch and or during physical education
 - e. Disposable masks will be available for staff/students who may have a need for one
 - f. Unvaccinated employees will be provided with an N95 grade facial mask
 - g. Athletes participating in indoor sports (basketball/volleyball) will be required to maintain mask/facial covering on at all times
4. Social Distancing
 - a. Student desks will be maintained with a minimum of 3 feet distance between each other
 - b. For classrooms where tables are used instead of a desk a plexiglass divider will provide separation and social distancing
 - c. Hallways/stairways and walkways will be 1 directional wherever feasible
 5. Hand Sanitizers
 - a. Staff and students are encouraged to frequently wash their hands, if no sink is available hand sanitizer dispensers and or stand up stations are available
 6. Campus Cleaning/ Disinfecting
 - a. All classrooms will be cleaned utilizing standard cleaning procedures (non-abrasive chemicals) at the end of each school day
 - b. Classrooms that have had a confirmed positive COVID-19 case will be deep cleaned via the approved use of the electrostatic sprayer if found to be necessary only
 - c. All restrooms and high touch surfaces such as door handles/ rails will be cleaned multiple times throughout the day
 - d. All classroom air filters have been changed and will be maintained per standard use and maintenance
 7. PPE
 - a. Per updated CDC and CDPH guidelines, the best cleaning strategy is traditional soap and water, therefore disinfecting wipes will be available on an as need basis
 - b. Latex gloves will be available upon request on an as need basis

We would like to assure you that we will continue to monitor and modify protocols based on updates from the CDC and State and County Health guidance.
