## F. President's Remarks and Board Comments

Member Petrie:

 Asked for clarification regarding the latest information around in-person board meetings. Steve Ezikian shared that the latest information from the Wayne County Health Department extends the opportunity to continue with remote meetings, if the Board decides to do so. Discussion amongst the board/administration ensued pertaining to this subject.

#### President Blackmon:

- Expressed how wonderful it has been working with Dr. Liepa adding that he has be a fantastic leader. Also, Welcomed Dr. Daveda Colbert sharing that she is delighted that she will be leading Wayne RESA as the next Superintendent.
- Provided a brief overview from the recent Metropolitan Affairs Coalition (MAC)
  meeting she attended (Broadband Capability for students/parents working from home,
  Infrastructure Concerns of the Region, Improvements to walking environments). In

addition, she noted that Congresswoman Debbie Dingell participated in the meeting and spoke about things happening in Washington that affect our Region.

- Shared the following Wayne County local school district highlights:
  - We are so excited that most of our school districts have found ways to celebrate graduations and proms in safe ways and in ways that students will be honored in the traditional sense, recognizing students for their achievements in memorable ways will last a lifetime.
  - Many of districts have been working with the WC Health Department and have set up vaccination clinics in their schools, so students can be vaccinated safely and efficiently. These efforts will help our State to defeat COVID and get our communities fully active again.
  - o Lastly, we want to recognize the significant planning that is happening in the districts to advance learning recovery for students who have fallen behind during the Pandemic. We appreciate the resources allocated from our state and federal government, but want to recognize our local Wayne County schools who have worked so diligently to get students the resources they need to be successful in school.

#### Member Jackson:

 Shared that she has just been appointed to serve on the American Red Cross Biomedical Committee.

# H. Superintendent's Report

Executive Director of Legislative Affairs, Mike Latvis:

- Shared a Legislative Presentation providing a summary and highlights on:
  - o A potential June 1<sup>st</sup> adjustment to the Governor's Vacc to Normal plan, allowing a change to current restrictions to move faster.
  - The 2021-22 Proposed Budgets (the Governor's Executive Recommendation Budget, the House Budget and the Senate Budget). Shared likes, dislikes and the message Education Lobbyists are pushing.
  - o Supplemental Budgets release of ESSERS funds proposed.

Mike answered questions from the Board

## Associate Superintendent Dr. Daveda Colbert:

- Thanked Mike for his tireless advocacy for public education and the students of Wayne County.
- Provided an overview on the Third Grade Reading legislation and the damaging effects of retention, noting that we do not support retention, it is not in the best interest of our students per educational research. We are looking for the best outcomes for all students and will continue to help our districts in every way possible, advocating for them against this law.
- Expressed that she is excited about the Governor's Academic Recovery Plan, pleased that she had an opportunity to provide input into it.

## Deputy Superintendent, Steve Ezikian

- Noted: in the report that Mike gave on the budget, unfortunately, there are no added funds for ISD's.
- Described a technical pronouncement from the state on the distribution of tax dollars.

- Special Education distributions As in previous years, as a result of our Act 18 fund balance, we will be making a one-time distribution payment in July to districts with Special Education Transportation expenses. You will see a Board Recommendation for these payments in your June Board Materials.
- Volkswagen Grant comes to an end. You may recall a grant opportunity for districts, through a Volkswagen settlement, to receive funding to help replace older busses for new more fuel-efficient models. The grant will be reimbursing about \$2.5 million to five of our school districts. You will see a Board Recommendation for these payments in your June Board Materials.
- Michigan School for the Deaf (MSD) MSD is having a lot of problems with staffing and compliance. MDE operates the school and they have approximately 30 students from Wayne County in attendance. The State is trying to pass the responsibility of providing FAPE (Free Appropriate Public Education) to the students back to the counties where the students come from. We have a problem with how this may affect the Center Programs we run, and ultimately the service students receive in the program.
- Years ago we were providing stipends for Paraprofessionals working to obtain their Special Education certification, however, we were cited for that by the State and it was deemed unallowable. Good news - we just received approval to offer this incentive again.
- ACE Academy (a strict discipline academy) in Highland Park is looking for a new authorizer and have approached WRESA to authorize them, however, we declined as they have a number of significant compliance issues. They have been denied by others as well, and as a result will likely be closing. We may want to explore the possibility of a strict disciplinary academy down the road. We are working with the Wayne County Juvenile group and Detroit schools to see if we can help accommodate the students, if the school closes.

# Superintendent, Randy Liepa:

- The last Superintendent Meeting (WCSSA) of the school year is Friday, May 21<sup>st</sup>. Superintendents and district staff have had a heck of a year, are exhausted. However, most will have a busier than normal summer and things are changing daily with regard to the health and safety requirements in Michigan (which, of course, always impact our schools).
- Recognized Deputy Superintendent Steve Ezikian as he has done an outstanding job working with the Health Department, providing guidance throughout the entire Pandemic. As we head into the end of the year our districts are facing new guidelines. They are more than ready to close out and prepare for next year. There is hope on the horizon for returning to a more normal school year, but of course there's no way to know if we will get an uptick in cases. We just have to be nimble to provide equitable education for all regardless of the circumstances.
- Thanked Associate Superintendent Daveda Colbert for the 3<sup>rd</sup> grade reading recap. It's unfortunate that our legislature didn't address and pause this, but our districts are working to have a game plan for their 3<sup>rd</sup> grade students.
- Shared that there are a variety of special education issues going on in the state that we are trying to help navigate. Our special education population were the most impacted through the pandemic. Superintendent Liepa recognized Assistant Superintendent Karen Howey and her colleagues as have had an enormous job trying to support local schools and advocate for special education students.
- Recognized and commended WRESA Board Member Lynda Jackson for her appointed to the American Red Cross Biomedical Committee; and for her willingness serve and provide her expertise to this committee.
