Health and Safety Plan Summary: Chester Charter Scholars Academy CS

1. How will the LEA, to the greatest extent practicable, support prevention and mitigation policies in line with the most up-to-date guidance from the CDC for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?

Chester Charter Scholars Academy (CCSA) continues to follow guidance and expectations related to COVID-19 from PDE, Pennsylvania Department of Health (PADoH) and Centers for Disease Control and Prevention (CDC). Mitigation efforts including social distancing expectations, masking requirements, increased cleaning, and education on handwashing allowed the school to provide in-person learning for 50% of the opt-in student population during much of the 2020-2021 school year.

In the few instances when a positive COVID-19 case was discovered, CCSA worked with the CCDoH to conduct contact tracing as effectively and efficiently as possible. This layer of support from the DoH was critical in minimizing the spread of the virus, keeping our buildings open and operating as safely as possible.

In similar fashion, CCSA intends to continue following guidance provided by PDE, PADoH and CDC to maintain in-person learning for students in the 2021-2022 school year.

2. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?

As a result of the Governor's order to close schools on March 13, 2020, Chester Charter Scholars Academy stopped providing face-to-face instruction. From March 16 through March 27, students worked on completing independent assignments provided to students online or in hardcopy. CCSA staff contacted each student at least twice per week to check on progress, respond to questions and provide academic assistance. Beginning on March 30, 2020, staff began to implement the CCSA Continuity of Education Plan. Students were provided with live virtual interaction with their assigned teachers on a daily basis. Each day students were

provided with a combination of academic lessons and office hours. Live lessons were recorded so that students could access the instruction asynchronously, if needed. CCSA staff worked remotely during the closure period so that many of them could manage their professional responsibilities while also caring for their own children at home.

CCSA began the 2020-21 school year by providing completely remote instruction. Students were provided a full day of live virtual instruction and support. Throughout the closure period, teachers and support staff including Climate Managers and teaching assistants followed up with any students who were not regularly attending class and/or completing assignments. Guidance Counselors continued to provide scheduled counseling supports by holding virtual sessions and held open office hours for students who needed additional socio-emotional support. Meals (including 5 breakfasts and 5 lunches) were made available for pick up each Monday. Technical support was provided for families daily at school. Students were also invited to attend the afterschool enrichment program for additional support. In February of 2021, CCSA offered in-person instruction for up to 50% of each class. Both students who elected to come in the building and those who remained remote had access to the same quality instruction.

CCSA staff members made home visits to monitor progress and well-being of some of our most vulnerable students and delivered meals for families who did not have transportation. Despite the efforts of our staff to engage families, the struggles with financial hardship, health issues, deaths, mental health, job loss, and shelter in place caused resulted a greater need for social emotional supports.

For the 2021-22 academic year, CCSA is providing in-person instruction. The meal pick-up will cease. Food pantry items continue to be available on an as needed basis in the main lobby. CCSA staff continue to receive training on trauma informed practices to ensure that they are better equipped to support students' social-emotional needs as a result of the pandemic. School leadership is reached out to families over the summer to resolve any conflicts that emerged between students during the 2020-21 school year without the supportive conflict resolution strategies typically provided in the school environment. Staff are expected to facilitate consistent community building and social-emotional learning opportunities within the classroom.

ARP ESSER Requirement	Strategies, Policies, and Procedures
a. Universal and correct wearing of masks	CCSA continues to follow PDE and PADoH's guidance, expectations, and requires universal masking. All students, staff and visitors will be required to wear a mask until further notice. Continued training and professional development provided training for students and staff on correct mask wearing. Sports: Athletes are required to wear a mask during practice and strongly encouraged to wear a mask during competition. Athletes must comply with requirements for any away competition.
b. Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding)	CCSA will continue to follow PDE and PADoH's guidance, expectations, and any updates related to physical distance. This includes but is not limited to removal of unnecessary furniture/furnishings and adjustments to room utilization. Additional measures were and can be implemented to keep students physically distanced at lunch and recess as well based on current guidance.
c. <u>Handwashing and</u> respiratory etiquette	Students and staff are trained on proper handwashing, appropriate sneezing and coughing techniques, as well as strategies for keeping distance in the hallways, classrooms, cafeteria, etc. Hand sanitizing stations have been added in each classroom and will be maintained.
d. <u>Cleaning</u> and maintaining healthy facilities, including improving <u>ventilation</u>	CCSA facilities are cleaned and disinfected according to recommendations from PDE and PADoH. The HVAC system has been adjusted to increase fresh air intake and air exchanges.

f. <u>Diagnostic</u> and	CCSA will continue to use a daily health screening tool that staff/students are expected to complete prior to

screening testing	reporting to school. Additionally, temperature checks for all staff and students remain in place. CCSA will continue to use COVID-19 antigen testing for symptomatic individuals and weekly assurance testing of staff, which is required for staff members who are not fully vaccinated and optional for staff members who are vaccinated. Sports: Any athletes who are not fully vaccinated must consent to COVID testing two times a week.
g. Efforts to provide vaccinations to school communities	CCSA worked with the COVID Taskforce of the Delaware County Department of Intercommunity Health to establish an on-site pop-up clinic for vaccinations in July & August. CCSA will continue to seek opportunities to promote the importance of vaccination as a health strategy and provide on-site vaccination clinics based on family/student demand.
h. Appropriate accommodations for students with disabilities with respect to health and safety policies; and	Appropriate accommodations will be made for students with disabilities based on the student's IEP and/or guidance provided by said student's physician.
i. Coordination with state and local health officials.	CCSA will continue to collaborate and coordinate with state and local health officials for the 2021-2022 school year.
