Group	Quarantine Requirements Due to Exposure
Fully vaccinated individuals	<ul style="list-style-type: none"> <li>• If asymptomatic, no quarantine is necessary, no testing required</li> <li>• If symptomatic, 10-day quarantine from last day of exposure and then 24 hours with no fever without the use of fever-reducing medications</li> </ul>
Unvaccinated persons exposed when both parties were wearing masks	<ul style="list-style-type: none"> <li>• May continue to come to school/work under the following modified 10-day quarantine, if exposed persons:               <ul style="list-style-type: none"> <li>○ Are asymptomatic; and</li> <li>○ Continue to appropriately mask, as required; and</li> <li>○ Undergo at least twice weekly testing during the 10-day quarantine; and</li> <li>○ Continue to quarantine for all extracurricular activities at school, including sports, and activities within the community setting.</li> </ul> </li> </ul>
Unvaccinated individuals	<ul style="list-style-type: none"> <li>• If asymptomatic during entire quarantine, 10-day quarantine from last day of exposure</li> <li>• If asymptomatic during entire quarantine, 7-day quarantine with a negative test result (test must occur on day 5 after exposure or later)</li> <li>• If symptomatic, 10-day quarantine from last day of exposure and then 24 hours with no fever without the use of fever-reducing medications</li> </ul>
Group	Quarantine Requirements Due to Positive Test Result
All Persons (vaccinated & unvaccinated)	<ul style="list-style-type: none"> <li>• 10-day quarantine from date of positive test, and then 24 hours with no fever without the use of fever-reducing medications</li> </ul>
Group	Quarantine Requirements Due to Symptoms with No Known COVID Exposure
All Persons, symptomatic with no known exposure	<ul style="list-style-type: none"> <li>• May return to school or work site after ten (10) day quarantine or with a negative COVID test, as long as person is symptom-free. <span style="color: red;">[Replaces 7/23/2021 Protocol]</span></li> </ul>

*\*Staff and Students who are not fully vaccinated are encouraged to wear a face covering in crowded outdoor settings or during activities that involve sustained close contact (including high-risk contact sports) with other unvaccinated individuals.*

*Exposure is defined as being within 0 -6 feet of a laboratory-confirmed COVID19 case for greater than 15 minutes in the aggregate over a 24-hr period.*
