**NOTES:** The GET Program is administered by the Washington Student Achievement Council. GET's value is based on resident, undergraduate tuition and required fees at Washington's most expensive public university, either UW or WSU. The monetary value of a GET account is the same wherever you use it. If your school costs more than UW/WSU, you pay the difference. If it costs less, you can also use units for room and board or other eligible college expenses. GET units must be held for 2 years before use. GET units include a premium over current tuition, so plan to hold your units for 6 years before you see financial gain. Custom Monthly Plans include a 7.5% finance charge. Account refunds may incur fees and tax penalties. See Master Agreement for full details.
