F.) PRESENTATIONS BY THE ADMINISTRATION

Mayor Daniel A, Champagne updated the Town Council on the following topics:

- The status and response to the 14" of recent rain and the impact to residents and the town was discussed. Michael J. Purcaro, Town Administrator and Emergency and Risk Management Director, spoke regarding the storm water management system as well.
- Vernon Dog Park has a sink hole in the small dog area a retention basin emptied into the Hockanum River and the pipe needs repair and that area will be closed during this repair.
- The 12th Annual Summer Days Community Carnival is Wednesday July 21 through Saturday July 24. Council Member Schaefer spoke regarding the event.
- The Rectangular Rapid Flashing Beacons have been installed at Center Road and Phoenix/Washington. The remaining locations will be installed once permits are finalized with the State of CT Department of Transportation.
- The schedule for swimming at Newhoca Beach, Community Pool and Valley Falls Beach were announced. The North Central District Health Department and town is testing the water quality regularly and any changes will be updated via social media.
- The paving project is still on schedule despite the recent rain with the parking lots of Northeast School, Center Road School and Maple Street Schools being done now and the remaining locations will be completed next.
- The solar canopy install projects at Center Road, Lake Street and Northeast schools have been completed.
- The Windermere Fields project has slowed due to rain, however, it is moving along with many requirements completed.
- The DPW wash bay project is progressing and has been delayed due to public safety projects taking precedence. A fire wall will be installed between the wash bay and building to meet fire codes.
- In addition to the public safety priorities, the cost of building supplies has also created a delay for other projects ie: Citizens Block, etc. as well.
- National Night Out is scheduled for Tuesday, August 3, 2021 from 5:00pm-8:00pm in the Courthouse Plaza parking lot. Council Member Didio spoke regarding the event.
- The 2021 Plan of Conservation and Development draft has been released. The Planning and Zoning Commission has scheduled a Public Hearing scheduled for September 14, 2021 at 7pm.
- Police Chief John Kelley assumed command on July 9, 2021.
- July in the Sky was successful considering the weather forecast.
- A \$2,000,000.00 state grant was received to clean up Daniel's Mill advancing plans for redevelopment Gateway to the Historic Downtown District.
- The Senior Center is moving forward with re-opening plans adding more in-house programs and increased capacity. The pavilion is open and Town of Vernon Sgt Chris Pryputniewicz is leading a new Pickle Ball Training Program.
- The Talcottville Main Street bridge project is on schedule to be completed in November 2021.
- Pegi Dietz has ended her appointment as the Town of Vernon's first Poet Laureate. The new Poet Laureate will be selected from students at Rockville High School in September.
- Reimbursement from the FEMA and Coronavirus Relief Fund will be used to reimburse the ambulance medical services fund.
- Shakespere in the Park summer performance is scheduled for Saturday August 7, 2021 at 7:00pm and Sunday, August 8, 2021 at 2:00pm in the upper parking lot of the Rockville Public Library, a free event being held rain or shine.
