WAIVER

The Waiving Party further agrees to indemnify, defend and hold the Released Parties harmless, from any and all claims, damage losses, costs, (including reasonable attorney's fees), liabilities, actions or causes of action arising out of, connected with or in any way resulting from the Waiving Party's participation in any Games or other St. Clement School Basketball Team sponsored event at the Center. The Waiving party acknowledges that the Released Parties are not responsible for any inclement weather, acts of God, which may affect the ability of any Games or other **St. Clement School Basketball Team** sponsored event at the Center to be conducted when otherwise scheduled, and releases and waives any and all claims against the Released Parties for damage, loss, cost or liabilities that may arise there from.

This Waiver is intended to be as broad and inclusive as permitted by law, and if any portion hereof is held invalid, it is agreed that the balance of this Waiver shall continue in full legal force and effect. The Waiving Party acknowledges that no promise or inducement has been offered, to him/her whether verbally or in writing, impliedly or explicitly, except as herein set forth and that this Waiver has not been executed based upon statements or representations by any person or entity. This Waiver shall be governed by and construed under the internal laws of the State of Illinois without regard to any conflicts of law principals.
