Call to Order

A Regular Meeting, Open to the Public, of the Board of Education for the Rochester Community Schools, Rochester, Michigan was held on Monday, December 8, 2014 at the Harrison Room. President Lisa Nowak called the meeting to order at 6:58 p.m. Board members led in the Pledge of Allegiance.

Reports

A. Superintendent's Committee Reports (Information Item) Dr. Shaner, Mr. Romzek

Dr. Shaner shared information from the Superintendent's Steering Committee meeting that took place on December 3, 2014. Topics of discussion included processes and systems for our Finance Department, Facility & Technology Infrastructure Committee, new board members and board goals for the coming year.

Assistant Superintendent for Business Dan Romzek shared information from the Superintendent's Business and Operations Committee meeting that took place on November 6, 2014 and December 1, 2014. Topics covered in the November meeting included a review of the draft audit report, discussion about facility planning process, and review of the budget. Topics covered in the December meeting included the process associated with new Board members, mid-year budget adjustment, facility planning update, bond refunding update, medical insurance cost sharing, proposed highway easement at Hamlin Elementary and the summer tax levy.

A. Board of Education Closed Meeting Minutes, December 1, 2014 (Action Item)

Dr. Fiaschetti was not a member of the Board of Education on December 1, 2014.

B. Approval of Resolution Accepting 2015 Refunding Bond Pricing - (Action Item) Mr. Romzek

Mr. Romzek introduced a representative from Thrun Law Firm who briefly highlighted the resolution that is being presented tonight.

Board discussion included correction to clerical error in contract, clarification that this refunding will allow us to reduce our millage, question regarding our ability to refund future bonds, and a clarification question regarding the timing of the refunding.

A motion was made to approve the Authorizing Resolution for the Issuance and Delegating the Sale of the Refunding Bonds, as presented.

D. Approve Resolution for Medical Insurance Cost Sharing for the 2015 Coverage Year (Action Item) Mr. Romzek

Mr. Romzek presented a resolution that is needed in order to comply with the requirements of PA152.

A motion was made to approve the Resolution for Medical Insurance Cost Sharing for the 2015 Coverage Year, as presented.

E. Approval of Highway Easement at Hamlin Elementary School (Action Item) Mr. Romzek

Mr. Romzek explained the easement project, which will include a three lane road and a sidewalk. The city is requesting that Rochester Schools grant the easement to the City of Rochester Hills for \$1.00. This is a project that is of mutual benefit to the City of Rochester Hills and the district.

A motion was made for the Approval of Highway Easement at Hamlin Elementary School, as presented.

Board discussion included an inquiry regarding speed limit changes, questions regarding the new sidewalk installation, and clarification that the distance from the vehicle lanes to the school building will remain the same.

Assistant Superintendent for Instruction Debi Fragomeni presented the draft of the Cardiac Emergency Response Plan.

Dr. Shaner reviewed our mid-year budget adjustments. Mrs. Fragomeni and Mr. Romzek, along with Executive Director of Elementary Education Michael Behrmann, Executive Director of Secondary Education Carrie Lawler, Executive Director of Special Education Anne Evans gave further explanation of the budget adjustments within their assigned areas.

A motion was made to approve the Resolution Authorizing Mid-Year Budget Adjustments, as presented.

Board discussion included reducing the number of subs at the elementary level, impact on special education services, FTE calculation explanation, clarifying the reduction from our Safe-Ed., LLC contract, secondary staff adjustments, General Fund subsidy to athletics, and fund equity balance.

Jenny McCardell, citizen, addressed the Board regarding the projected student enrollment count.

Michael Cicco, citizen, addressed the Board regarding class sizes at the elementary level and how we estimate enrollment count.

Jeff Lauth, citizen, addressed the Board regarding impact on displaced district personnel.

David Leszkowitz, citizen, addressed the Board regarding open enrollment for students outside of the Rochester Schools boundaries.

Michelle Bueltel, citizen, addressed the Board regarding the eliminated classes at the secondary level.

Dana Meyer, citizen, addressed the Board regarding the reduction of subs at the elementary level.

Thomas Crowe, citizen, addressed the Board regarding contracts awarded for district services.
