# 2021-22 Guiding Principles

- Staff are prepared to support our students and each other.



## Logistics-Vaccinations

- Current staff data indicates 50% are fully vaccinated (50% of staff responded to survey thus far with 97% of respondents vaccinated)
- Students 12 and up are eligible, offering pop up clinics at the District Office Parking Lot on Breaker Day (8/12 & 8/13) and WaveRider Day (8/13)
  - Parents must provide written consent and register directly with the pharmacy providing the vaccinations.
    - Information sent to all TMS and LBHS families via ParentSquare

## **Logistics- Masks**

- Masks are required for all indoors on school sites when students are on campus even if fully vaccinated
- Masks are required while riding the bus at all times
- Fully vaccinated staff may remove their mask indoors when no students are on campus
- Masks are optional outdoors for all, including unvaccinated staff/students
- Unvaccinated staff interested in having an N-95 mask provided to them can request one from their admin assistant



- Self-administered mail-in PCR saliva test kits are available for pick-up at all school sites and the District office during business hours. Individuals can drop off the completed kits at any Fedex drop box location.
- Kits will be provided to any staff or student who is considered a close contact (within 6 feet for >15 minutes in a 24 hour period, regardless of masking).

### **Logistics- Contact Tracing & Quarantine**

Student Quarantine Protocol for Close Contact (within 6 feet for >15 minutes in a 24 hour period) for <u>Vaccinated Students/Documented</u> <u>COVID-19 within past 90 days (OCHCA 8/3/21 & CDPH K-12 Schools Guidance 2021-22 Questions & Answers 8/6/21)</u>:



#### No Symptoms:

- No quarantine
- □ No required testing (although CDC recommends testing between day 3-5)
- ☐ Continue to monitor symptoms through day 14



### Any Symptoms:

- ☐ Isolation for 10 days regardless of test results
- Get tested
- Get care

### **Logistics- Contact Tracing & Quarantine**

Student Quarantine Protocol for Close Contact (within 6 feet for >15 minutes in a 24 hour period) for **Unvaccinated Students (OCHCA 8/3/21 & CDPH K-12 Schools Guidance 2021-22 Questions & Answers 8/6/21)**:




#### No Symptoms:

- Exposed student may return to school on a "Modified 10-day Quarantine" if:
  - Both the infected and exposed were wearing a mask at the time of exposure
  - No symptoms emerge
  - Testing immediately after exposure, and subsequent testing 3 days apart
  - Required to wear mask indoors and strongly encouraged outdoors
  - Quarantine from all extra-curricular activity for 14 days, except
  - Student quarantine can end after day 7 from last known exposure if COVID-19 test is negative after day 5 from last known exposure
    - Student may begin extra-curriculars



### Any Symptoms Develop During Quarantine

- Isolation for 10 days regardless of test results
- Get tested
- Get care



## Logistics

- Addition of UV light filters in all HVAC units which replaces evening UV disinfection
- Continued use of HEPA air purifiers in every workspace and classroom
- Continue to follow all respiratory and hand washing etiquette
- Continuation of additional custodial support daily for disinfecting

### **Logistics- Other Measures**

- Reduced class size averages with the addition of 17 FTE compared to 2019-20.
  - 1 staff member for every 9 students in 2019-20
  - Projected 1 staff member for every 7.5 students in 2021-22
- Outdoor Learning Environments at TOW/EM
  - Committee comprised of staff and parents
  - Created additional large outdoor spaces for classroom learning
  - Purchased additional furniture/tents increasing outdoor work spaces for each classroom

## **Logistics- Outdoor Spaces**



- CDPH released new K-12 guidance on July 12, 2021
- Mid-July the logistics team engaged in researching potential options to increase outdoor learning spaces at elementary schools
- Major factors in developing options included procurement timeline, DSA requirements, CDPH & OSHA requirements, efficient use of space, etc...

## Logistics- Outdoor Spaces

- Existing shaded areas conducive for outdoor learning identified
- 10'x20' temporary shade structures set-up for each grade level K-5
- Additional temporary shade structures (10'x20' & 10'x10") set-up at designated positions
- Temporary outdoor furniture procured for outdoor spaces
- Extra shade structures and furniture available upon request

### Outdoor Learning Spaces

- Options developed to create flexible outdoor spaces at each school
- Elementary schools identified as needing additional shaded areas to support outdoor learning
- Secondary schools both confirmed sufficient existing outdoor spaces available for use
- Temporary shade structures and furniture identified for use to create new outdoor learning spaces



## **Logistics- Nutrition**

- Meals prepared in-house, mostly from scratch
- Meals will be prepped and ready for students to pick up from designated location near cafeteria at each school
- A la carte food items not offered initially, but will reevaluate as we begin the school year
- Lunches served to all students at no cost for the 2021-22 school year
- Universal meal program to begin in the 2022-23 school year, making two meals a day free to students at school

## **Logistics- Transportation**

- Social distancing requirements mitigated by requiring face coverings for all riders
  - Capacity increased to provide maximum available seating
  - Additional resources provided on the transportation web page
- Bus windows must remain open to maximize outside airflow


### Transportation Services

- August 9th bus pass sales went live for the 2021-22 school year
  - Sales initially limited to 27 per bus, matching the end of last year
  - Pass requests far exceed available limited capacity
- Bus capacities increased based on latest CDPH guidance - 54 TMS / 81 elementary schools
- August 12th Additional bus passes open for sale at noon
  - Buses operating at full capacity to support transportation needs



# Full-Day, In-Person Instruction at ALL Schools

- Elementary Schools = students with their assigned classroom teacher everyday
- Secondary Schools = 6+ year long classes
- After-school clubs and sports
- Return to regular attendance requirements = on-campus
  - Hybrid class or simultaneous teaching not an option (class participation via Zoom)
- Short-Term Independent Study (*less than 15 days*): coursework will be provided from their teacher that accounts for each day of absence.



### **Independent Study Option**

- Absent for 15 or more days (Long-Term Independent Study)
- For students whose health would be put at risk by in-person instruction
- Home-based learning option offered with Orange County Department of Education (OCDE)
  - TK-8 grades = Community Home Education Program (CHEP)
  - 9-12 grades = Pacific Coast High School (PCHS)
- Students may return to in-person instruction throughout the school year
- For students with disabilities, IEP must allow for independent study participation




#### Student Supports: **Academics**

- Universal screeners and diagnostic assessments for ELA and math to monitor student progress
- Smaller class sizes to decrease in student-to-teacher class size ratios
- Increase in academic intervention staff at elementary and middle schools
- **Before and after school** academic supports
- Designated time during the school day for intervention and enrichment at all 4 schools
- Access to 24/7 tutoring through Paper educational support system
- Blended learning through Canvas and Google
  Classroom learning management systems
- Ongoing vertical articulation and planning between grades/subject areas teachers



### Student Supports: Social-Emotional

- Universal social-emotional screeners
- Increase in district mental health support staff
- Increase in counseling services for students who are English learners and with low socioeconomic status
- Targeted small group after school support for social-emotional wellness
- Development of well(ness) spaces at TMS and LBHS in partnership with OCDE/CHOC
- Implementation of research-based social-emotional learning (SEL) curriculum
- School-based intervention teams to support wrap-around services
- Increase in community-based program collaboration, including Boys & Girls Club Laguna Beach



## **Technology**

- Continue to offer at-home internet access as needed.
- All K-12 students will have chromebooks this year.
- K-5 students are using Google Classroom
- 6-12 grade students will be using **Canvas**
