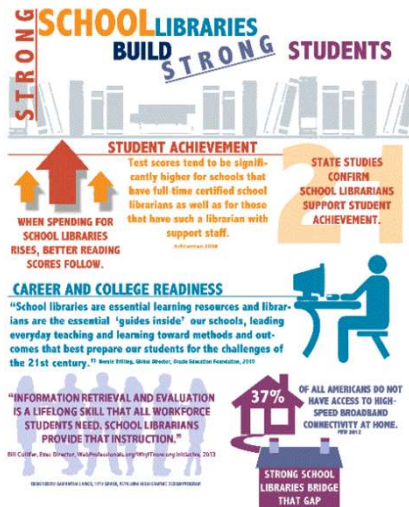

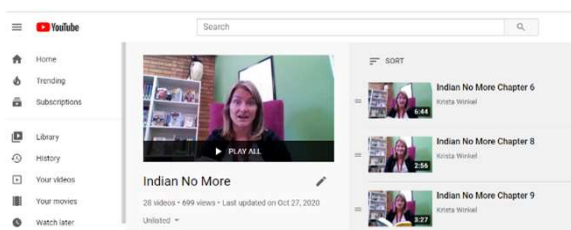

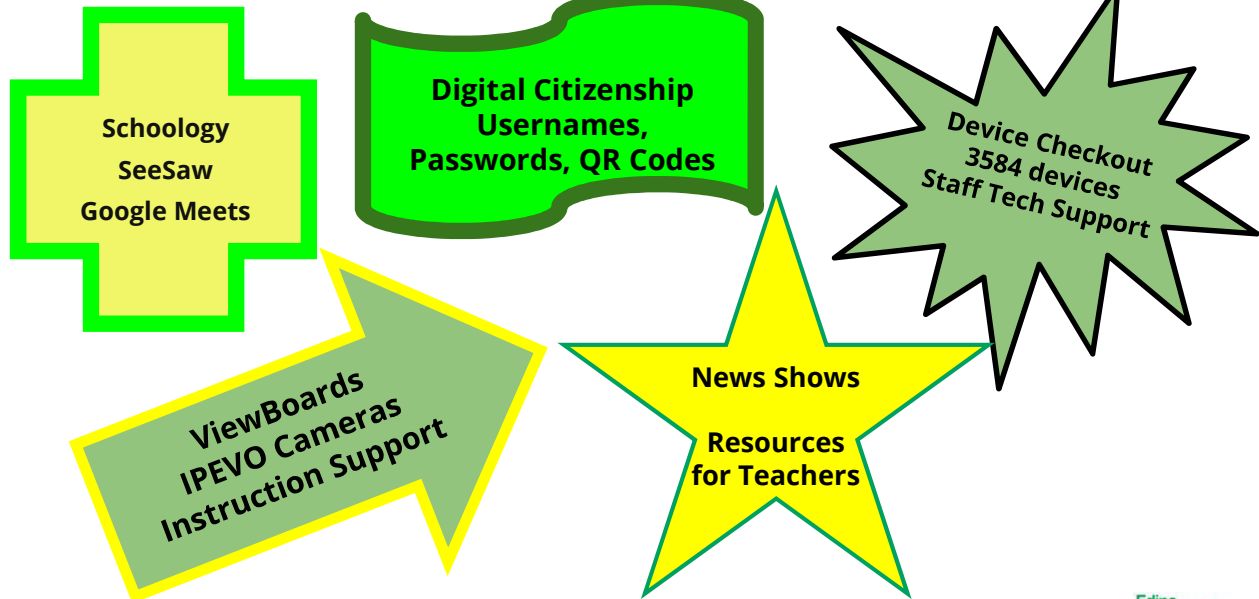

New Hire, Basic Leave Allotment: A newly hired employee will receive a one-time basic leave allowance of 35 days in addition to any amount provided for a given fiscal year.

Performance Based Pay Incentive: An employee who has successfully achieved the employee's goals set with the supervisor will receive up to \$2,150.00. The amount of payment may vary based on budgetary restrictions and significance of goals achieved.

RETIREMENT BENEFITS

Employer's maximum contribution towards tax-deferred matching contribution: \$4250

Employer's match towards tax-deferred matching contribution: 3%

HRA Contribution, For Employees hired after August 1, 2013:

The Employer will make annual contributions into an HRA for 10 years in accordance with the below schedule for a total Employer contribution of up to \$65,000. The funds contributed by the Employer and placed in an HRA for the employee vested with the employee after the seven consecutive years of employment with the Employer. The Employer retains control of any funds contributed into an HRA on behalf of an Employee until those funds have vested. The Employer remains responsible to invest any funds and pay any associated fees until the funds vest with the Employee, at which point those responsibilities are transferred to the Employee. The Employer will deposit the appropriate amount of money into the HRA by June 30th of the completed year of service.

Retirement Payments Benefit:

Eligibility: To be eligible for the retirement payments described below, an employee must be retiring after age 50 and have been a full-time district employee of Edina Public Schools for a minimum of ten full years.

Application: Application for the retirement payments for retirement at the end of the school year must be submitted to the Human Resources Office by February 1. The Employer may approve a retirement request effective at a date prior to the end of the fiscal year. Application for this consideration for "mid-year" retirement must be submitted by the end of the previous fiscal year.

Distribution of Retirement Payments (Payment 1 and Payment 2): An employee eligible for the retirement payments will receive payment in two installments. The first payment will be on the last day of the month the employee retires in an amount equal to two-thirds (2/3) of the retirement incentive payment amount. The remaining one-third (1/3) will be distributed the following January 15.

If an employee applied for mid-year retirement, as defined above, the amount of retirement payments is based on the last full fiscal year of employment.

The retirement payments (early retirement incentive payment and basic leave conversion payment) will be deposited in the employee's 403(b) account to the maximum extent allowed by the 403(b) administrator and any remainder of the payment will be deposited into the employee's account with Minnesota State Retirement System's Health Care Savings Plan.

Calculation of Early Retirement Incentive Payment (Payment 1): A full-time eligible employee will receive a retirement incentive payment of 120 days. The daily rate of pay is calculated from the last year of full-time service.

Calculation of Basic Leave Conversion Payment (Payment 2): In addition to the Early Retirement Incentive Payment (payment 1), an eligible employee will receive a basic leave conversion for unused basic leave days to a maximum of 83 days. The payment equals the number of the employee's accumulated unused basic leave days, not to exceed 83 days, multiplied by the employee's daily rate of pay. The daily rate of pay is calculated from the last year of full-time service.

Employer Contribution to the Health Care Savings Plan (Payment 3): A full-time employee retiring after age 50 with a minimum of ten full years of service is also eligible for an Employer contribution toward the Minnesota State Retirement System's Health Care Savings Plan. The accumulative total of this contribution will not exceed the following calculation: \$35 multiplied by the employee's accumulated unused basic leave days in excess of 140 days as of the date of retirement.

Maximum Benefit: A combined total of (1) early retirement incentive payment (payment 1), (2) basic leave conversion payment (payment 2), and (3) the Employer contribution to the Health Care Savings Plan (payment 3) must not exceed the employee's last full year salary.

RESOLUTION ESTABLISHING COMBINED POLLING PLACES
FOR MULTIPLE PRECINCTS AND
DESIGNATING HOURS DURING WHICH THE POLLING
PLACES WILL REMAIN OPEN FOR VOTING
FOR SCHOOL DISTRICT ELECTIONS NOT HELD
ON THE DAY OF A STATEWIDE ELECTION

BE IT RESOLVED by the School Board of Independent School District No.273, State of Minnesota, as follows:

1. Pursuant to Minnesota Statutes, Section 205A.11, the precincts and polling places for school district elections are those precincts or parts of precincts located within the boundaries of the school district which have been established by the cities or towns located in whole or in part within the school district. The board hereby confirms those precincts and polling places so established by those municipalities for **2021**. (Exhibit A)

2. Pursuant to Minnesota Statutes, Section 205A.11, the board may establish a combined polling place for several precincts for school district elections not held on the day of a statewide election. **Each combined polling place must be a polling place that has been designated by a county or municipality.** The following combined polling places are established to serve the precincts specified for all school district special and general elections not held on the same day as a statewide election: (Exhibit A)

Note: See Section 2.3.2 of the Election Manual regarding changing polling places in the case of an emergency or if the polling place is no longer available.

*3. Pursuant to Minnesota Statutes, Section 205A.09, the polling places will remain open for voting for school district elections not held on the same day as a statewide election between the hours of 7 o'clock a.m. and 8:00 o'clock p.m.

Note: See Section 3.6 of the Election Manual regarding certain restrictions on voting hours.

4. The clerk is directed to file a certified copy of this resolution with the county auditors of each of the counties in which the school district is located, in whole or in part, within thirty (30) days after its adoption.

5. As required by Minnesota Statutes, Section 204B.16, Subdivision 1a, the clerk is hereby authorized and directed to give written notice of new polling place locations to each affected household with at least one registered voter in the school district whose school district polling place location has been changed. The notice must be a nonforwardable notice mailed at least twenty-five (25) days before the date of the first election to which it will apply. A notice that is returned as undeliverable must be forwarded immediately to the appropriate county auditor, who shall change the registrant's status to "challenged" in the statewide registration system.

The cost section of the response must not contain any erasures, corrections, or white outs. Failure to comply will result in the response being rejected.

The District will reject all responses received after the closing time identified above. Facsimile responses will not be accepted. The District is not responsible if an improperly addressed response is opened prematurely. All requests to withdraw a proposal must be made in writing to the District at the address listed above. Vendors may not withdraw their proposal within 90 days after the actual date of the opening, without forfeiting the bond.

The School District reserves the right to waive technicalities or irregularities, to accept any portion of a vendor's proposal, when responses are by items, to reject any or all responses and to make arrangements to the best interest of the Edina School District.

The vendor must include as part of their response:

- A. A signed affidavit of non-collusion.
- B. A signed Statement of Affirmative Action for Equal Opportunity Employment.

The above forms are provided as part of the RFP document.

1.3 RFP Response Format

Vendors must include the following in their response:

- A. Description of the services being proposed. Services proposed must comply with the requirements as outlined in Section II of the RFP.
- B. Vendor qualifications as outlined in section 1.5
- C. Cost information as required in Section III of the RFP

Failure to submit your proposals in accordance with the requirements of the RFP will be grounds for rejection. Vendors must warrant that the proposed services meet or exceed all specifications contained or referenced herein. Vendors remain solely responsible for the accuracy of the proposal as to service performance and quality and quantity of any material provided.

1.4 General Requirements and Instructions to Vendors

The primary intent of this document is to provide vendors with sufficient information and a point of reference to propose solutions and associated services that will satisfy the objectives of the District as stated in Section II of the RFP.

Vendors must respond to the base request and any alternates if requested as set forth in Section II of the RFP. Final determination of what is procured is dependent on the responses provided by the vendors and other budgetary considerations.

The following must be considered in responding to the RFP.

- a. The specifications provided herein are intended to facilitate an understanding of the district's needs and are to be considered the *minimum* requirements. It is the vendor's responsibility to propose a technically sound and operationally functional service.
- b. The proposed solution must provide a highly reliable grade of service. Vendors must document conformance with the performance requirements of Section II.
- c. Each vendor is required to submit proposed contracts, catalog data and technical information that completely describe the services being proposed. Information provided will be used during the evaluation process. All general contents of this RFP and technical specifications herein, as well as the complete response of the successful vendor, will be included in any contract between the District and the successful vendor.
- d. The District reserves the right to determine whether a vendor is responsive and has the ability and resources to perform the contract in full and comply with the specifications. Inability to demonstrate vendor experience will result in rejection of the proposal.

- e. The District reserves the right to request additional information from the vendor to satisfy any questions that might arise. The District further reserves the right to reject any or all response and/or to issue invitations for new proposals.
- f. The District assumes no responsibility for understanding or representations concerning conditions made by its officers or employees prior to the execution of a legal contract, unless such understanding or representations are specifically incorporated into this RFP.
- g.. Verbal discussions pertaining to modifications or clarifications of this RFP will not be considered part of the RFP unless confirmed in writing. Any information provided by the vendor verbally will not be considered as part of that vendor's response until written confirmation is received by the District at the address provided in this RFP.
- h. The vendor is required to review this document and to become familiar with the requirements necessary to make a complete response in compliance with local, state, and federal codes and the RFP specifications. Failure to review the provided information regarding this project will not relieve the vendor from submitting a complete and fully responsive proposal.
- i. The District is not responsible for location or securing any information that is not identified in the RFP and reasonably available to the district. To ensure that sufficient information is available, the vendor must furnish as part of the response, all descriptive material necessary for the District to determine whether the response meets the requirement of the RFP and establishes exactly what the vendor proposes to furnish.
- i. Subcontractors working for the vendor must meet all the requirements of the RFP and any contract between the vendor and the subcontractor must include all contract terms agreed to between the District and the successful vendor.

1.5 Response Evaluation

It is important that vendors review this subsection to understand the District's evaluation process.

A. Vendor Qualifications. Vendors responding to the RFP must have the following minimum qualifications.

- 1.The company or the subcontractors used must have a minimum of five years' experience in providing the service being proposed.
- 2.The company or subcontractors used must have successfully installed services of similar scope and size for at least three customers.
- 3.The company or subcontractors used must have a service and support capability and be able to respond within the specified time frame identified in Section II of the RFP.
- 4.Vendors must participate in FCC's Schools and Libraries E-Rate program and commit to follow the guidelines necessary to enable the District to qualify and obtain appropriate discounts. Vendors must include their Service Provider Identification Number (SPIN) for use In E-Rate applications.

Vendors must include information that substantiates their qualification as part of their response to the RFP. Vendors that do not qualify will not be considered further.

B. Proposed Solution Against the Requirements of the RFP. Solutions not meeting the requirements stated in the RFP (Section II) will be eliminated from further consideration at this stage in the review process.

Arvig Agrees

C. The District will weigh the proposal as follows:

- i) Cost (350 points-35%)-One time and/or multi-year costs(s) for will be used to evaluate the total cost of the services. Cost incurred to transition from existing services would be

included as part of the cost evaluation.

- ii) Technical Solution (250 points-25%)-The District will review the technology used to deliver services, the resiliency of the proposed solutions, and effort required by the District to work with the vendor.
- iii) Vendor Capabilities and Support (200 points-20%)-The District will review vendor experience, service level agreement provided, customer references and the overall support capabilities.
- iv) Ease of Transition (200 points-20%)-The District will review the proposal and the ease of implementation and cutover of services.

The District may shortlist vendors and request presentations from shortlisted vendors before making a decision. The District will award the contract to the lowest **responsible** vendor.

The District reserves the right to waive minor defects in a proposal during the evaluation process if it is deemed not to have any material effect on the final outcome.

1.6 Contract Terms and Conditions

- 1.6.1 **Contractual Conditions.** The following contractual conditions, in addition to service requirements and installation terms, shall be included in the contract entered into by the District and the successful vendor.

- 1.6.1.1 Number of Vendors: The District may have multiple contracts-one for each category of service requested. The vendor may have subcontractors. Any agreements between the vendor and subcontractors must not conflict with the terms of the agreement between the District and the vendor.

- 1.6.1.2 Laws of Minnesota and Effective Date: The contract between the District and the successful vendor shall be governed by the laws of the State of Minnesota. The contract shall be effective on the date it is approved and signed by the District.

- 1.6.1.3 Risk of Loss or Damage: The District shall be relieved from all risks of loss or damage to the materials during periods of transportation, installation and during the entire time it is in possession of the successful vendor and until such time as unencumbered title for the system is vested in the District and it is in the exclusive possession of the District.

- 1.6.1.4 Successful Vendor's Liability: The successful vendor shall be liable for damages resulting from injury to a person and/or damage to the property of the District, employees of the District, or persons designated by the District for any purpose, prior to or subsequent to acceptance, delivery, installation, and use of the system or service either at the successful vendor's site or at the District, provided that the injury or damage was caused by the fault or negligence of the vendor.

The vendor agrees to at all times to protect, defend, indemnify, and save the District (including the District's employees) from any and all claims and damages of every kind and nature made, rendered or incurred by or in behalf of every person or corporation whatsoever, including the parties hereto and their employees that may arise, occur, or grow out of any acts, actions, work, or other activity done by the said vendor, his employees, subcontractors, and the like, in the performance of this agreement.

- 1.6.1.5 Assignment of Interest: The successful vendor shall not assign any part of its interest in this agreement without prior written consent of the District or agents thereof.

- 1.6.1.6 Permits: The successful vendor shall be responsible for any and all permits required.

- 1.6.2 **Date of Acceptance.** The contract will be considered substantially complete under the following conditions:

- a. All of the work has been completed in accordance with the contract and specifications.
- b. The system and or service operates in conformance with manufacturer's published speci-

cations.

- c. Completion of 30 consecutive days of operation without major system or failure from when the system or service is turned over to the District for use. Failure within this period would re-start the 30-day period.

The vendor shall certify in writing to the District Project Manager when the system or service is installed, operational in accordance with the specifications stated above, and ready for use. The District will start its acceptance testing. At the end of the acceptance period, upon the District's written acceptance, operations control becomes the responsibility of the District. This constitutes Date of Acceptance.

- 1.6.3 **Contract Duration Pricing.** During the contract term the successful vendor must pass on to the District all discounts and price reductions made available to other customers using similar services. At no point will the vendor be allowed to raise cost above the stated contract price.
- 1.6.4 **Reimbursement of Liquidated Damages.** If the vendor fails to provide a complete and operational system by the specified or otherwise agreed-upon date of completion, the District will receive reimbursement for liquidated damages of \$250 per calendar day until such is provided.
- 1.6.5 **Installation.** Prior to installation of equipment or service, approval of installation plan shall be obtained from the District.
- 1.6.6 **Status of Responses.** The District reserves the right to accept or reject any or all responses and waive formalities or irregularities in the process. A response once submitted shall be deemed final and binding on the vendor, and shall constitute an option with the District to enter into a contract upon the terms set forth in the response.
- 1.6.7 **Incurring Costs.** The District is not liable for any costs incurred in replying to the RFP.
- 1.6.8 **Permission to Proceed.** The vendor must obtain the District's permission before proceeding with any work necessitating cutting through any part of any District building structure.
- 1.6.9 **Payment Schedule.** Vendor shall invoice the District for any one time installation costs after the service has been installed and accepted.
- 1.6.10 **Insurance.** The successful vendor must purchase and maintain insurance to protect the vendor from claims set forth in the following paragraphs that may result from the vendor's operations under the contract, whether the operations be by the vendor, by a subcontractor or by anyone employed by either.

The vendor shall be responsible for all losses that fall under any deductibles on required insurance coverage. If subcontractors are employed, the vendor shall procure and maintain any bodily injury and property damage liability insurance for and on behalf of the vendor for claims and on behalf of the vendor for claims and damages resulting from acts of subcontractors in the same amounts as required for claims and damages resulting from acts of the vendor.

The vendor agrees to indemnify and render the District harmless for any and all claims, demands, damages, actions, or causes of action, to arise against the District by reason of the vendor's performance of the contract. The school district shall be named as an additional insured on the required liability policy. Such insurance shall be acquired for and on behalf of the vendor in pro-

protecting the vendor from claims for damages for bodily injuries, including sickness or disease, death, and for care and loss of services, as well as from claims for property damages, including loss of use, which may arise from operations under the contract, whether such operations by the vendor or any directly or indirectly employed by the vendor. A vendor shall be required, as a minimum, to carry the following insurance coverage and types:

- a. *Commercial General Liability*: Coverage shall have minimum limits of \$1,000,000 each occurrence and \$1,000,000 aggregate combined single limit for bodily injury and \$1,000,000 aggregate combined single limit for bodily injury liability and property damage liability. This shall include premises and operations, independent contractors, products and complete operations, contractual liability, and personal injury liability.
- b. *Business and Auto Liability*: Coverage shall have minimum limits of \$1,000,000 per accident for bodily injury liability and property damage liability. This shall include owned vehicles, hired and non-owned vehicles, and employee non-ownership.
- c. *Property Insurance*: Coverage shall be all risk and shall be in a broad form basis, including coverage for explosion, collapse, and damage in and around facilities. The coverage also must include off site and in transit exposures.
- d. *Worker's Compensations*:
 - *State: Statutory
 - *Applicable Federal: Statutory
 - *Employer's Liability: \$100,000 per accident
 - \$500,000 Decease, Policy Limit
 - \$100,000 Decease, Each Employee

1.6.11 **Independent Contractors.** The vendor and his employees shall **not** be considered employees of the District while engaged in the performance of any work of the District while engaged in the performance of any work or services required herein, and shall be Independent Contractors. Any and all claims that may arise under the Workers Compensation Act of Minnesota on behalf of said employees, and any and all claims made by any third party as a consequence of any act of omission on the part of the work or service provided to be rendered herein, shall in no way be the obligation or responsibility of the District.

1.6.12 **Other Required Contract Terms.** The following other contract terms shall apply.

1.6.12.1 *Indemnifications*: Any and all claims that arise or may arise against the vendor or its agents, servants, or employees as a consequence of any act or omission on the part of the vendor or its agents, servants, or employees while engaged in the performance of this contract shall in no way be the obligation or responsibility of the District. The vendor shall indemnify, hold harmless, and defend the District and its employees against any and all liability, loss, costs, damages, expenses, claims, or actions, including attorney fees that the District and its employees may hereafter sustain, incur, or be required to pay, arising out of or by reason of any act or omission of the vendor or its agents, servants, or employees, in execution, performance, or failure to adequately perform the vendor's obligations pursuant to this contract.

The District shall also be indemnified for any attorney's fees it incurs to enforce this indemnification provision or any other indemnification provision in the contract.

1.6.12.2 *Default*:

- a. *Force Majeure*: Neither party shall be held responsible for delay or failure to perform when such delay or failure is due to any of the following unless the act or occurrence could have

been foreseen and reasonable action could have been taken to prevent the delay or failure:

- * Fire
- * Flood
- * Epidemic
- * Strikes
- * Wars
- * Acts of God
- * Unusually severe weather
- * Acts of public authorities
- * Delays or defaults caused by public carriers

Provided the defaulting party gives notice as soon as possible to the other party regarding the inability to perform.

- b. *Inability to Perform:* The vendor shall make every reasonable effort to maintain staff, facilities, and equipment to deliver the system or service purchased by the District. The vendor shall immediately notify the District in writing whenever it is unable to, or reasonably believes it is going to be unable to, provide the agreed-upon quality and quantity of services. Upon such notification, the District shall determine whether such inability requires a notification or cancellation of the contract.
- c. *Duties to Mitigate:* Both parties shall use their best efforts to mitigate any damages that might be suffered by reason of any event giving rise to remedy hereunder.

1.6.12.3 *Nondiscrimination:* During the performance of this contract, the vendor shall not unlawfully discriminate against any employee or applicant for employment because of race, color, creed, religion, gender, national origin, sexual orientation, disability, age, marital status or public assistance status. The vendor will take affirmative action to ensure that applicants are employed and that employees are treated equally during employment, without unlawful discrimination because of their race, color, creed, religion, gender, national origin, disability, age, marital status, sexual orientation, or public assistance status. The vendor shall also comply with any applicable federal or state laws regarding nondiscrimination.

1.6.12.4 *Access to Records/Audit:* Vendor's books, records, documents, and accounting procedures and practices relevant to the contract are subject to examination by the District and either the Legislative or State Auditor, as authorized by Minnesota Statute 16B.06, subd. 4. Such data are also subject to review by the Comptroller General of the United States, or a duly authorized representative, if federal funds are used for any work under the contract. The vendor agrees to maintain such data for a period of 3 years from the date services or payment was last provided or made, or longer if any audit in progress requires a longer retention period.

1.6.12.5 *Safety:* The vendor will comply with all State and Federal laws as they relate to employee safety, i.e., AHERA, OSHA, Confined Space Entry, Employee Right to Know, Respiratory Protection, NESHAP, Lock-Out Tag-Out, etc.

1.6.12.6 *Tobacco:* No person may smoke or use a tobacco product (1) in any building or upon any grounds owned or leased and occupied by the District, or (2) in any location or facility during any school or District-sponsored education program, activity, or event, regardless of the location of such activity or event. The term "smoke" shall include smoking a cigarette, cigar, or pipe, or carrying a lighted cigarette, cigar, or pipe. The term "use a tobacco product" shall include chewing of tobacco or snuff or the consumption of any other tobacco product.

TITLE: PURCHASE OF NETWORKING EQUIPMENT - FIREWALL

TYPE: Consent

PRESENTER(S): Steve Buettner, Director of Media and Technology

BACKGROUND: As part of a life cycle plan for our critical networking infrastructure, we have approached end of life for our firewall and Internet protection equipment. As part of our erate process, the district conducted a Request for Proposal for Firewall and cybersecurity service. Responses were evaluated based on Cost, Proposed Solution, Vendor Capabilities and Support and Ease of Transition. Purchase will be made July 1, 2021.

RECOMMENDATION: Approve the purchase of Firewall devices and support from CDW for \$74,564.80.

PRIMARY ISSUE(S) TO CONSIDER: This purchase will leverage e-rate funding to upgrade our firewall as well as Application Control, Intrusion Prevention Services, Web Filtering, AntiVirus, AntiSpam, and IP & Domain Reputation protection. With an increase in cyber security threats this service is becoming critical to protect the district from data threats. The proposal provides three years of support.

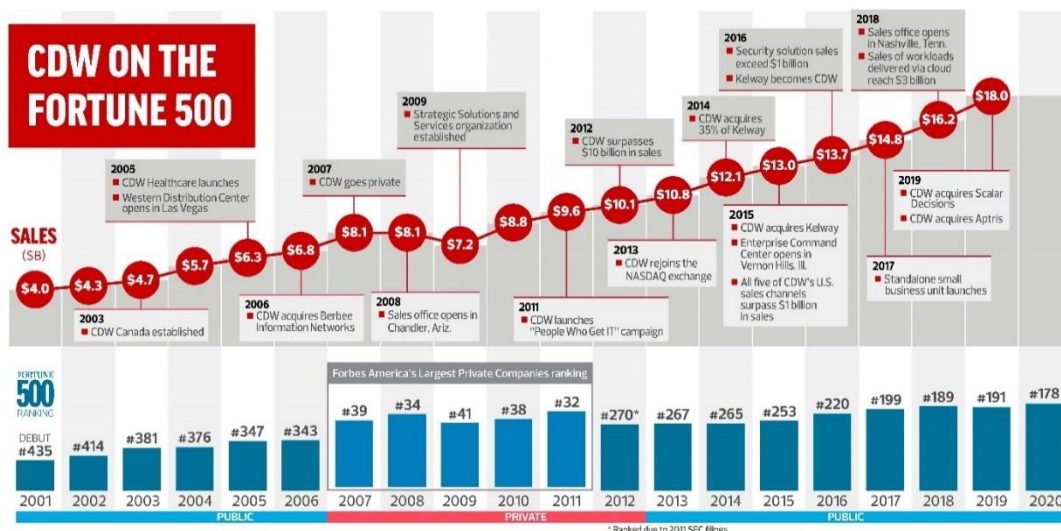

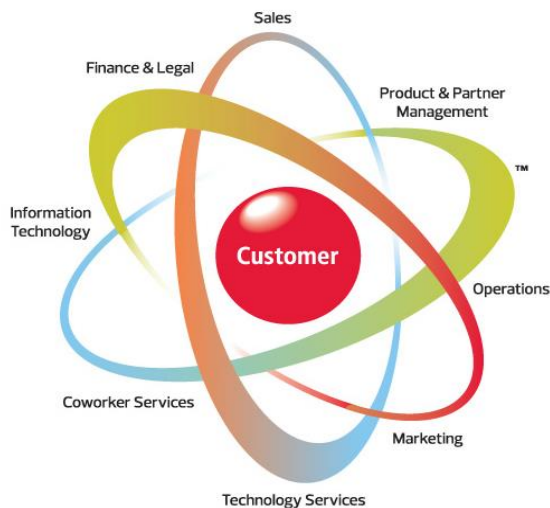

SEPARATE PURCHASE ORDERS SHALL BE SUBMITTED FOR PRODUCTS THAT ARE NOT ELIGIBLE FOR E-RATE FUNDING. ALL ORDERS SHALL BE SUBJECT TO ACCEPTANCE BY SELLER.

C. Assistance with Order

Customer may call 1-800-328-4239 to get assistance on any purchase order. Any terms or conditions stated in or on the Customer's purchase order which are inconsistent with or in addition to the terms and conditions in this Agreement or the Product Sales Terms and Conditions shall not be valid, are considered null and void and shall not be applicable to or binding on Seller.

FOR PRODUCTS WHICH ARE DISCONTINUED AFTER A CUSTOMER ORDER HAS BEEN ACCEPTED BY SELLER BUT BEFORE THE PRODUCT HAS SHIPPED, SELLER WILL MAKE REASONABLE EFFORTS TO OFFER A COMPARABLE OR BETTER PRODUCT AT THE SAME OR LESSER PRICE, IF AVAILABLE, UPON SLP'S APPROVAL OF THE PRODUCT SUBSTITUTION.

4. PRICE AND PAYMENT TERMS

This statement of work (“**Statement of Work**” or “**SOW**”) is made and entered into on the last date that this SOW is fully executed as set forth below (“**SOW Effective Date**”) by and between the undersigned, CDW Government LLC (“**Provider**,” and “**Seller**,”) and EDINA PUBLIC SCHOOLS - ISD 273 (“**Customer**,” and “**Client**,”).

This SOW shall be governed by Seller’s “**SOW Services**,” accessed via the “**Terms & Conditions**” link at www.cdwg.com (the “**Agreement**”). If there is a conflict between this SOW and the Agreement, then the Agreement will control, except as expressly amended in this SOW by specific reference to the Agreement. References in the Agreement to a SOW or a Work Order apply to this SOW.

Seller will provide professional services to assist with the design and implementation of a security solution leveraging the Fortinet security platform.

As part of this project, Seller will perform the following tasks:

 - Configure Ethernet settings and sub-interfaces

Project Plan

Planning

The planning phase consists of the following:

- Project Kickoff – The project team will be chartered, and staff will be assigned to project roles. The team will review Customer’s needs, discuss/revise the project scope and assumptions, and finalize logistical details.
- Inventory Hardware – Seller staff will inventory, document, and hardware power-on test. Issues with faulty hardware, as well as inventory discrepancies, will be identified and resolved.
- Project Planning – Members of the project team will develop a detailed project plan and test plan for the Fortinet Firewall with FortiGuard Services deployment.

Design

Seller will conduct a detailed design session with the project team. The goal of this design session is to identify and address architectural, security, and device management requirements. The design phase consists of the following sub-phases:

- Analysis – Seller and Customer technical staff will work together to:
 - Review network architecture, technical specifications, and VPN requirements
 - Analyze hardware configuration
 - Review industry best practices in order to develop baseline design information.
- Network Design – Seller staff will lead an effort to:
 - Develop the final design
 - Identify all security zones on the network
 - Map security zones to physical and virtual interfaces on the Firewall

- Design site-to-site and remote access VPN considerations
- Documentation – Seller staff will document and diagram the Firewall with Next Generation Services design, including VPN.

Staging

The process for staging, configuring and testing the Fortinet Firewall can be further detailed as follows:

- Unpack the hardware
- Upgrade the Fortigate software to meet the standards specified in the design phase
- Deploy FortiAnalyzer in FortiCloud environment
- Configure existing FortiAnalyzer appliance to support new FortiGate Firewalls
- Install necessary licensing
- Download latest signatures and service updates
- Build the Firewall configuration to the specifications documented in the design phase, including:
 - Firewall security zones/interfaces
 - Apply initial security policies
 - VPN configuration
- Execute the test plan developed during the planning phase to ensure proper design and configuration

Fortinet Firewall Implementation

The process for implementing the Fortinet firewalls can be further detailed as follows:

- During a scheduled change period, the Fortinet firewalls will be placed into production.
- Seller will work with Customer to perform application testing to validate the implemented firewall policy developed in the design phase of this project.
- Remote User VPN connectivity will be tested
- Site to Site VPN connectivity will be tested

The Seller will provide day one support on the first production day following the cutover.

Fortinet Services implementation

The process for implementing the Fortinet FortiGuard Services on the firewall can be further detailed as follows:

- CDW recommended FortiGuard security profiles added in monitor mode
- Tuning of initial security policies will take place to tailor profiles to customer network

Knowledge Transfer

Seller will provide up to 4 hours of knowledge transfer for the Fortigate, FortiManager and FortiAnalyzer solution. Topics include operational tasks, managing security policies and updates.

Project Closure

This phase signifies the end of the project. All services in the Description of Services section of this document are completed and all items to be provided are received by Customer.

Customer Responsibilities

Customer is responsible for the following:

1. Provide a 4 hour maintenance window to allow for the cutover to the Fortinet solution.
2. Configuration of their LDAP environment when integrating with the Fortinet solution. Seller will provide guidance on the required configuration for integration.

3. Customer will provide documentation for required connectivity through the firewall that includes source IP, destination IP, port, protocol information, and network address translation requirements. If traffic analysis is required to determine the appropriate connectivity information; it may result in a revision of the services estimate.
4. Customer is responsible for all change control procedures and notifications that are necessary for the performance of this project.
5. Customer is responsible for application testing performed during cutover(s).
6. Customer will provide full access to all network devices to Seller.
7. Customer is responsible for racking, cabling, and powering of all equipment
8. Customer is responsible for any additional hardware, software, certificates, and licenses that are required for installation.
9. Customer is responsible for interpreting firewall configuration or provide a resource who is familiar with the existing solution
10. Customer will provide at least one (1) domain member computer for installation of the Fortinet Single Sign-On agent to allow for user policy creation.
11. Customer is responsible for distributing any client certificates required for SSL inspection policies

Project Assumptions

1. Customer will provide Seller staff with appropriate physical and network access to implement configurations defined in this statement of work.
2. There is adequate power, UPS, rack space, and network connectivity for the devices included on the bill of materials
3. For the FortiGuard services, Seller will configure up to:

4. Training documentation is not part of this project.
5. For Migration Deployments:
 - a. Firewall configurations will be migrated ‘as-is’.
 - b. Migrations may be manual and/or use Fortinet’s FortiConverter Tool. ***Note – Fortinet Migration Tool only supports limited vendors and limited features within the configuration***
 - c. In addition, Seller will configure no more than 8 Interfaces/Zones.
 - d. In addition, Seller will configure no more than 250 Security Policies.
 - e. In addition, Seller will configure no more than 100 Network Address Translation (NAT) or Port Address Translation (PAT) entries.

GENERAL RESPONSIBILITIES AND ASSUMPTIONS

- Customer is responsible for providing all access that is reasonably necessary to assist and accommodate Seller's performance of the Services.
- Customer will provide in advance and in writing, and Seller will follow, all applicable Customer's facility's safety and security rules and procedures.
- Customer is responsible for security at all Customer-Designated Locations; Seller is not responsible for lost or stolen equipment, other than solely as a result of Seller's gross negligence and willful misconduct.
- This SOW can be terminated by either party without cause upon at least fourteen (14) days' advance written notice.

PROJECT MANAGEMENT

Seller will assign a project management resource to perform the following activities during the project:

Kickoff Meeting. Review SOW including project objectives and schedule, logistics, identify and confirm project participants and discuss project prerequisites.

Project Schedule or Plan. A project schedule that details the schedule and resources assigned to the project. The schedule should align with the estimated project duration as established in the Project Scheduling section.

Status Meetings and Reports. Status meetings will be conducted on a regular cadence schedule based on agreement with stakeholders, the estimated project duration and budget available. During these meetings, the Seller and you will discuss action items, tasks completed, tasks outstanding, risks, issues, key decisions and conduct a budget review.

Change Management. When a change to a project occurs, the Seller's project change control process will be utilized.

Project Closure. Once verbal scope completion is confirmed, a written Project Closure Acceptance will be provided for client to formally acknowledge. If desired, the project team will meet to recap, answering any questions address project transition activities and next steps.

Project Management

A Project Manager is assigned and provides the following:

- Coordinates and facilitates kickoff, status (at agreed upon intervals) and close out calls
- Documents and distributes meeting notes/action items for all calls
- Creates and distributes escalation and contact lists
- Conducts regular status meetings to proactively identify any issues that may arise in order to mitigate risk
- Facilitates any necessary change orders and administrative tasks as necessary
- Monitors project scope and expectations
- Identifies and manages project risks
- Monitors the status and progress of the project and the quality of items provided
- Communicates at regular intervals, as agreed upon
- Acts as the main POC to customer, if requested

Ensures project timelines, dependencies, budgets and closure are met within the project lifecycle

CONTACT PERSONS

Each Party will appoint a person to act as that Party's point of contact ("**Contact Person**") as the time for performance nears and will communicate that person's name and information to the other Party's Contact Person.

Customer Contact Person is authorized to approve materials and Services provided by Seller, and Seller may rely on the decisions and approvals made by the Customer Contact Person (except that Seller understands that Customer may require a different person to sign any Change Orders amending this SOW). The Customer Contact Person will manage all communications with Seller, and when Services are performed at a Customer-Designated Location, the Customer Contact Person will be present or available. The Parties' Contact Persons shall be authorized to approve changes in personnel and associated rates for Services under this SOW.

CHANGE MANAGEMENT

This SOW may be modified or amended only in a writing signed by both Customer and Seller, generally in the form provided by Seller ("**Change Order**"). Services not specified in this SOW are considered out of scope and will be addressed with a separate SOW or Change Order.

In the event of a conflict between the terms and conditions set forth in a fully executed Change Order and those set forth in this SOW or a prior fully executed Change Order, the terms and conditions of the most recent fully executed Change Order shall prevail.

PROJECT SCHEDULING

Customer and Seller, who will jointly manage this project, will together develop timelines for an anticipated schedule ("**Anticipated Schedule**") based on Seller's project management methodology. Any dates, deadlines, timelines or schedules contained in the Anticipated Schedule, in this SOW or otherwise, are estimates only, and the Parties will not rely on them for purposes other than initial planning.

- The following scheduling scenarios that trigger delays and durations to extend beyond what's been planned may require a change order:
 - Site preparation, such as power, cabling, physical access, system access, hardware/software issues, etc. must be completed in a timely manner.
 - Project tasks delegated to customer PMs/Engineers/Techs/Management/Resources must be completed in a timely manner. For example, in the event a project's prioritization is demoted, and customer resources are reallocated causing the project's schedule to extend on account of experiencing interruptions to its momentum requiring complete stop(s) and start(s).

- External projects/dependencies that may have significant impact on the timeline, schedule and deliverables. It is our assumption that every reasonable attempt will be made to mitigate such situations.

TOTAL FEES

The total fees due and payable under this SOW (“**Total Fees**”) include both fees for Seller’s performance of work (“**Services Fees**”) and any other related costs and fees specified in the Expenses section (“**Expenses**”).

Seller will invoice for Total Fees. Customer will pay invoices containing amounts authorized by this SOW in accordance with the terms of the Agreement. Unless otherwise specified, taxes will be invoiced but are not included in any numbers or calculations provided herein. Any objections to an invoice must be communicated to the Seller Contact Person within fifteen (15) days after receipt of the invoice.

SERVICES FEES

Services Fees will be calculated on a TIME AND MATERIALS basis.

The invoiced amount of Services Fees will equal the rate applicable for a unit of a service or resource (“**Unit Rate**”) multiplied by the number of units being provided (“**Billable Units**”) for each unit type provided by Seller (see Table below).

Services Fees of \$23,690.00 is merely an *estimate* and does not represent a *fixed fee*. Neither the Billable Units of 112 nor the Services Fees are intended to limit the bounds of what may be requested or required for performance of the Services.

The rates presented in the table below apply to *scheduled* Services that are performed during Standard Business Hours (meaning 8:00 a.m. to 5:00 p.m. local time, Monday through Friday, excluding holidays). When Seller invoices for scheduled Services that are not performed during Standard Business Hours, Services Fees will be calculated at 150% of the Unit Rates. For any unscheduled (i.e., emergency) Services performed at any time of the day, Services Fees will be calculated at 200% of the Unit Rates.

Any non-Hourly Units will be measured in one (1) unit increments when Services are performed remotely or at any Customer-Designated Location(s) (as defined below).

Any Hourly Units will be measured in one (1) hour increments with a minimum of one (1) hour billed each day Services are performed remotely and four (4) hours billed each day Services are performed at any Customer-Designated Location(s). When Hourly Seller personnel must travel more than two (2) hours a day to work at any Customer-Designated Location(s), there will be a minimum of eight (8) hours billed for each day (less travel time that is invoiced pursuant to the “Expenses” section below).

Upon notice, Seller may adjust the rates below, provided that the rates will remain fixed for at least six (6) months after the SOW Effective Date and then again for at least six (6) months after any subsequent adjustment.

The rates below only apply to Services specified in this SOW as it may be amended by one or more Change Order(s).

EXPENSES

When Seller’s personnel are located more than 60 miles from the Customer-Designated location, travel charges will apply. It is the bidder’s sole responsibility to ensure that its RFP is received before the RFP deadline. In accordance with Government Code Section 53068, any bid received after the scheduled closing time for receipt of RFPs shall be returned to the bidder.

Proposals shall be submitted on the prescribed Bid Form, completed in full. The RFP must conform to and be responsive to all Contract Documents. All bid items shall be properly and legibly filled out. Numbers shall be stated both in words and in figures where so indicated, and where there is a conflict in the words and figures, the words shall govern. The signatures of all persons shall be in longhand. Prices, wording and notations must be in ink or typewritten.

3. SIGNATURE

All signatures on the following documents are required to be submitted.

4. MODIFICATIONS

Changes in or additions to any of the bid documents, the summary of the work bid upon, or the alternative proposals, or any other modifications which are not specifically called for by the Owner, may result in the Owner’s rejection of the bid as not being responsive. No oral or telephonic modification of any bid will be considered. However, prior to the opening of bids, a telegraphic modification signed by the bidder and postmarked and received prior to the opening of bids, may be considered if included with a bid.

5. ERASURES, INCONSISTENT, OR ILLEGIBLE BIDS

In the event the District determines that any bid is unintelligible, illegible, or ambiguous, the Owner may reject the bid as not being responsive.

6. EXAMINATION OF CONTRACT DOCUMENTS

At its own expense and prior to submitting bids, each bidder shall examine all documents relating to the project, visit the site, if applicable, and determine the local conditions which may in any way affect the performance of the work, including the general prevailing rate of per diem wages and other relevant cost factors. Each bidder shall be familiar with all federal, state, and local laws, ordinances, rules, regulations, and codes affecting the performance of the work, including the cost of permits and licenses required for the work.

7. WITHDRAWAL OF PROPOSALS

Any bid may be withdrawn, either personally, by written request, or by telegraphic or email request confirmed in the manner specified above for bid modifications, at any time prior to the scheduled closing time for receipt of bids. No bidder may withdraw any bid for a period of 60 days after the award of the contract.

nor shall any oral interpretation be binding by the Owner. If there are discrepancies on specifications, or conflicts between specification, terms or conditions, the interpretation of the Owner shall prevail. Bidder shall become familiar with the plans, specification, and drawings.

SUBMISSION OF A PROPOSAL WITHOUT REQUESTING CLARIFICATIONS SHALL BE INCONTROVERTIBLE EVIDENCE THAT THE BIDDER HAS DETERMINED THAT THE PLANS, SPECIFICATIONS, AND DRAWINGS ARE SUFFICIENT FOR BIDDING AND COMPLETING THE WORK, THAT BIDDER IS CAPABLE OF READING, FOLLOWING AND COMPLETING THE WORK IN ACCORDANCE WITH THE PLANS, SPECIFICATIONS, AND DRAWINGS, AND THAT THE PLANS, SPECIFICATIONS, AND DRAWINGS FALL WITHIN AN ACCEPTABLE STANDARD FOR THESE ITEMS, AND THAT BIDDER AGREES THAT THE PROJECT CAN AND WILL BE COMPLETED ACCORDING TO THE OWNER'S TIMELINES FOR DELIVERY OF THE ITEMS.

10. BIDDERS INTERESTED IN MORE THAN ONE PROPOSAL

No person, firm, or corporation shall be allowed to make of file or be interested in more than one bid for the same work unless alternate bids are specifically called for by the Owner. A person, firm, or corporation that has submitted a sub-proposal to a bidder, or that has quoted prices of materials to a bidder, is not disqualified from submitting a proposal or quoting process to other bidders or submitting a bid on the project.

11. AWARD OF CONTRACT

(a) The Owner reserves the right to reject any or all proposals, or to waive any irregularities or informalities in any bids or in the bidding process.

(b) If made by the Owner, award of the contract will be by action of the governing board or other governing body to the responsible bidder with highest points awarded. In the event an award of the contract is made to a bidder and that bidder fails or refuses to execute the Purchase Contract and provide the required documents within the time required, the Owner may award the contract to the next responsive and responsible bidder or release all bidders. An election by the Owner to reject all bids does not release the bid security of any bidder who has previously been awarded the contract and failed or refused to execute the Purchase Contract and provide the required documents.

By submitting a bid, each bidder agrees that in determining the successful bidder and its eligibility for the award, the Owner may consider the bidder's experience, facilities, conduct, and performance under other contracts, financial condition, reputation in the industry, and other factors relating to or which could affect the bidder's performance of the project. 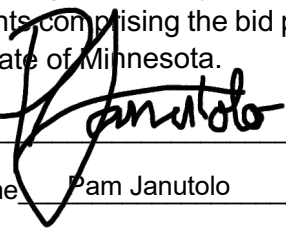

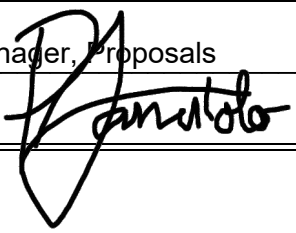

BACKGROUND: As part of a life cycle plan for our critical networking infrastructure, the plan is to leverage e-rate funding to upgrade critical data closet switching gear and provide continuity of service during power outages. This gear will replace UPS (Uninterruptable Power Supplies) that will provide power until a generator or power is restored. Purchase will be made July 1, 2021.

RECOMMENDATION: Approve the purchase of 19 UPS devices and 33 network cards from CDW for \$10,197.00.

PRIMARY ISSUE(S) TO CONSIDER: Because our phone system as well as wireless network are critical components of emergency communications within our buildings, ensuring network switches and routers remain online during power failures is critical. These UPS systems will ensure that critical network gear stays online during a power failure.

PRESENTER(S): Steve Buettner, Director of Media and Technology Services;
John Toop, Director of Business Services

BACKGROUND: The PAY21 property tax levy, which the School Board certified on December 14, 2020, covers the 21-22 school year, and marks the end of the ten-year technology levy. The School Board needs to renew this levy before the next levy cycle in order to maintain current technology funding. The funds from this levy allowed the district to upgrade technology and infuse technology into our instructional practices.

RECOMMENDATION: Provide update on Levy efforts as well as discuss tax impact on households and how the proposed amount compares with other districts

PRIMARY ISSUE(S) TO CONSIDER: The use of technology is pervasive in all aspects of our educational system. From managing our heating, keeping us safe, paying our employees and of course guiding, enhancing and directing our instruction, technology is key. Though the current technology levy has served the district to incorporate technology into these areas, we will need to continue our investment in technology as well as explore other areas of technology use. To ensure we continue to be intentional with the use of technology as well as fiscally responsible the district will discuss the proposed \$500,000 increase in the base levy amount.

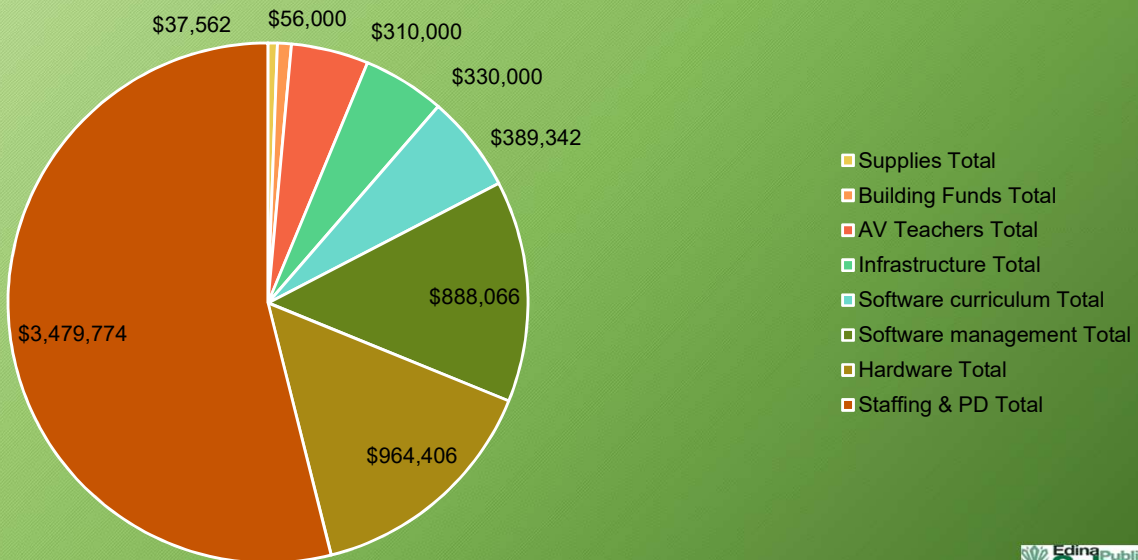

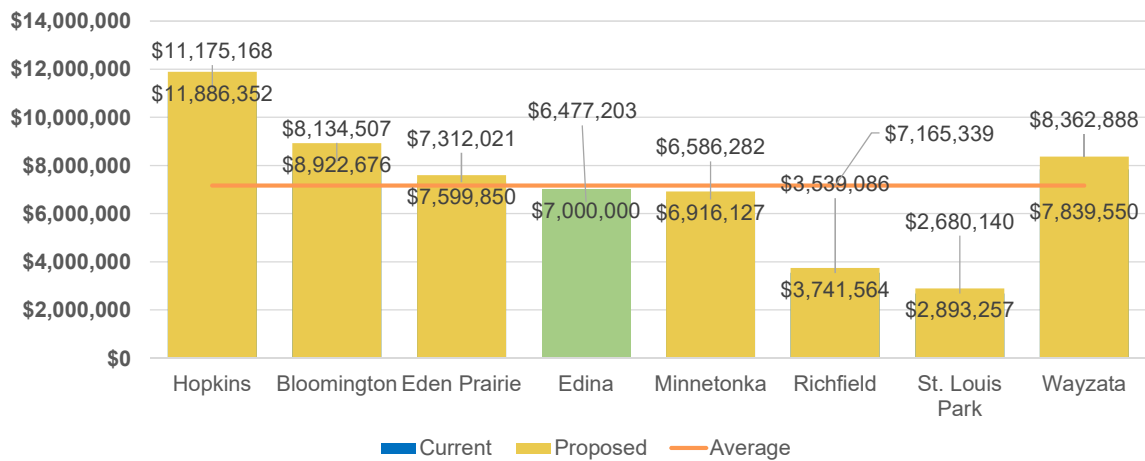
Proposed Annual Spending by Category 7,004,215

Budget Focus

Enrollment (ADM) Parameters

1. A five year weighted average enrollment projection calculation has been used to project future years. This method assumes steady enrollment to a small amount of growth per year. If open enrollment is closed in certain areas of the district, this will influence projections. (Change in enrollment projection methodology, which can change every year based on best projection method.)

2. Pupil Unit Weighting Factors – Pre-Kindergarten (1.0), Kindergarten Handicapped (1.0), Grades K-6 (1.0) and Grades 7-12 (1.2).
3. Average Daily Membership (ADM) increase of 76 and Adjusted Pupil Units (APU) increase of 62.

Revenue Budget Parameters

1. General Education Revenue (GER) amount per APU is at \$6,567 for 2021-22 and 2022-23, the same amount that it was for 2020-21. The base assumption for 2023-24 and beyond is a 1.5% increase. A 1% increase in GER is approximately \$601,172. Most of the GER is for the general operation of the school district and is not designated by the State for a specific purpose. GER is funded by state aid. (No increase in the per student amount is a change from previous years. Previous years projected an increase for future unknown funding years at 1%. The GER per student has increased by 2% each year for the past 7 consecutive years.)
2. Basic Skills Revenue – Basic Skills revenue includes the former compensatory, Limited English Proficiency (LEP), and LEP concentration revenues. While these revenues are combined into a single category, the funding available for Basic Skills revenue is based on existing formulas for the individual components. LEP Average Daily Membership is estimated to be 389. Compensatory revenue is based on October 1, 2020 free and reduced lunch counts. The combined revenue is estimated to be \$567,970.
3. Gifted and Talented revenue is \$13 per APU for 2021-22 which is estimated to be \$119,417.
4. Operating Referendum monies in the General Fund (after LOR subtraction) equal \$1,819 per APU.
5. Local Optional Revenue (LOR) equals \$724 per APU. The LOR is subtracted from the referendum allowance.
6. Equity revenue is calculated by a formula that evaluates the highest paid districts and the lowest paid districts in the state. It is estimated that the district will receive \$65.71 per APU, or \$603,636 for 2021-22.
7. Operating Capital revenue has a component representing the former equipment formula (\$79 per APU), a component representing the former facilities formula (\$109 times the District's maintenance cost index, age of buildings), and a learning year rate (\$31 per APU). It is estimated that the district will receive \$229.40 per APU, or \$2,107,243 for 2021-22.
8. Safe Schools revenue for EPS (\$36) and ISD #287 (\$15) is \$51 per APU for 2021-22 which is estimated to be \$459,389.
9. Special Education Revenue: In 2015-16, the state implemented new special education formulas. There are three calculations for state special education

aids using prior year data. The district receives the lesser of these calculations:

- a. "Old formula" calculations excluding transportation times .62
- b. Districts nonfederal special education expenditures excluding transportation times .50
- c. Census-based calculations times .56

Further, the 2019 Education bill increased funding by \$91 million (cross-subsidy reduction aid), began phase out and subsequent elimination of the state aid growth cap, and reduces the portion of unreimbursed special education costs the serving district can bill back to the resident district from 90% to 85% (FY20) to 80% (FY21 and later).

The estimated Special Education State aid that will be used for budgeting purposes is \$15,045,325, which represents a 2.5% increase from the estimated FY20-21 amount of \$14,678,366.

10. The district participates in the third party billing program. The revenue from this program is estimated at \$115,533 and will pay for the costs of contracted services associated with the program and unreimbursed special education substitute costs.
11. The 2-year grant cycle for the Alternative Delivery of Specialized Instructional Services (ADSIS) program aid is for the 19-20 and 20-21 years. Budget parameters assume maintenance of the ADSIS funding and approval of another 2-year grant. If funding is not approved, appropriate adjustments will need to be implemented.
12. Literacy Incentive Aid estimate is \$506,756.
13. Federal aids are estimated to correspond to federal expenditure increases.
14. Miscellaneous revenues will be approximately the same amount.
15. Gifts and donations revenue will equal gift and donation expense.
16. Interest revenue is based on current interest rates and available cash flow for investments.

Expenditure Budget Parameters

1. Staffing –The 2021-22 staffing base FTE was based on December 1, 2020 estimated ADM calculations. The current estimated actual ADM for 2020-21 was slightly less than projected for the elementary, middle schools and the high school. Staffing may be adjusted according to the Board budget plan to be approved in March 2021. The base long-range plan does not include staffing for enrollment growth.

2. Salaries and fringe benefits are actual amounts for settled contracts. An inflationary increase based on regional and historical trends is planned for non-settled contracts. Total budgeted salaries and benefits for all General Fund staff in 2020-21 is \$97,447,025, prior to FY20-21 budget revision and additions for enrollment growth or reductions. A 1% increase in employee compensation equals approximately \$974,470.
3. Lane changes are estimated at \$200,000, which is based on actual lane changes from the previous year. (Change from \$250,000 to \$200,000 based on number used in EME settlement agreement.)
4. Instructional contingency (Asst. Supt.) of \$50,000, strategic contingency (Supt.) of \$50,000 and special education contingency (Spec. Services Dir.) of \$50,000 to be used at the start of the school year to address student needs and class size concerns. Any additions funded with contingency funds will be for the 2021-22 year only.
5. A three-year history will be used to project gas and electricity costs with consideration given to current utilities rates. Utilities costs are allocated to Food Service and Community Service programs for the calculated portion of their usage.
6. Supply allocations – Allocations are based on projected ADM for 2021-22 with a 1% inflationary increase. These budget allocations are based upon the projected ADM data as of January 1, 2021. Sites are to work with Principals and the Special Services Director to determine appropriate budget amounts for ELL, gifted, and special education at each respective site.
7. Equipment Allocations – Operating Capital allocations are based on projected ADM for 2020-21, building age and square footage.
8. Currently, the district is not anticipating the need to borrow for cash flow purposes. The district will continue to monitor state budget forecasts and legislative activity for potential impact to cash flow.
9. Purchased services, supplies, and miscellaneous expenditures will increase by 1%.
10. Federal program, alternative compensation and integration expenditures equal appropriate program revenue.
11. Staff Development expenditures will equal 2% of GER.
12. Substitute budgets and overtime budgets are based on prior year's history of costs.

13. Annual Other Post Employment Benefit (OPEB) costs are estimated to be \$875,000 per year. (The last 2 years actual amounts have been \$752,088 and \$915,707.)
14. Reduction of one-time expenditures added in 2020-21 with contingency funds.
15. Reduction of one-time enhancements added in 2020-21.

New Course Proposals:

- ***Physical Earth Science***

The purpose of this new course is to ensure Alignment with new MN State Science Standards. The course will be offered in 2021-22 at Middle School and in 2022-23 at the High School.

Course Title - **Physical Earth (Or Earth Science)**

Prerequisites - Completion of 8th grade Science standards

Grade - 9th grade (Or Compacted 8th grade, implemented 2021/2)

Length - Full-year, S1 and S2

Meets Requirements for - Earth Science

Out of class work - Frequently

Fee - None

Course Description: This year-long course focuses on Earth Science standards. Students will engage in science practices as they learn about mechanisms and phenomena on Earth and in space. Space science topics include solar systems, laws of gravitation and planetary motion, the Big Bang Theory, and the composition of stars. The course explores Earth's atmosphere and water, including air compositions and circulations, the carbon cycle, the greenhouse effect, oceans, and wetlands. Students will also learn about geology topics, including rock formation, volcanic and tectonic activity, and wave propagation (earthquakes).

- ***Unified ACE & Creative Foods (Club Buzz)***

The purpose of this class is to align it with the Creative Foods class and Peers Insights group from South View which promotes inclusion. The goal is to streamline Peer Insights districtwide and to connect to the concept that has been implemented and that has successfully evolved.

Course Title - **Unified ACE & Creative Food (Club Buzz)**

Prerequisites - None

Grade - 9, 10, 11, 12

Length - Semester, S1 and S2

Meets Requirements for - Elective

Out of class work - Minimal

Fee - None

Course Description: This course is designed to increase the student's skills in basic food preparation. Emphasis is on practical experiences of cooking and nutrition. Labs include breads, main dishes, side dishes, cakes, desserts and snacks

This is specifically an inclusive/unified class that promotes two evidence-based teaching methods of peer modeling and community-based instruction (skills correlate to Creative foods units), both needed to function as an independent adult in the community that

surrounds us. This class will include connecting peer models with students with developmental and cognitive disabilities in community-based instruction activities. The class will provide opportunities for social interactions, meaningful connections, and inclusion while teaching students important life skills such as cooking, budgeting, shopping, and healthy lifestyle choices.

Semester One Report Card for Distance Learning 2020-2021

New Information in Response to Board Discussion on 1.4.2021

In response to the questions for Elementary Grading, specifically providing grades for Kindergarten in relation to the report card and narrative learning descriptors prior to the end of the year, we have engaged in more conversations with Elementary Principals and Kindergarten Teachers and will be developing a plan to do this sometime in March. We will be collaborating on the details of when and how over the next couple of weeks.

Background Process:

Throughout the month of December, Elementary staff met on Wednesday's during designated Cross District Collaboration meetings to talk about progress reporting for semester one in order to ensure consistent and accurate report card communication in January. The meetings were organized by grade level and specialist area. At each meeting there was representation of staff from every building, including EVA. In addition, an Elementary Dean, Assistant Principal, or Instructional Support staff supported conversations and listened to feedback. The facilitators then met on a weekly basis to share insights and build agendas for future meetings.

Emerging Themes:

In each grade level meeting the facilitators reported that the conversation around the quality of instruction that has occurred thus far this year was remarkable. The opportunity to hear our teachers discussing what they have taught and what could be used as benchmarks to determine a level of understanding of what has been taught for each student was affirming. In the meeting conversations the facilitators recognized the dedicated efforts of our instructors to provide educational excellence despite challenging and changing situations. In the meeting conversations our teachers acknowledged that a primary responsibility of any school is communication about the achievement status of students to parents. That being said, complying with Emergency Executive Order 20-82 and the MN Safe Learning Plan has created some challenges related to reporting. The challenges are:

- 1) The fall semester began later than planned while teachers planned for hybrid and EVA learning models along with another disruption in November while planning for distance learning.
- 2) As a result, the amount of in person learning was reduced from a typical school year.
- 3) With a reduction in the amount of learning time available this year compared to a typical year, the amount of material presented in some content areas was similarly reduced. Our instructional focus areas have been Literacy, Math, and Social and Emotional Learning (ICCAR Values).
- 4) Some aspects of assessment in a hybrid and/or virtual environment can be difficult (e.g. level of student independence in completing work) and/or not recommended as best practice by some assessment vendors (e.g. FastBridge, NWEA MAP, etc.)
- 5) Each student and family will experience learning differently this year depending on their environment, ability to access resources, and level of pandemic related stress.

Differences in Semester One Elementary Report Card:

Due to the challenges listed above, there are some differences that will be reflected in the Semester One Elementary Report Card. They are:

- Instruction (in person and asynchronous) and grading focused most heavily on collecting artifacts and evidence of learning in Math and Literacy
- N/A means “Not Assessed at this time”--this means that students have been learning in these content areas, but there may not have been enough concrete evidence of learning at this point in the school year to determine an exact level of mastery
- The numeric scale (4, 3, 2, 1) on the report card offers just one of the many ways to measure and communicate mastery along with comments, teacher feedback on student work, conferences and contacts with your student’s teacher(s)

Grade 1- 5 Semester One Report Card Specific Decisions:

- In Grades 1- 5 the report card line items and scale (4, 3, 2, 1) will remain the same.
- Every grade level, across each learning model will be consistent in the line items that will be graded.
- Line items in Mathematics, English Language Arts, and ICCCAR Values will be marked closely matching what would be marked in a typical year at this time.
- Science/Social Studies/Health will be marked using NA.
- Music, Art, and Physical Education will be marked using NA and comments will be shared that include:
 - What standard was covered?
 - What was done to cover it?
- Edina teachers are dedicated to the progress of our students and are prepared to share additional information about their progress with families at any time.

Kindergarten Semester One Report Card Additional Decisions;

- Math, English Language Arts, and ICCCAR Values will have a Narrative Statement that explain what learning experiences students were exposed to in semester one. This Narrative Statement will be shared with parents as a cover letter to the report card.
- All line items will be marked NG: Not Graded.
- Teachers will comment in the comment section for Math, English Language Arts, and ICCCAR Values on a positive about the student’s learning and an area for growth in relation to the narrative statement descriptors.
- Music, Art, and Physical Education will be marked using NG and comments will be shared that include:
 - What standard was covered?
 - What was done to cover it?
- Edina teachers are dedicated to the progress of our students and are prepared to share additional information about their progress with families at any time.

Narrative of English Language Arts, Mathematics, and Social & Emotional Learning

Descriptors:

A highlight of the learning your child has experienced this year

English Language Arts:

Using our “Collaborative Classroom” curriculum, we covered the following concepts during our first semester:

- Identifying letters, letter sounds and concepts of print
- Isolating sounds in words, & blending and segmenting syllables and sounds and in words (Phonemic awareness skills)
- Listening and responding to key details in stories, making text-to-self connections, and retelling the beginning, middle and end of stories
- Vocabulary development & introduced semester 1 sight words
- Communicating opinions, information and stories through drawing, dictating and writing
- Reading emergent level text with purpose and understanding

Mathematics:

Using our “Math in Focus” curriculum, we covered the following concepts during our first semester:

- Number sense (one more/one less, ordering, sequencing, one-to-one correspondence, and representation of numbers 0-20.)
- Number identification and counting
- Spotting differences and comparing attributes
- Comparing and ordering based on different attributes (size, weight, shape, length...etc)
- Composing and Decomposing Numbers to 5
- Identifying 2-dimensional and 3-dimensional shapes
- Creating, identifying and extending patterns

Social Emotional & Learning: ICCAR Values

The primary focus in kindergarten is to stay connected with families and students; teach students how to be successful members of our classroom community; and help students feel supported, cared for, safe and secure.

Using a variety of research based curriculum materials, we covered the following skills during our first semester:

High School students

- An Incomplete (I) should be entered for students who have incomplete work but are working with their assigned teacher to complete assigned work.

- No Grade (NG) will be entered for a student who did not complete enough acceptable work throughout the semester to receive a grade at this time; a grade of NG earns no credit. An NG will not impact a student's GPA.
- In addition, High school students will have the opportunity to turn one or more of their *passing* letter grades this semester to a "P" or Pass. This option will be available AFTER grades are posted. Students applying to change a grade to a "P" should fill out [this form](#) after grades are posted at the end of the semester. A P will not impact a student's GPA.
- Students who are currently seniors and who earned a final grade of NG in a course required for graduation will need to enroll in credit recovery at the high school to graduate in 2021; please connect with your school counselor to enroll in credit recovery.

- In addition, High school students will have the opportunity to turn one or more of their *passing* letter grades this semester to a "P" or Pass. Notes: This report shows General Fund expenses excluding Operating Capital and Long-Term Facilities Maintenance expenses. Those expenses are excluded due to their volatile nature and restricted funding purposes. Excluding these expenses gives a truer picture of where General Fund expenses are at the end of a given month in relation to the fiscal year-end. The District should always have a gap in the amount it is into the fiscal year versus the current month fiscal to-date expenses. For example, when the report is for the end of Dec 31 ,2020 the District is 50% into the fiscal year. District expenses should be less than the amount the District is into the fiscal year, by anywhere from 8-13%, due primarily to teaching staff not being paid their first paycheck until 9/15. Also, the majority of teaching staff spread their paychecks out over 24 pay periods, resulting in a large expense in June when we "pay off" or expense all of the remaining paychecks at the end of the fiscal year. Expenses at the same point in time for the previous two fiscal year's are also provided for comparison purposes.

Dear Superintendent Schultz and Chair Allenburg,

Thank you for your letter dated December 15, 2020. Governor Walz has asked us to respond on his behalf. We first want to acknowledge all of the work that you and your team have done to support your students and keep our communities safe during this pandemic. We agree about the myriad challenges all students face with distance learning, especially around the needs of our most underserved students, including those receiving special education services and English language learners. We have emphasized flexibilities in serving these students in person where possible in several executive orders. We, with our other state partners, continue to listen to students, families, educators, and our schools to look to how to improve the teaching and learning environment during the pandemic. Again, this work has been challenging, and we appreciate your focus on solutions that will improve students' academic success and emotional well-being, while keeping both students as well as school staff safe.

The [Safe Learning Plan](#) was developed to prioritize safe in-person learning for students by taking a localized, data-driven approach, recognizing that the needs of each school community are different. Step five of the Safe Learning Plan has always encouraged our districts, in consultation with Regional Support Teams, to consider more factors than cases per ten thousand alone when determining the most appropriate learning model for a school community, including close contacts, quarantines, community spread, and ability to effectively implement health and safety protocol. Recent updates to the Safe Learning Plan will provide increased flexibility for local decision making as all elementary schools may choose to phase their students into in-person learning with additional mitigation strategies beginning January 18, 2021. Returning more students to in-person learning will also help ease the pressure on schools to provide child care. We will continue to work with and follow the professional advice of the Minnesota Department of Health (MDH) when developing guidance that ensures our students, teachers, and school community are safe and supported.

Beginning January 4, 2021, robust testing operations will be launched at schools for all staff on a biweekly basis. The free testing for educators at the beginning of the pandemic was created using federal funds. Testing is now available for free for all Minnesotans at over 300 community testing sites across the state. We hope these scheduled testing opportunities will provide continued support to our schools next semester. We would like to thank Edina Public Schools for your leadership and proactive movements to support and promote COVID-19 testing.

We share your earnest request that teachers and school support staff be prioritized for vaccine distribution. The Governor has communicated that in Minnesota, we will follow three principles when guiding our distribution of the vaccine:

1. Immunize for impact and maximizing immediate health benefit, reduce death and serious illness, and minimize the harm created by COVID-19.
2. Equitable distribution and access, making sure no procedural or structural issues impact access to the vaccine among any particular group or population. And we want Minnesotans in every corner and every community to know they can trust the process, the safety, and the effectiveness of the vaccine.
3. Transparency and sharing information as quickly as possible with Minnesotans.

As you may know, the Federal Advisory Committee on Immunization Practices (ACIP) recently issued new recommendations on phase 1b to include frontline essential workers and people age 75 and older. Included in these frontline essential workers are those working in education. As with phase 1a recommendations from the federal government, MDH will be convening the Minnesota Vaccine Allocation Advisory Group together again to help make recommendations for sub-prioritization as we will not immediately be able to vaccinate everyone who falls into these groups. MDH hopes to have allocation recommendations for phase 1b the week of January 18.

Congress voted this week on a new emergency relief bill, which includes \$82 billion for education. This is in addition to the over \$30 billion that was passed as part of the CARES Act last spring, of which Minnesota received \$173.5 million for K-12 education. We will communicate more details about Minnesota's allocation of the new federal funds as they become available. We also hear your suggestion for more state funding to come through, and will keep this request in mind when Minnesota legislative session begins on January 5, 2021.

Finally, we share the view that all students deserve a high-quality education and that we must work tirelessly to ensure their academic success is not hindered by the pandemic. We are listening to students, parents, communities, and schools on these issues. Both near and long-term solutions will require creative thinking to address this anticipated need for our children. We are open to hearing more about specific ideas that you have.

Thank you again for your letter and your leadership. We look forward to continuing to partner with you to serve Minnesota's students.
