Concetta Lewis provide an Early Childhood Special Education (ECSE) update which included:

- Program and Services overview
- Classrooms
- ECSE Team

Board discussion included: clarification on how children are identified for the Great Start Readiness Program (GSRP); how many GSRP classrooms the district has; how staffing (or lack thereof) impacts enrollment at Caring Steps; disaster relief grants/funding; breakeven FTE; comparison survey of other centers; demographics; average salary for childcare workers and tuition comparison; breakeven profit; how students are chosen to be in either a blended or traditional classroom and respective class sizes; appreciation for these programs that allow opportunities for a quality education; and success kids have from these early programs.

B. MTSS and Learning Pathways

Karen Gelardi and Tiffany Goliday provided an overview on the Multi-Tiered Systems of Support (MTSS) which included:

Pasquale Cusumano and Brian Shelson further reviewed Tier 1, highlighting the high-quality teachers, world-class instruction and innovative learning environments.

Neil DeLuca, Tracye Schwartz, and Christy Clement went on to discuss Tier 2 indicators and interventions.

Jeff Fosnaugh shared his passion as an educator, particularly for those in Tier 3.

Adrean Bedard and Paul Kennedy reviewed the Virtual Campus' online platform levels of support as well as personal ways they have supported students.

Board discussion included parental input on tiered support for their child; clarification on whether or not students know what tier they are in; reading recovery; the purpose of changing the graphic of different tiers of support; clarification on whether or not RCS created the graphic; (for Paul Kennedy) challenge on the transition to teaching virtually and takeaway; acknowledgement of the 702 teachers with master's degrees;
