#### **Call to Order**

A Work Session, open to the public, of the Board of Education for Rochester Community Schools, Rochester, Michigan, was held virtually on Monday, January 25, 2021, via Zoom Webinar and YouTube Live. #### **Work Session**

# A. Return to Learn Update

Debi Fragomeni, Cory Heitsch, Carrie Lawler, Concetta Lewis, Dave Murphy and Beth Davis reviewed the timeline through present day. Cory and Debi went on to review the following items: COVID-19 Summary for Oakland County; Oakland County Health Division (OCHD) Oakland County Schools Weekly Report; Michigan Department of Health and Human Services (MDHHS) and OCHD School Guidance at a Glance; Michigan Guidelines for Operating School Safety; safety protocols; updated MDHHS guidance (spacing, movement, lunch, cleaning, and quarantining); MI Safe Schools rationale; evolution of state and county guidance; athletics update; antigen testing in partnership with the Michigan High School Athletic Association; building resources; OCHD drive through testing sites; COVID-19 vaccine goal and approval process; OCHD Save Your Spot; five-day in-person learning return dates; Return to Learn Committee update; assessments; scholarly distinctions; no changes to scheduled breaks in school calendar; new RCS website; and a summary of recommended timeline.

Board discussion included: why the MDHSS matrix is now obsolete (which became obsolete prior to the variant strain being reported in MI); factors for moving from/to remote/in-person instruction; factors that may require one building to close/quarantine; prioritizing schools means shutting down the community before closing schools again; PPE (face masks and Plexiglas barriers); elementary specials and limiting movement between classes; antigen testing; how many staff members have been vaccinated to date; classroom and cafeteria capacity with spacing requirements; para support; phase-in process; quarantine procedure once back to full-time instruction; the things within control that RCS is most optimistic about as well as what posts the biggest challenge; appreciation for opening schools in a thoughtful manner; the importance of mitigation protocols; appreciation for committee work and the RCS team; accommodations for teachers with concerns; substitute availability in buildings; preparations for the fall; whether the Virtual Campus will have any changes as in person learning returns; and how to address those families who are apprehensive about returning to in-person learning.

Cabinet members addressed the Board to answer their questions.
