Dear Scarborough School Community,

Scarborough Public Schools is fully committed to having our staff and students return to full-time, inperson learning for the Fall 2021! At last night's School Board meeting, I shared with the Board (presentation is linked here - beginning on slide 5) the work and planning that has been done so far to begin this roll-out for the fall, and explained why we are not able to have our students return any sooner. It will be a major undertaking for this to happen - mostly the repurposing of space so that we adhere to the CDC's guidelines, and the hiring of 17 additional staff - but we are fully determined to be prepared for the fall.

Assisting us with our preparations, are the members of the Fall Reopening Taskforce. Each phase level has created a team of staff and parents to help them with this project. We are currently creating a new page on our <u>website</u> where you will be able to follow their progress as they will be posting their meeting notes. Each taskforce has scheduled weekly meetings throughout the months of May and June. I would like to thank each of the team members for taking time out of their busy schedules and dedicating themselves to this very important work.

Like you and your families, we are all looking forward to some sense of normalcy. With the return to inperson learning - we believe this is a huge step in the right direction!

Mask Guidance Reminder

As a reminder, the Maine Department of Education made a change to their mask requirements effective on 4/28/2021 and was included in the <u>DOE's PK-12 and Adult Education Public Health</u>

<u>Guidance</u> document, which is Maine's CDC Guidance for schools.

- Adults, including educators and staff, are required to wear a mask/face covering **when indoors.**
- Students age five and above are required to wear a mask/face covering that covers their nose and mouth **when indoors**.
- Students and adults may be unmasked outdoors when 6 feet distance can be maintained.



This is very similar to the DOE Framework that was in place at the beginning of the school year. What does this mean for schools? Teachers are able to take groups of students outside for instruction or a mask break, and staff and students can be unmasked during those times, given the caveat that they are 6 feet apart. Face coverings will still be required at recess for staff and students, whereas students generally like to play in close vicinity to one another.

Vaccination Updates - All Maine Residents Ages 12+

All Maine residents age 16 and older are eligible for a COVID-19 vaccine.

As with all changes in eligibility, it will take some time for some vaccine clinics to begin to schedule appointments and administer COVID-19 vaccines. The Pfizer vaccine is authorized for individuals ages 16 and 17, but consent from a parent or legal guardian is required to vaccinate children. <u>Get more information here</u> on vaccinations for 16 and 17 year old Maine residents.

All Maine residents age 12-15, the FDA authorization of the use of the Pfizer vaccine is expected soon. We will continue to keep you posted on any upcoming vaccination clinics as they become available.

FREE Transportation to COVID-19 Vaccination Sites

We have recently just learned that there is <u>free transportation</u> offered to all Mainer's who need a ride to and from a COVID-19 vaccination appointment for people who do not have access to reliable transportation, are unable to drive, or are otherwise unable to travel to their appointment. Before you call to schedule your ride, you **MUST** have a confirmed appointment before you schedule your ride, therefore rides are not available to the walk-in clinics. To schedule your ride, please call Modivcare at 1-855-608-5172 at least 48 hours before your scheduled appointment. Please read this <u>information</u> <u>sheet</u> with the full details of obtaining your ride.

Change in Close Contact Notification Protocols

As the number of positive COVID 19 cases and close contacts have spiked in our community, it has become increasingly difficult for our nurses to continue to make personal phone calls to every affected family. Our nurses spend numerous hours in the evenings and over the weekend tracking cases and reaching out to families, in addition to all of the pressure they are under during each school day. They work as a team, assisting one another as cases come in and share the load. Even so, that sometimes becomes too much.



Moving forward, we will be utilizing robocalls and email notifications anytime there are 10 or more affected individuals in a positive case. We are so appreciative of our nurses for all they continue to do and want to make their work more doable, especially when increased volume happens. At the same time, please know that any and all medical questions that you have are important to us, and our nurses would be happy to have a personal conversation with you when questions arise for you.

Spring Assessment Information

This year, we made several appeals to Maine's Department of Education seeking a waiver from the state testing requirement. **The third and final appeal was made directly to the Commissioner of Education in March and was denied.**



As the assessments themselves are new and the accountability and reporting will look different (they will not be used or reported publicly as they have been in the past, per DOE communication as they currently are seeking a federal waiver for accountability). *Please know that in any case, we will not be using the state assessment data to make instructional or program decisions.* In fact, the MEA Science assessment is an operational field test with no items available from which students can practice other than to learn how to navigate the online assessment.

We will continue to use the i-Ready Diagnostic data this spring to assess growth from fall to spring and identify areas for curriculum improvements for reading and math. As there is overlap with both the state test and i-Ready, we will analyze and compare data from both to determine assessment planning for next year. We are quite concerned about over testing our students both this spring and next year.
