## Curriculum Syllabus

### World Literature/Grade 9

## Course Description:

Students entering High School with a foundation in fiction, drama, poetry, mythology, and literary nonfiction and in 9th grade will continue to study those genres across world literature. Each unit allows for a close study of literary works, the analysis of informational texts, the consideration of historical and cultural contexts, and a focus on specific forms of formal and informal writing. The units explore not only geographical regions and their societies, but also themes and literary forms that pertain to them. Students come to grasp the relationship between local concerns and universal questions. They become aware of the authors' views of literature itself – its forms, peculiarities, language, and relationship to reality. Throughout the year, students take part in seminars, write essays, and engage in group discussions. By the end of 9<sup>th</sup> grade students will be prepared for close readings of American literature and the advanced writing tasks of 10<sup>th</sup> grade.

#### **Key Ideas and Details**

RI.9-10.1. Accurately cite strong and thorough textual evidence, (e.g., via discussion, written response, etc.) and make relevant connections, to support analysis of what the text says explicitly as well as inferentially, including determining where the text leaves matters uncertain.

RI.9-10.2. Determine a central idea of a text and analyze how it is developed and refined by specific details; provide an objective summary of the text.

#### **Text Types and Purposes**

W.9-10.1. Write arguments to support claims in an analysis of substantive topics or texts, using valid reasoning and relevant and sufficient evidence.

A. Introduce precise claim(s), distinguish the claim(s) from alternate or opposing claims, and create an organization that establishes clear relationships among claim(s), counterclaims, reasons, and evidence.

B. Develop claim(s) and counterclaims avoiding common logical fallacies, propaganda devices, and using sound reasoning, supplying evidence for each while pointing out the strengths and limitations of both in a manner that anticipates the audience’s knowledge level and concerns.

C. Use transitions (e.g. words, phrases, clauses) to link the major sections of the text, create cohesion, and clarify the relationships between claim(s) and reasons, between reasons and evidence, and between claim(s) and counterclaims.

D. Establish and maintain a style and tone appropriate to the audience and purpose (e.g. formal and objective for academic writing) while attending to the norms and conventions of the discipline in which they are writing.

E. Provide a concluding paragraph or section that supports the argument presented.

W.9-10.2. Write informative/explanatory texts to examine and convey complex ideas, concepts, and information clearly and accurately through the effective selection, organization, and analysis of content.

A. Introduce a topic; organize complex ideas, concepts, and information to make important connections and distinctions; include formatting (e.g., headings), graphics (e.g., figures, tables), and multimedia when useful to aiding comprehension.

B. Develop the topic with well-chosen, relevant, and sufficient facts, extended definitions, concrete details, quotations, or other information and examples appropriate to the audience's knowledge of the topic.

C. Use appropriate and varied transitions to link the major sections of the text, create cohesion, and clarify the relationships among complex ideas and concepts.

D. Use precise language and domain-specific vocabulary to manage the complexity of the topic.

E. Establish and maintain a style and tone appropriate to the audience and purpose (e.g. formal and objective for academic writing) while attending to the norms and conventions of the discipline in which they are writing.

F. Provide a concluding paragraph or section that supports the information or explanation presented (e.g., articulating implications or the significance of the topic).

W.9-10.3. Write narratives to develop real or imagined experiences or events using effective technique, well chosen details, and well-structured event sequences.

A. Engage and orient the reader by setting out a problem, situation, or observation, establishing one or multiple point(s) of view, and introducing a narrator and/or characters; create a smooth progression of experiences or events.

B. Use narrative techniques, such as dialogue, pacing, description, reflection, and multiple plot lines, to develop experiences, events, and/or characters.

C. Use a variety of techniques to sequence events so that they build on one another to create a coherent whole.

D. Use precise words and phrases, telling details, and sensory language to convey a vivid picture of the experiences, events, setting, and/or characters.

E. Provide a conclusion that follows from and reflects on what is experienced, observed, or resolved over the course of the narrative.

### **Production and Distribution of Writing**

W.9-10.4. Produce clear and coherent writing in which the development, organization, and style are appropriate to task, purpose, and audience. (Grade-specific expectations for writing types are defined in standards 1–3 above.)

D. Respond thoughtfully to various perspectives, summarize points of agreement and disagreement, and justify own views. Make new connections in light of the evidence and reasoning presented.

## Scope and Sequence

### Unit 1

**Unit Summary:** Students will read literature and nonfiction, focusing mainly on determining themes and citing evidence. Students will practice and develop both informative and explanatory writing. Students will conduct discussions and show understanding of overarching ideas by reporting information. Students will show understanding of standard grammar conventions, such as using proper punctuation, maintaining parallel structure, compound and complex sentence structures, and effective use of pronouns. Students will continue to acquire vocabulary through exposure to complex texts and daily practice with discreet lists.

**Reading Text Type:** literary, nonfiction, and informational texts

**Writing Focus:** Routine Writing, Informative and Explanatory, Short Research, Reflection Writing

**Speaking and Listening** Task type: Conduct discussions, Report findings

**Language Skill Focus:** Study and apply grammar in context and practice; Study and apply vocabulary in context and practice

## **Unit 2**

**Unit Summary:** Students will read literature and nonfiction, focusing mainly on how the author structures the text and draws on source material. Students will practice and develop argumentative writing. Students will conduct discussions and show understanding of overarching ideas by reporting information. Students will show understanding of standard grammar conventions, such as how language functions in different contexts.

**Reading Text Type:** literary and informational texts

**Writing Focus:** Routine writing, Argumentative/Persuasive; Research, Reflection Writing

**Speaking and Listening Task Type:** Conduct discussions, Report findings

**Language Skill Focus:** Study and apply grammar in context and practice; Study and apply vocabulary in context and practice

## **Unit 3**

**Unit Summary:** Students will read literature and nonfiction, focusing mainly on point of view, attitude and tone, and the use of figurative language. Students will practice and develop narrative writing. Students will conduct discussions and show understanding of overarching ideas by reporting information. Students will show understanding of standard grammar conventions, such as determining the meaning of unknown and/or multiple meaning words.

**Reading Text Type:** literary and informational texts

**Writing Routine:** Routine writing, Narrative, Research, Reflection Writing

**Speaking and Listening Task Type:** Conduct discussions, Report findings

**Language Skill Focus:** Study and apply grammar in context and practice; Study and apply vocabulary in context and practice

## **Unit 4**

**Unit Summary:** Students will show mastery in the comprehension of both literature and nonfiction. Students will produce well-developed, organized writing. Students will conduct discussions and show understanding of overarching ideas by reporting information. Students will show understanding of standard grammar conventions, such as demonstrating understanding of word relationships and figurative language.

**Reading Text Type:** literary and informational texts

**Writing Focus:** Routine writing, Research/Inquiry-Based Writing Project

**Speaking and Listening Task Type:** Conduct discussions, Report findings

**Language Skill Focus:** Study and apply grammar in context and practice; Study and apply vocabulary in context and practice.

## Assessments

Evaluation of student achievement in this course will be based on the following:

- Expository essay using primary and secondary evidence to support a thesis (3-5 pages minimum with differentiation as necessary)
- Persuasive essay using evidence to support a thesis (3-5 pages minimum with differentiation as necessary).
- Visual/oral presentation on a theme, concept, or issue using digital media
- Narrative piece (3-5 pages minimum with differentiation as necessary)
- Research-driven essay using primary and secondary evidence to support a thesis (4-6 pages minimum with differentiation as necessary).
- Observational data collected by teachers as students are learning
- Formative assessments given by teachers to gauge progress toward each standard
