Athletics	Follow AIA guidelines and quarantine those who are identified as close contacts.	
Bus Safety	Require all students, coaches, faculty/staff to wear a face mask while on a bus when representing NDP.	
Case Counts	Continue to use the dashboard and report cases to our community through the dashboard.	
Cleaning/Disinfecting	Daily cleaning and disinfection of bathroom, classrooms, and touchpoints using approved cleaning	
	supplies. Classrooms will also have individual sanitization wipes for students to use before the start of	
	each class.	
Contract Tracing for	Seating charts are required for all classes. NDP will continue to consult with the Maricopa County Health	
Students	Department and refer to all county and CDC guidelines. Students who are identified as close contacts	
	and vaccinated may present their vaccination card to avoid the required quarantine. Students who wish	
	to test out of quarantine will follow the guidelines for testing on day 6 and returning on day 8 with a	
	negative test.	
Contact Tracing for	NDP will continue to consult with the Maricopa County Health Department and refer to all county and	
Adults	CDC guidelines. Adults who are identified as close contacts will be notified but not required to	
	quarantine unless they develop symptoms.

Quarantine Students	Students in a required quarantine are not required to participate in their classes but will have access to

Events/Field	Large scale events will be monitored and may be reconfigured in order to maintain social distancing

Exclusion Guidelines	Students and staff experiencing COVID-like symptoms should remain home for 10 days unless they meet

Face Coverings	Face coverings are optional unless traveling on a bus.	
Food Services	Regular cafeteria service will continue for break and lunch. NDP will observe social distancing when	
	possible. NDP has provided additional seating inside and outside for all students.	
Hand	Students will be encouraged to wash their hands with soap and water for at least 20 seconds or use	
Washing/Sanitizing	hand sanitizer. Hand sanitizer stations are available in all classrooms. Classrooms will also have	
	individual sanitization wipes for students to use before the start of each class.	
Overnight Trips	All students, faculty, and staff will be required to provide a negative test no earlier than 72 hours before	
	the trip.	
Restrooms	Restrooms will be left propped open during the school day	
School Health	Any student with signs/symptoms suggestive of COVID-19-like illness (Fever of 100.4° F or higher, chills,	
Screenings	cough, difficulty breathing, body aches, headache, new loss of taste or smell, sore throat, congestion or	
	runny nose, nausea/vomiting, diarrhea) will be taken to the health office, and parents will be contacted	
	for pick up. The student will be excluded from school per NDP guidelines unless symptoms are	
	confirmed by a doctor's note to be part of a known condition (such as allergies) or an alternative lab-	
	confirmed illness.	
Shared Belongings	When possible, students use individual belongings. Shared materials will be allowed, but regular	
	disinfection will be encouraged.	
Signs and Messages	Handwashing signs in all school bathrooms will be posted to help remind students to wash their hands	
	properly.	

Social/Physical	Classrooms are arranged to maximize distancing between students in the classrooms. NDP has allowed
Distancing	for 3 ft distancing when possible.
Ventilation Systems	Air filters are changed regularly.
Volunteers/Visitors	Visitors and volunteers will be limited but allowed at this time.

Area of Interest	Tier 2 Mitigation Strategies  Metric: If approximately 3% of our population tests positive at one time, we would move to Tier 3
	All Tier 1 mitigation strategies remain in place, with the following changes and additions
Quarantine Students and Coursework	Students in a required quarantine are not required to participate in their classes but will have access to observe their classes while in quarantine. Students will also have access to Canvas and should review recordings and coursework provided by their teacher. If they need additional assistance, they should contact their teacher via email.

Area of Interest	Tier 3 Mitigation Strategies
	Metric: If approximately 5% of our population tests positive at one time, we would move to Tier 4
	All Tier 1 and Tier 2 mitigation strategies remain in place, with the following changes and additions:
Bus Safety	One student per seat on the bus will be required.
Face Coverings	Face masks will be required for all students, faculty, and staff regardless of vaccination status.
Events/Field	Events/Large gatherings will not be permitted.

Food Services	Food distribution will move outside.
Lunch/Break	Students will be required to sit outside for break and lunch.
Restrooms	Restrooms will be limited to 2 people per restroom at a time. Additional staff will be outside to monitor
	restrooms.
Temperatures	Temperature checks would be required before students, faculty, and staff enter the campus. This would
	also apply to athletes before each practice occurs.
Volunteers/Visitors	Volunteers and visitors will be limited.
