		All persons parking a vehicle on school property will be required to register their vehicle.
		The fee for parking registration will be \$40.00.
		Enforcement of parking violations will be conducted by designated school district employees.
		Parking permits must be displayed and clearly visible at all times in vehicles parked on school property.
		Vehicles violating parking rules may be towed at the owner's expense with no prior warning.
		I understand that parking on school property is a privilege and that my ability to park on campus may be revoked at any time due to disciplinary infractions and/or unsafe driving.
		Vehicles must have insurance coverage with proof required.
		If more than one vehicle is registered to the same family, and will be used, all vehicles must be registered on the application.
		Handicapped spaces are available with proper state permits but still require a parking registration with the school.
		Anyone using these premises assumes all risk of accident, and expressly agrees that the UPSD shall not be liable under any circumstances for any injury to person, loss or damage to property.
		Vehicles parked on school district property are subject to search at any time by school officials. Vehicle searches may be conducted on a random and periodic basis without regard to any suspicion or alleged infraction of school rules.
		Copies of insurance cards, driver's license and vehicle registrations must be attached to the application.
		This parking application is only valid for the 2021-2022 school year.

Dear Parents and Students:

Enclosed please find a parking pass application form. This form must be completed and returned to the school by October 1, 2021. All applications should be completely filled out and returned with a copy of the student's driver's license (permits not accepted), insurance card, registration card. The parking tag fee for the 2021-2022 school year is \$40.00.

Parking on school grounds is a privilege and all students who are eligible for parking registration will receive a parking placard/tag to be hung on the inside rear view mirror of the vehicle while parked on school grounds. Vehicles not displaying the appropriate parking placard/tag will be subject to towing at the owner's expense. Students will lose their privilege to drive and park on school grounds if they violate school RULES or DRIVING/PARKING REGULATIONS which can be found in the Student Handbook.

The parking placard/tag will be good for one school year (September 2021 – June 2022), **unless revoked**. Parents and students should review the Upper Perkiomen School District's parking permit policy, School Rules, and Driving/Parking Regulations prior to completing the parking application form. Once reviewed, the parking application form should be signed, initialed, completed, and returned with copies and fees to the Upper Perkiomen High School Office by October 1, 2021.

NOTE: Students may apply for a parking placard/tag after October 1st, but they are not permitted to park on school grounds until a parking placard/tag is issued.
