- I. CALL TO ORDER: Gordon Oliver Chairman, called the meeting to order at 7:06 PM.

- V. CHAIRMAN'S REPORT: Nothing to report
- VI. RECREATION DEPARTMENT REPORT:
  - A. Sandy Beach: The beach has been operating daily with the expected last day of the season being August 29<sup>th</sup>. The lifeguard staff has been very busy and has worked many hours to keep the beach running for the residents of Ellington.
  - *B.* Summer Camp: The summer camp has exceeded or met full capacity each week. The offering of the free breakfast and lunch program has been very beneficial for most of the families attending this year and Dustin looks to have that budgeted into the camp for the upcoming years.
  - C. Summer Programs: All programs planned for the summer have proceeded as planned.
  - D. Community Garden: The Eagle Scout benches are being installed this upcoming week.
  - E. Fall Programming: Currently the following programs are active for registration: Girls Fall Basketball, Fall Soccer, Winter Youth Basketball, Music and Movement, Jukido, ZUMBA and others. We are still waiting on guidance for indoor programming. We are planning the 2<sup>nd</sup> Annual Robert Tedford 5K Road Race for Saturday, November 13, 2021. The plaques honoring Bob Tedford are planned to be installed into the schools this year. Date still to be determined.
  - F. Crosstown Trails Proposal: There is potential for surrounding towns that this trail will connect to South Windsor, East Windsor and other towns to connect to Hartford. A Potential AdHoc Committee is to be created. The Board of Selectman is still researching this proposal as well as the Planning and Zoning department.

#### VIII. OLD BUSINESS:

The family has reached out to the Recreation Department Director and would like to have their playground located at the Robert Tedford Memorial Park. Dustin is looking to the Recreation Commission for a consensus to continue conversations with the family/foundation on the design and map of the playground proposal.
