


Students in grades 3-5 will be dismissed from the gate located in between the MPR and Right at School Building (CDC).

Social Emotional Learning (SEL) & Inclusion

- <u>Students</u>: Students will participate in regular opportunities for social-emotional learning and will have access to mental health support including individual, group, and family counseling.
 - Students will participate in weekly classroom lessons for all students
 - Students may participate in direct counseling services and programs offered through the counseling programs.
 - Students will engage in an instructional environment designed to help students appreciate diversity



Social Emotional Learning (SEL) & Inclusion

- <u>Parents/Caregivers</u>: Our elementary school and middle school counseling programs provide comprehensive resources for parents, students, and teachers on their websites. This includes back-to-school support.

In-person Instruction

Students enrolled in full-time, in-person instruction can expect:

- A return to full-time instruction, with schedules matching those from before the pandemic
- To wear masks at all times indoors
- To complete the daily COVID-19 screening test required for entry to campus, sent to parents/caretakers each day
- Comprehensive health and safety protocols employed at each school site

Long Term Independent Study Program



- Per the California Department of Education Assembly Bill 130 (AB 130), WUSD is required to provide an alternative to in-person classroom instruction for students whose health would be put at risk during the 2021-2022 school year due to the ongoing COVID-19 pandemic.
- 40-50 total students (2% of student population) opted into the program, pending further discussions with their school site



Long Term Independent Study Program



Students enrolled in the WUSD independent study program will:

- Access online curriculum in all subjects through an online learning resource.
 Learning will be independent with support provided online based on grade level.
- Kindergarten to grade 3: Participate in daily synchronous instruction* throughout the school year.
- Grades 4 to 8: Participate in both daily synchronous interaction* and weekly synchronous instruction* throughout the school year.
- Families asked to commit to full semester(s) of independent study.
- All students have the option to return to in-person instruction for the 2021-22 school year.
- Families required to conference with school administrator prior to student enrolling in ISP and sign a written learning agreement.

^{*&}quot;Synchronous interaction/instruction" means designated small group or one-on-one instruction in the form of internet/ZOOM or telephonic communications between the teacher or instructional aide and student(s).





Short Term Distance Learning Model

- Per standard guidance for isolation at home after close contact, the classroom where the COVID-19-positive individual was based may need to close temporarily as students isolate.
- During the isolate at home period the school site will provide a plan for continuity of education with online schedules matching those of a regular school day, social services and meal program as needed, and alternate mechanisms to support student in quarantine.
- WUSD has proactively purchased ZOOM accounts for all teachers and administrators and continues to provide access to learning resources online through Google Classroom, Canvas at the middle school level, and the CLEVER single sign on portal for all online learning programs.

Health and Safety





Health and Safety

While the variants may change, the typical recommended strategies to fight COVID-19 remain effective and widely available.

At Wiseburn, we will employ them all in combination:

- 1. Masks
- 2. Ventilation
- 3. Vaccines
- 4. COVID-19 Testing
- 5. Limiting indoor crowding where possible



Masks





Masks

- Masks continue to reduce transmission of COVID-19, including the Delta variant, per the CDC.
- Per state and local directives, indoor masking is required for everyone at K-12 schools regardless of vaccination status. Students, staff and visitors must wear masks inside our schools.
- Some limited exceptions apply: Students granted a reasonable accommodation in the form of mask exemption due to a disability or other condition are not excluded from in-person education. However, it is strongly recommended by the LADPH that these students be tested for COVID-19 weekly.
- Students who do not comply with the masking requirement will be offered an opportunity to join our Independent Study Program. They will not be allowed on campus.
- Outdoor masking is recommended, but we will use this time to also allow students to take mask breaks, especially while eating/drinking.
- Per LADPH, physical education classes held indoors requires all present to wear masks except when drinking water.



Ventilation





Ventilation

- COVID-19 spreads through the air. To combat COVID-19, the CDC, recommends using filtered ventilation systems.
- In March 2021, we installed state-of-the-art air purifier systems that are connected to our current HVAC systems in all 150 classrooms, office spaces, and multi-use rooms.
- These air purifiers are similar to those used to disinfect air in airplanes, and they will be active and providing continuous disinfection in our classrooms.
- Our HVAC systems are routinely maintained. Air filters on air conditioning units will be replaced every three months.



Vaccines

Vaccines

- Per the CDC:
 - COVID-19 vaccines are safe and effective at preventing COVID-19, including severe illness and death.
 - COVID-19 vaccines are effective against severe disease and death from variants of the virus that causes COVID-19 currently circulating in the United States, including the Delta variant.
 - Infections happen in only a small proportion of people who are fully vaccinated, even with the Delta variant. When these infections occur among vaccinated people, they tend to be mild.
 - More than 99.99% of people fully vaccinated against Covid-19 have not had a breakthrough case resulting in hospitalization or death
 - If you are fully vaccinated and become infected with the Delta variant, you can spread the virus to others.
 - People with weakened immune systems, including people who take immunosuppressive medications, may not be protected even if fully vaccinated.



Vaccines

- At Wiseburn, we recognize that:
 - Unvaccinated employees are at greater risk of contracting and spreading COVID-19 within the workplace and to the District community
 - A portion of the District's students, those who are 11 years of age and under, are not eligible for the COVID-19 vaccine at this time, and thus face an elevated risk of contracting COVID-19
 - It is critical that we protect the health and safety of our students and staff
- Because of this, we are requiring all staff members to be vaccinated against COVID-19, with limited exceptions (those who fall under these exceptions must undergo regular COVID-19 testing) as per a Health Order issued by Governor Newsom (effective 8/12/21)



COVID-19 Testing





On-campus Testing Protocols

Used in conjunction with other mitigation strategies, regular COVID-19 testing provides an additional tool to support a safe and successful in-person instruction, allowing for early identification of cases and preventing transmission.

- Wiseburn will be offering COVID-19 testing for students, staff, and community members twice a week beginning the week of August 23.
- COVID-19 test results will be available to the patient as well as the Wiseburn COVID-19 Compliance Officer within 24 - 36 hours.
- Wiseburn will also have a cache of rapid COVID-19 tests for immediate use should the need arise.



Limiting Indoor Crowding





Limiting Indoor Crowding

- Per LADPH, physical distancing strategies are still recommended as long as they do not interfere with full-time attendance for all students. They recommend 100% masking where distancing is not feasible.
- Wiseburn will employ social distancing where possible and will rely on 100% indoor masking.
- Class transitions and hallway use will be monitored and adjusted, as needed by site administrators.
- Wiseburn will also maintain an increased distance as much as possible during times when students or staff are not masked (e.g., due to eating or drinking, napping).
- Wiseburn will limit on campus visitors to essential visitors.



Additional Health and Safety Measures

In addition to our five most critical strategies, Wiseburn will maintain additional preventative strategies that provide added defense against COVID-19.




Daily Screening

Prior to entering campus, all students and staff must conduct a COVID-19 screening test. The screening will be done via a tailored daily self-screening application sent to parents/caretakers daily, as done during the 2020-21 school year.

Students who are symptom-free will receive a time-stamped certification to participate in school and related activities. They will receive a green checkmark, which they will show to enter school grounds.

Students who have symptoms or potential exposure to COVID-19 will receive a red X which means they are not allowed to enter school.

Additional Health and Safety Measures

- Staff members will be provided the appropriate PPE including face masks, face shields, and gloves. PPE will be provided to students upon request. Wiseburn will also provide desktop plexiglass shields and hand sanitizer stations.
- The District will coordinate with the custodial staff to be sure facilities are regularly and sufficiently cleaned and disinfected to LADPH and CDC standards. Our custodians have checklists and sign off on cleaning assignments at their required intervals on a consistent schedule.
 - The District will continue with enhanced cleaning protocols, to include regular disinfecting of high touch surfaces and daily classroom sanitizing.
- Learning may take place outdoors as appropriate.

Reporting Off-campus COVID-19 Exposure

Staff and families should self-report to the individual school site by contacting the individuals listed below if they or their child have symptoms of COVID-19, a positive test for COVID-19, or were exposed to someone with COVID-19 within the last 14 days.

Wiseburn On-campus Exposure Protocol Examples

Scenario		Response		
	01	A child is exposed to a confirmed case of COVID-19 at home		That child should not come to school, should be tested for COVID-19, and should quarantine at home for an appropriate amount of time, communicated by the WUSD District Nurse.
	02	A child in who has been in the classroom tests positive for COVID-19		Families of the students in that classroom are notified, students & teacher/adults will be sent home to quarantine if appropriate as communicated by the WUSD District Nurse and/or LADPH. Students will be provided work to complete at home for the duration of the quarantine. Staff will communicate with the family and adjust the delivery method of work, as needed.
	03	A child has illness symptoms not consistent with COVID-19 (potential COVID-19 symptoms are fever, new uncontrollable cough, vomiting, diarrhea)		Parents will be notified and student will either return to class or will need to be picked up, depending on symptoms and their severity

Wiseburn On-campus Exposure Protocol Examples

Scenario Response The WUSD COVID-19 Compliance Team, in collaboration with school leadership, convenes to A staff member (not a determine who, if anyone, was a close-contact teacher) tests positive for ("exposed") to this individual. Return to Distance Learning Procedures

In the event that a whole class/cohort is sent home to quarantine, the students would shift to a 100% Distance Learning model with no change to their daily learning <u>schedule</u>. Teachers will utilize zoom, Google Classroom, and/or other online platforms to provide for continuity of learning.

Students who are enrolled in our Independent Study Program model will not be impacted by quarantine protocols and/or classroom closures as they will continue with their current schedule and instructional model.

If a student or a small group of students are quarantining, they will still have access to their classwork (asynchronous assignments).



FAQs



Will the school hours return to pre-COVID-19 times?

Yes. Our school sites will follow our regular schedules as they did before COVID-19.



Will Back to School Nights be done virtually or in person?

To mitigate large in-person gatherings where possible, our school sites will hold Back to School Nights virtually. However, the site administrators are arranging for an open campus opportunity for families to walk around and get familiar with the site.



What is Wiseburn's policy/procedure for students who refuse to wear a mask?

Students who refuse to wear a mask will not be allowed to remain on campus as per a Health Order from the LADPH. Note that health orders are legal mandates. The school administrators will work with these students and families to find the best alternative for them to continue with their learning. The District's Independent Study Program would be a viable option.



Will students be required to be tested for COVID-19 on a weekly basis?

At this point in time, students will not be required to be tested for COVID-19 on a weekly basis. However, the District will have a testing site open two days a week at no cost to our students, families and community members.



Are students 12 years of age and older required to receive the COVID-19 vaccine?

At this point, vaccinations are only required for school district staff. However, we strongly encourage and recommend that all eligible students be vaccinated.



Will students be required to quarantine after traveling out of state?

Vaccinated individuals do not have to quarantine after traveling out of state. It is recommended that those who are unvaccinated get tested for COVID five days after return and/or quarantine for 7 days. This is a recommendation and not a health order. What do after-school activities look like at Wiseburn?

After school activities will resume as normal, but we will have to build back some of our program offerings that were in place prior to the pandemic. Our after school daycare program will resume and all activities will follow the same protocols as those required by WUSD related to COVID safety and mitigation strategies.



Are masks going to be required only for indoor scenarios or also for outside such as recess and PE, between classes passing periods?

It is recommended that masks are worn when students are in large groups. However, we understand that these outdoor opportunities allow students to have a "mask break". We ask that students who are not wearing a mask outdoors physically distance themselves from others.



How does lunch on campus work?

Lunch procedures will vary by school site and information will be provided by the site administrators.

Anza:

Students will sit on the outside benches whenever possible

Students will sit with students from their own class in line/seat order



Will students have recess while at school?

Students will have recess as per the pre pandemic school schedules and/or based on information provided by the site administrators.



What previously "usual" activities will be allowed/not allowed at recess and lunchtime?

We expect that most, if not all, activities will resume as usual during recess and lunchtime.



Will classroom activities, especially for more hands-on classes like science (experiments/labs) and Project Lead the Way (PLTW), return to "normal"/pre-COVID-19 status, or will they be limited/removed as they were when students returned to school in Spring 2021?

We expect a much more normal return to school with the ability to do hands on projects, group work, etc. However, this will evolve as students and staff become more comfortable with the current circumstances. It is recommended that group work happen in "chunks" of around 15 minutes, but this too, will evolve.



How will quarantining students access digital/remote instruction from their teachers?

The teachers will use Google Classroom and/or other online resources to provide the necessary material for students who miss in-person instruction due to quarantine or other issues that may come up. More information on this will be provided by the site administrators and classroom teachers.



Will hand-washing be incorporated into the daily/hourly routine?

Good hand hygiene is an important element of virus mitigation. Handwashing will be incorporated into the daily routine and hand sanitizer will be strategically placed throughout the campuses.



What is the policy/procedure if we have children at 2 schools and one school/classroom shuts down and the other does not? Are families expected to hold both children from school? Do they do their schoolwork online?

The only students who would be restricted from school are those who are considered by LADPH to be close contacts to someone infected with COVID-19. If a sibling is a close contact, the District will likely determine that the other sibling is also exposed to the virus. Thus, both students would be required to stay home and will be provided the opportunity to access school work online. If it is determined that only one of the siblings is a close contact then the District will not restrict the other sibling from attending school.



What are the cleaning and sanitizing procedures at Wiseburn?

- Intensified cleaning, sanitation and ventilation will be put into effect at all schools and work locations.
- High-touch items will be cleaned and sanitized daily.
- Classroom and student work areas will be cleaned and sanitized when a new group of students will be using the location.
- School-approved Environmental Protection Agency-listed disinfectant products proven to eliminate the COVID-19 virus will be used.

Can students walk to school or ride a bike?

Yes, students are able to walk to school or use a bike/scooter/skateboard and properly lock them up in the designated area. They will need to show the green checkmark for their health clearance and or go through the screening with an adult.



Will students be sharing supplies and materials in the classroom?

Your teacher will give further guidance on this specific to each class, but students should be not be sharing supplies while in class, unless cleaned between use.



Will I be notified if there is a COVID-19 case on campus?

Yes, you will be notified anytime there is a positive case on our school site campus. If your student is deemed a "close-contact," you will also be contacted and will receive additional notification of quarantine or isolation procedures by the Wiseburn COVID-19 Compliance Officer.
