Introduction

The purpose of this Health and Safety Plan is to provide the Parkland School District Community with an outline for full in-person instruction five days per week. This plan was developed by a Health and Safety Pandemic Team using recommendations from the Center for Disease Control (CDC), Pennsylvania Department of Health (PA DOH), Pennsylvania Department of Education (PDE), and continuous dialogue with our local health care provider: St. Luke's University Health Network (SLUHN). This plan specifically addresses the needs of the Parkland School District. Additionally, the plan will be monitored and revised as federal, state, and local agencies dictate and through continual monitoring of community transmission data.

Decision Making

The Parkland School District Health and Safety plan aligns with current recommendations from the Pennsylvania Department of Health (PA DOH), Center for Disease Control (CDC), and the Pennsylvania Department of Education (PDE). These health and safety recommendations are designed to guide school districts as they prepare for the 2021-2022 school year and make full day, in person K-12 instruction a priority.

We are committed to maintaining the health and safety of our students and staff. The District continues to strongly encourage eligible individuals to get vaccinated and recommends that unvaccinated individuals wear face coverings **unless required to wear a face covering in accordance with this Revision #1 Plan.** Please contact your health care provider for more information regarding vaccinations.

Feedback

This plan was posted for public review beginning July 21, 2021. Utilizing a feedback form, community and staff members submitted comments/feedback regarding the plan. All feedback was reviewed and taken under consideration by administration prior to July 27, 2021. Upon board approval on July 27, 2021 administration will continue to monitor federal, state, and local regulations as well as the community transmission of COVID-19. Changes may be made as needed throughout the 2021-2022 School Year.

Since the School Board's adoption of the Health and Safety Plan for School Year 2021-2021 on July 27, 2021, the School Board has received public comment about the Plan, especially that



portion of the Plan that addresses face coverings as one of the many mitigation strategies set forth in the Plan. The School District has developed a decision-making tool matrix to assist the District when a change is needed regarding the wearing of face coverings. The decision-making tool matrix was sent to the Parkland community on August 20, 2021, for review and comment. This Revision #1 Plan adopted on August 24, 2021, has taken into account community comments.

Revisions

Parkland School District will make changes and updates to this plan as necessary based on the level of community/building spread. Additionally, the School District will adhere to federal, state, or local governmental restrictions and/or mandates. Revisions will be highlighted and notification of revisions will be communicated with our school community.

American Rescue Plan (ARP) Elementary and Secondary School Emergency Relief (ESSER) Requirements

1. Mitigation Strategies- Parkland School District will continue utilizing disinfecting products that kept students and staff safe during the 2020-2021 school year. No change to procedure during school and after school. Buildings will continue with social distancing to the maximum extent feasible. Facilities Improvements- The district plans to utilize American Recovery Plan Elementary and Secondary School Emergency Relief (ARP ESSER) dollars to upgrade aging HVAC systems to enhance air quality in schools where equipment has aged and is in need of repair or replacement.


2. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?

Continuity of Services: How will LEA use funds to sustain services to address students' academic needs; students' and staff social, emotional, and mental health needs; and student nutrition and food services? The following positions have been added or additional positions have been created; Board Certified Behavior Analyst (BCBA) to assist with behavioral issues, school psychologist and a school counselor to assist with mental health needs. Additional



learning support teachers and an additional school nurse have also been hired to meet the needs of students. The district also plans to hire additional staff to reduce class sizes or offer online instruction. Access to instruction; how will LEA use funds to support the goals of increasing opportunity to learn and equity in instructional delivery? (attendance/ chronic absence) Attendance meetings will be held monthly by the CORE Teams in each building. Students with attendance concerns will be identified. Student Attendance Improvement Plans will be developed with the parents and students. Interventions may include but are not limited to mentoring, guidance seminars, or home school visitor meetings. Home school visitors make home visits to intervene when attendance and disengagement is a concern. We will also partner with our community agencies such as K/S Consultants Truancy. The district will again be providing breakfast and lunch to all Parkland-enrolled students free of charge, as well as providing meals to go for students within the school district who may opt to remain fully online as their method of instruction.

When making its decision regarding the wearing of face coverings, the Administration will take into account the metrics as recommended by the CDC, PA DOH, PDE and its local health care advisors. The community will be notified of any changes.</p> <p>Wearing a face covering may be subject to change at any time during the school year starting with the first day of school and ending with the last day of school.</p> <p>The Parkland School District has developed a decision-making tool in partnership with St. Luke’s University Health Network and in consultation with Lehigh Valley Health Network. This evidence-based approach is designed to assist Parkland School District when a change may be needed to our face covering policy.</p> <p><u>Indoor face covering requirements</u> (Appendix A) are a priority mitigation strategy across the tiers. Classroom

- Schools will maintain physical distancing practice per recommendations of the CDC and/or PA DOH to the maximum extent feasible.
- Field trips will follow the tiered system attached (Appendix B).

Face coverings are required while riding District transportation.

- Water Fountains will be closed this year, therefore students and staff should bring their own water. Touchless hydration fill stations and classroom sinks will be available.

Transportation

- The front seat behind the driver should remain vacant to the greatest extent feasible.
- Face coverings will be required while riding District transportation for all individuals, vaccinated or unvaccinated. This includes, field trips, sporting events, activities and regular riding of buses/vehicles to and from school.
- Assigned seats may be implemented based on level of community/building spread.
- Secondary school buses will be loaded from back to front.
- Elementary School buses will be loaded back to front with the exception of kindergarten and first grade students who will sit in the front of the bus.
- Morning bus run - students will disembark from front to back. Afternoon bus run - students will disembark by bus stop.

Food Services

Cafeteria Capacity and/or Alternative Serving Models:

- Maximum capacity will be determined to accommodate social distancing to the maximum extent feasible.
- Meals will be served in the cafeterias and other spaces as appropriate with limited, spaced and/or assigned seating.
- Entrance and exit flow paths, with appropriate spacing, will be determined at each building.
- Cohort seating will exist at the elementary level.



c. Handwashing and respiratory etiquette;



Hand Washing Etiquette will be encouraged for everyone.

Elementary

- Handwashing will occur prior to leaving the classroom for lunch and prior to any snack.
- Hand sanitizer will be used prior to and after breakfast, after lunch, and after snack; upon return from recess; prior to and after gym class; entering specials, and when entering and exiting the nursing suite.

Middle School/High School

- Frequent hand washing will be encouraged with students and staff at a minimum of two (2) times per day including before and after gym class.
- Hand sanitizer will be available as students and staff enter serving areas.
- Each classroom will have a supply of disinfectant.
- Children may bring individual bottles of hand sanitizer to keep on their desk or in a backpack.

Hand sanitizing stations will be available throughout the buildings.

Respiratory Etiquette:

Students/Staff will be encouraged to use proper respiratory etiquette.

Building School Nurse's will provide respiratory etiquette vignettes via electronic means, in person, and/or with posters that are visibly displayed throughout the buildings.

School Services

Sanitization Requirements

- Each classroom, restroom, hallway and touch points will be cleaned and sanitized per CDC requirements throughout the course of the school day.
- Students/Staff may clean their own personal contact areas and electronics. Cleaning products will be provided by the district as requested.

Restrooms

- The restrooms will be cleaned and sanitized when the students arrive for school. Additionally, the common area restrooms will be cleaned and/or sanitized a minimum of one time between the start of school and lunch, and once after lunch.

Hallways

- Door knobs, handrails and touch points in hallways will be routinely sanitized throughout the course of the day.

Transportation

- Hand sanitizer will be provided for students and drivers on each bus/van.
- Students entering and exiting the bus/van will be encouraged to use hand sanitizer.
- Buses will be disinfected after the morning runs and following the end of the day runs.
- Buses/vans will be aired out before and after runs, weather permitting.
- If a student/staff is diagnosed with a case of COVID-19, the bus/van will be removed from service for cleaning and disinfecting.

Ventilation Systems

- Routinely, School Services will check/monitor the operation of the ventilation systems.
- Windows may be opened, weather permitting, to increase air circulation

Kitchens/Cafeteria

- Kitchens will undergo additional cleaning routinely.
- Food Services staff will clean and sanitize kitchen equipment, surfaces, hand washing stations, and all other frequently touched surfaces throughout their work day.
- Serving lines will be sanitized after breakfast and each lunch period.

Cafeteria tables will be disinfected as follows:

ELEMENTARY

- After breakfast
- After each lunch period

MIDDLE SCHOOL

- After breakfast
- After each lunch period

HIGH SCHOOL

- After breakfast
- After second period study hall
- After each lunch period
- After school

e. Contact tracing in combination with isolation and quarantine, in collaboration with the State and local health departments;

- Current CDC and PA DOH guidelines will be utilized in assessing potential cases and exposure.
- The Director of Health and Wellness or designee will be in communication with the PA DOH with suspected cases of COVID-19.





- Parkland School District nursing department will assist with contact tracing as directed by the PA DOH.
- Close contacts to a case impacting school will be identified and sent home.
- Notifications will come via letter, email, District website, and/or School Messenger.
- Self reported positive cases will be confirmed by the PA DOH prior to notifications.
- Nursing staff will wear Personal Protective Equipment (PPE) during the school day when deemed appropriate and based on the level of community and building spread.

When an Employee/Student becomes ill or demonstrates a history of exposure:

- Isolation areas exist in each building to separate anyone from the general population who may be exhibiting COVID-19 symptoms.
- Decision Flow Charts for return to work/school and any necessary quarantine/isolation will be used by the school nurses based on the latest guidance from the PA DOH.
- Reports to the PA DOH will be made by the school nurse or Director of Health/Wellness.
- Increased cleaning and disinfecting of exposed classrooms and buses will be based on CDC guidance.
- Notification to potential close contacts will occur once a positive case, impacting a school, has been identified.
- All persons who have been in the presence of a positive case up to 48 hours prior to symptoms/testing will be excluded from school/work until the individual has met the PA DOH criteria to discontinue quarantine.
- Classroom instruction for quarantined/isolating students will move to virtual learning via Schoology and teacher direction.

- Individuals must be fever free for 24 hours prior to return to work/school without fever reducing medication. If a provider states there is an alternate diagnosis and feels the individual can return to school/work, a doctor's note may be required.

Returning quarantined staff, students or visitors to school.

- Return to work/school will be permitted in accordance with the current CDC and PA DOH guidelines. A doctor's note may be required.

Return to School/ Work (after COVID-19 diagnosis with mild symptoms (not hospitalized)).

- The District will follow the most recent recommendations provided by the PA DOH for return to school/work.
- Employees/Students should communicate with the Director of Health and Wellness and/or the building nurse to determine the timeline for return.
- Students/staff should be evaluated and may provide a return to school/work note from a medical provider (MD (Medical Doctor), DO (Doctor of Osteopathic Medicine), NP (Nurse Practitioner), PA (Physician Assistant), and (PA DOH).
- Visitors/Volunteers/Outside organizations may be limited from entering a district building based on level of community/building spread.
- Individuals without a medical provider may contact one of the following local public health agencies:

Diagnostic and screening testing;</p>	<p>Based upon the community and building level spread, a wellness screener for students, staff, visitors, and volunteers may be utilized during the school year. Everyone is encouraged to self monitor for illness.</p> <p>Students and Staff are encouraged to remain home if ill.</p> <p>Employees are required to notify their building supervisor if diagnosed with a positive case of COVID-19.</p> <p>Parents are required to notify their child's building nurse with a diagnosis of COVID-19.</p> <p>Suspected cases of a communicable disease will be masked while waiting for departure.</p> <p>Diagnostic testing opportunities will be provided by the community-based testing sites as directed by the employee/student's doctor.</p>

Indoor face covering requirements are a priority mitigation strategy across the tiers. Individual schools or the District may transition between tiers depending on the metrics set forth. Movement among tier levels will be considered after two consecutive weeks from the indicated change of the criteria. Immediate changes may be necessary as a result of outbreaks within a building.
