\* Recovery is defined as the resolution of symptoms and absence of fever without the use of fever-reducing medications.

\*\* Fever-free is defined as the absence of fever without the use of fever-reducing medicines.

### Definition of Fully Vaccinated

A fully vaccinated person is someone who is two weeks out from the recommended number of doses for the particular type of vaccine they received, taking into account any boosters that are recommended for particular demographic groups.

### Testing

Testing is done based on CDC recommendations for those with symptoms, those who do not have symptoms but came in close contact with someone who has tested positive, and those who are in a CDC-defined high-risk group. MSD recommends that employees and families utilize their primary care physician (PCP) to seek medical care. CDC recommends that all individuals take preventative measures including wearing face coverings and maintaining physical distancing to reduce the spread of the COVID-19 virus.

NCDHHS has clarified that, if someone (student or employee) has been referred for COVID-19 testing, **a negative molecular PCR (polymerase chain reaction) COVID test** is more accurate than a rapid antigen test and is therefore what MSD will continue to require.

MSD will coordinate with the Durham County Department of Public Health to determine when and how to inform families, students, faculty and staff as appropriate and maintain privacy and confidentiality as required by law. MSD may also decide to issue notifications above and beyond what public health notification guidelines call for. Suspected and confirmed cases will be reported to the MSD COVID-19 response team, including but not limited to the Administrative Team.
