# **Principal's Report**

# District Advisory Council (DAC) Report

- Recent meeting focused on Learning Continuity and Attendance Plan (LCP). Eight topics were grouped into 4 groups of 2 topics each. Each attendee was asked to join 2 of the 4 group sessions.
  - 1. In Person Learning & School Nutrition
  - 2. Distance Learning & Pupil and Family Engagement and Outreach
  - 3. Pupil Learning Loss & Increased or Improved Services
  - 4. Mental Health & Social Emotional Well-being
- Vinod attended 2 sessions
  - In Person Learning & School Nutrition
    - When students are in class, to maintain social distancing, will class size be reduced?
      - Yes, only half the class will be in at any time. The other half will be on asynchronous study at home (distance learning).
    - What will the hybrid model look like?
      - Proposal is to have 3 days of distance learning and two days that go like this:
        - $\circ\quad$  8:00 to 12:30 students attend class.
        - Students then "grab and go" lunch.
        - School is sanitized.
    - Since there is a high likelihood of at least one person in the school getting sick, are HVAC filters going to be upgraded so the infection doesn't spread through the school?
      - Filters upgraded to MERV13 and will be replaced more often.
      - If issue is found in any class, that room will be closed off and fogged later in the day.
      - Common areas will be sanitized daily.
    - Questions Vinod sent via a form post-meeting
      - Is there going to be any contact tracing to minimize infection spread?
      - Is any PPE going to be used? Staff? Teachers? Nurse?
  - Distance Learning & Pupil and Family Engagement and Outreach
    - Erin Chapman asked about instruction minutes. She got questions about these at her school.
      - How are minutes counted? Are these teacher minutes or student instruction minutes?
    - Questions Vinod sent via a form post-meeting
      - What is the plan to handle interruptions in instruction (technology issues)?
        - Can we have some material to use offline so kids can continue?
      - Can teachers get better training in Google Meet? Zoom is a lot better, any option to switch?
