COVID-19 Vaccination Requirement

Vaccination Card

Background

Oregon Department of Education (ODE) has developed a <u>frequently asked questions</u> (FAQ) about the Oregon Administrative Rule (OAR) 333-019-1030, COVID-19 Vaccination Requirements for Teachers and School Staff. Please note the listed categories in the FAQ are: Schools and school-based programs vaccine requirement, other agencies, vaccine rule enforcement, vaccine rule exemptions, Early Learning Division (ELD) staff, students, coaches, parents, substitute teachers, School Board members, district staff, school nurses, private schools, School psychologists, pathologists, counselors, and support staff, and temporary staff.

The **vaccination requirement** rule will apply to all **schools** and **school-based programs**. A **School** means a public, private, parochial, charter or alternative educational program offering kindergarten through grade 12 or any part thereof. This includes online schools.

A **School-based program** means a program serving children or students that takes place at or in school facilities.

- Includes individuals age 16 and older who are:
 - Employed by a school or school-based program or
 - Not employed but are otherwise engaged to provide goods or services to a school or school-based program through any formal or informal agreement, whether compensated or uncompensated
- Includes but is not limited to teachers, substitute teachers, administrative staff, child care staff, cleaning staff, coaches, drivers, volunteers; and who provide goods or services at or for a school-based program that includes direct or indirect contact with children or students.
- Does not include short-term visitors or individuals making deliveries.
- Does not include district office, facility, ESD staff who never work or volunteer in a school setting.

Vaccination Requirement

"Fully vaccinated" means having received both doses of a two-dose COVID-19 vaccine or one dose of a single-dose COVID-19 vaccine and at least 14 days have passed since the individual's final dose of COVID-19 vaccine.

Proof of vaccination means documentation provided by a tribal, federal, state or local government, or a health care provider. This includes an individual's name, date of birth, type of

COVID-19 vaccination given, date or dates given, depending on whether it is a one-dose or two-dose vaccine, and the name/location of the health care provider or site where the vaccine was administered. Documentation may include, but is not limited to, a COVID-19 vaccination record card or a copy or digital picture of the vaccination record card, or a print-out from the Oregon Health Authority's immunization registry.

Submission

An individual who has proof of vaccination as described in the message needs to submit a copy to Courtney Wilson, the assistant to the superintendent, at cwilson@pleasanthill.k12.or.us, or in person at the district office. This information will be kept in a confidential health file here at the district office.

Deadline

After October 18, 2021, teachers, school staff, and volunteers may not teach, work, learn, study, assist, observe, or volunteer at a school unless they are fully vaccinated or have provided documentation of a medical or religious exception. A school may not employ, contract with, or accept the volunteer services of teachers, school staff or volunteers who are teaching, working, learning, studying, assisting, observing, or volunteering at a school unless the teachers or school staff are fully vaccinated against COVID-19 or have a documented medical or religious exception.
