How to Calculate Your Maximum Monthly Benefit Amount

Step 1: Divide your eligible annual earnings by 12.Step 2: Multiply that figure by the benefit percentage of 66.67. You may elect a minimum of \$300 of coverage in \$100 monthly benefit increments.

Note: If your calculated monthly benefit is more than the maximum monthly benefit of \$7,500, use the maximum monthly benefit of \$7,500.
