

What is Title I?

Title I is a federally funded program that provides financial assistance to local educational agencies to improve educational opportunities for children. Title I programs are designed to help children meet the state content and performance standards in reading, language arts, and mathematics.

Which schools qualify for Title I funding?

Based on the federal funding formula, Belle Valley, Chestnut Hill, Grandview, and Tracy are eligible to receive Title I funds.

Each of these schools has a School-wide Title I program. The School-wide Plans are reviewed annually and provide a clear plan for addressing the academic needs of all students.

How are Title I funds used in my school?

The Title I funds provide additional support in reading and math instruction to students in grades K-5. There is a strong emphasis on developing collaborative intervention plans to address student needs as measured by District assessments, commercial and standardized tests, and the PSSA.
